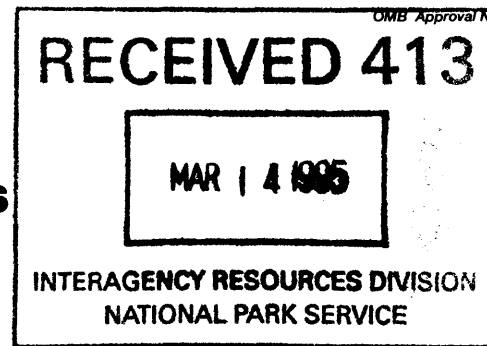

School #82 is an outstanding representation of the Georgian Revival style of architecture. In keeping with that design, the building contains such elements as paired end chimneys, quoins, broken pediments, roof balustrades, and an Adamesque-inspired cupola.

The main facade, which faces south, consists of the original two story brick building with a two story addition on the east (Photo #2). The 1931 building has a gabled roof with paired end chimneys and a centrally-located octagonal cupola. This portion of the building rests upon a raised basement with three-over-three double-hung sash windows. There is a one bay wing which extends northward at each end of the original building.

There are fourteen bays across the south facade, excluding the wings and new addition. Below the limestone cornice are twelve six-over-six double-hung sash windows with limestone keystones. Above each door, which is located east and west of center, is one eight-over-eight double-hung sash window with limestone surrounds. The first floor also has twelve six-over-six double-hung sash windows, but with plain brick surrounds.

Each of the two doorways consists of three replacement doors with a fixed-sash transom. The door has limestone surrounds with pilasters and a broken pediment. The bay is highlighted by brick quoins. The western-most entrance is inscribed with "Public School"/"Number 82" above the door; the eastern-most entrance says "Christian Park School." (Photo #3)

The new addition is joined to the 1931 structure by a one story brick passageway with three round arch double-hung sash windows (Photo #4). The 1955 addition is also a brick two story building ornamented by brick quoins; however, this section has a flat

roof. The three-over-six double-hung sash windows reflect those used in the older section.

The eastern facade contains one central bay delineated by brick quoins (Photo #5). The second floor has one three-over-six double-hung sash window with limestone surrounds. The first floor has a double metal door with fixed-sash transom and limestone surrounds.

The northern facade is a combination of utilitarian construction (Photo #6). The 1955 addition contains seven bays. The facade of the connecting section is not visible due to a six-bay, one-story addition which extends to the north of it. This eastern section contains an entrance on each end. The center portion of the original building contains 18 bays with a four-story smokestack rising four bays from the west. The west wing of the original structure extends north past the center section to expose four bays which face east. The extension of the two wings forms a modified "U" shape on the north facade.

The west facade reveals fourteen six-over-six double-hung sash windows on the second floor and thirteen six-over-six double-hung sash windows on the first floor (Photo #7). Three of these windows are located on a projecting bay with limestone trim. Thirteen basement windows are also visible on this facade.

The interior remains much the same as it was at the time of construction. The first floor contains administrative offices, the gymnasium and auditorium, and classrooms. Photo #8 shows the interior of the gym. This small, utilitarian space combines the facilities of a recreation facility and stage. The three-part doorway reflects the Colonial detailing through a pediment and fluted pilasters (Photo #9).

Photo #10 shows the standard classroom entrance located in the 1931 building. The wooden door contains six panes of glass; next to the door is a 15-pane fixed sash window. Photo #11 shows a second floor hallway in the 1931 section.

The present cafeteria is located in the basement (Photo #12). The original plans indicate that this space was reserved for a future manual arts room, sewing room, and a cooking room, with the cafeteria on the second floor.

Photo #13 shows a classroom doorway in the 1955 addition. The multi-panes of glass are in keeping with the original building.

Christian Park School is significant under criteria C because of its Georgian Revival architecture. Of the two Georgian Revival style structures in the Indianapolis Public School System, Christian Park is the oldest having been built in 1931. The other such structure, P.S. #86 was built in 1940. P.S. #82 maintains a high level of interior and exterior integrity as well as exhibiting numerous characteristics associated with Georgian Revival architecture.

For a complete record of the development of the Indianapolis Public School System, please refer to the corresponding Multiple Property Submission.

The Christian Park School, designed by the firm of McGuire & Shook, harmonizes architecturally with the nearby Christian Park Community House built in 1930 (Photo #1).

The present P.S. #82 is the result of the merger of two earlier schools--P.S. #82 and P.S. #77. In response to the educational needs of South Irvington, the School Board erected a portable structure on the southeast corner of English and Emerson in 1923 which became P.S. #82. In 1926 the patrons of P.S. #21 (located at English and Rural) petitioned for a portable to be erected two blocks east at English and Sherman to accommodate the pupils of the area. The School Board was reluctant to fulfill this request because they believed there were more children in the area than a portable could support. However, the Board approved erection of two, two-room portables one block south of English at Sherman and Spann, and designated them P.S. #77. Meanwhile, the Parent-Teacher Association of P.S. #82 clamored for a permanent building. The December 1928 building program included

a new building for P.S. #82, but these plans were later discarded.

In 1930, despite some opposition over the merger of the two schools, the School Board decided to go ahead with the new construction on land near Christian Park donated by the Park Board. The Building Program Committee decided that one large school would meet the needs of the community better than the two small buildings. The recommended structure contained sixteen classrooms with an auditorium, kitchen, and shop. McGuire & Shook, architects for the project, later designed Thomas Carr Howe High School and the James E. Roberts School. Service Construction Company served as the general contractor for Christian Park School.

On April 14, 1931 a delegation of the South Irvington Civic Club and the PTAs of Schools #77 and #82 asked that the new school be named Christian Park School "as a means of identifying its location, but primarily as a tribute to Edna M. Christian." She and her husband, Dr. Wilmer Christian, donated the land that became Christian Park. Their donation specified that the land be used to benefit children.

In 1955 McGuire & Shook prepared architectural drawings for an addition to the east end of the existing building. The addition blends well with the 1931 structure and reflects the same style of architecture.

The Indianapolis Public School System continues to operate the structure as an elementary school.

Verbal Boundary Description

Starting at the southwest corner of Wentworth Blvd. and Worcester Ave., proceed south along the west edge of Worcester Ave. to the north edge of English Ave. Turn west and follow the north edge of English Ave. 640'. Turn north and proceed to the south edge of Wentworth Blvd. (314.47'). Turn east/southeast and follow the south edge of Wentworth Blvd. for 659.17' to the point of origin.

Boundary Justification

This description comprises the boundaries of the land acquired to build School #82. Only the school building is included.
