

Describe the present and original (if known) physical appearance

The Roak Block in Auburn, Maine, is a large commercial building in the Mansard style. The block is constructed of brick with granite trim, and it consists of 3 1/2 stories.

The facade faces west and is thirty-six bays long, divided into nine sections. Fenestration is 2/2. The half-story bays are dormers with low arched roofs and decorative brackets. An entablature between the half and third stories contains recessed brick panels equal in number to the building's bays. Third story bays are capped with low bracketed arches with keystones, while in the second story the arches are semi-circular.

The first story of the Roak Block has been modified with modern storefront detail, but this is a veneer which would be easily reversable. More serious are alterations to the half-story in four of the building's nine section. There are plans, however, to reverse these changes.

Statement of Significance (in one paragraph)

At the time of its construction in 1871, the Roak Block was the largest commercialindustrial structure ever erected in Maine. Over 1,800,000 bricks were used in this, for its time, enormous Mansard building designed by Stevens and Coombs, prominent Lewiston architects, and built by Norton and Edwards, local contractors.

The Roak Block also proved to be a momentous development in the City's shoe industry, then only beginning to emerge as the major industrial feature in its economic structure. Jacob Roak who, in addition to being a shoe manufacturer, was a banker, businessman, and foremost in community development, conceived the idea of constructing a four-story brick factory in the principal business center. He did not retain this project himself but secured the cooperation of eight other citizens, all connected in some way with shoe making, to invest in and own a separate vertical section of the combined structure. It was in that sense a "row factory" and it served a great purpose. In addition to some stores on the first floor it furnished nine sections on the other floors for beginning shoe firms or modest ones to get started and there continue operation until their trade dictated a move to larger quarters, usually new ones they became able to finance.

The venture continued actively for nearly 90 years until it finally experienced the wane of Auburn shoe manufacture. But during the long active period, Roak Block became known as, and virtually was, "the cradle of the Auburn Shoe Industry." Still standing for 270 feet along Main Street, the building has been recently retenanted on the first floor by several stores but has deteriorated. It has now been purchased by a developer who is rehabilitating the structure according to the Secretary of the Interior's "standards" for use as elderly housing so that Roak Block will once again resume its former imposing facade.
