The Wright House is an ante-bellum cottage of rare distinction. A one story hipped roof frame building, the house has a recessed entry porch across the front facade which is supported by six square panelled columns with decorative carved insets. Windows on the side elevations have pedimented frames. The cornice is a flat, undecorated design, and the corner boards are also plain. The front entrance and windows are framed in excellent Greek Revival mouldings, capped by a row of dentils. The double door is panelled and flanked by sidelights and a fixed transom, all of which have finely detailed glass panels. The door frame has carved rosettes and is of exceptional interest. The front facade is flush siding treated as stone, and the remainder of the house is clapboard

Numerous wings have been added to the house over the years, but the remain hidden from view for the most part. The original interiors in the older section of the house are excellent examples of their period, with good mantels, wainscoting, door and window frames and other detailing.

The Wright House has recently undergone complete restoration and is in excellent condition.
