Describe the present and original (if known) physical appearance


The Samuel Gould House of Skowhegan, built in 1887, is a well-preserved example of a Queen Anne style residence in a northern setting.

The $2\frac{1}{2}$ -story house is of brick and frame construction, with gabled roof, 3 ornate internal brick chimneys, corner tower, shingle siding (brick first story), and brick foundation.

The facade, which faces south, is 3 bays wide with a central entrance. This entrance consists of a door with sidelights, flanked by 6/2 windows and covered by a one-story curving porch with elaborately-turned posts and balustrade. In the second story is a five-sided bay window with ten multi-paned casements flanked by shuttered 7/2 windows. In the half-story is a gabled projection containing three 4-light casements; to the right of this is a gabled dormer. At the left side of the facade is a three-story corner tower with six sides topped by an eight-sided bell-cast roof.

The 3-bay-wide west side of the house has a partially-exposed cellar wall with a doorway and window. Attached to the north end of the house is a 2-story shingled barn with gable roof.

8. Significance



Statement of Significance (in one paragraph)

Samuel Wadsworth Gould, a man of local importance, had this elegant Queen Anne style home built in 1887. A rare example of this architectural style in Skowhegan. the Gould house is one of the finest Queen Anne homes in the State.

Samuel Gould was a Porter, Maine, native who began practicing law in Skowhegan in 1880. An active and ardent Democrat, Gould was always politically involved, but in this strongly Republican area of the State he gained little bipartisan support. He ran for Governor once, unsuccessfully, and for Congress three times, being victorious only once, in 1910. The lawyer was also active in local politics. For twenty years he operated the Oxford Hotel in Skowhegan along with his law practice.

Gould purchased an Elm Street lot in 1885, but the site was already occupied by James White's tavern (which housed Skowhegan's first dancing floor). In 1886, after returning "from the Provinces with some fine looking work horses", Gould moved the tavern to another lot and constructed his lovely dwelling in the fashionable neighborhood. The brick and wood residence was completed in 1887 for the young lawyer and his wife and was painted "contrasting, but harmonizing colors". Still in excellent, original condition the residence stands today as a dramatic example of Queen Anne style architecture in a relatively remote section of Maine.
