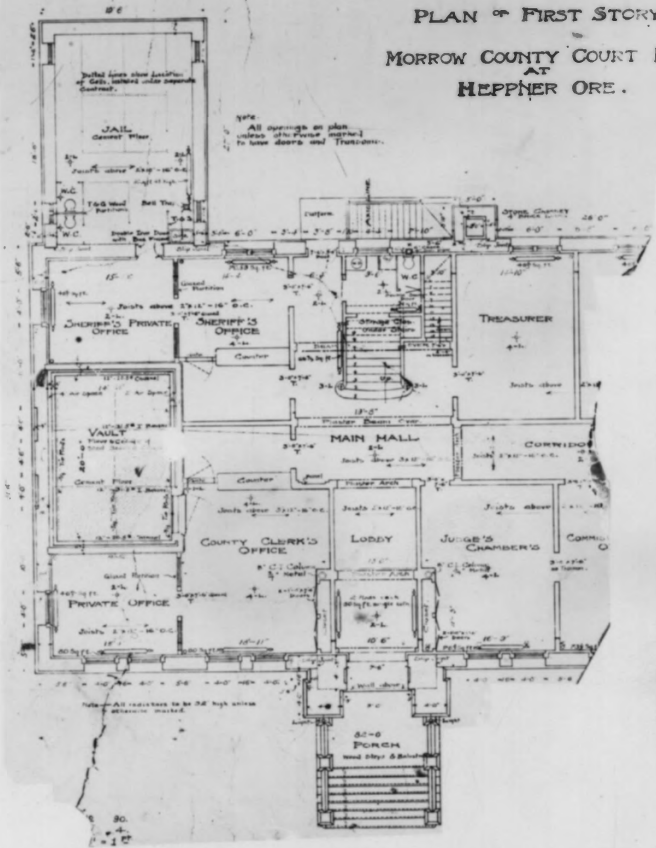

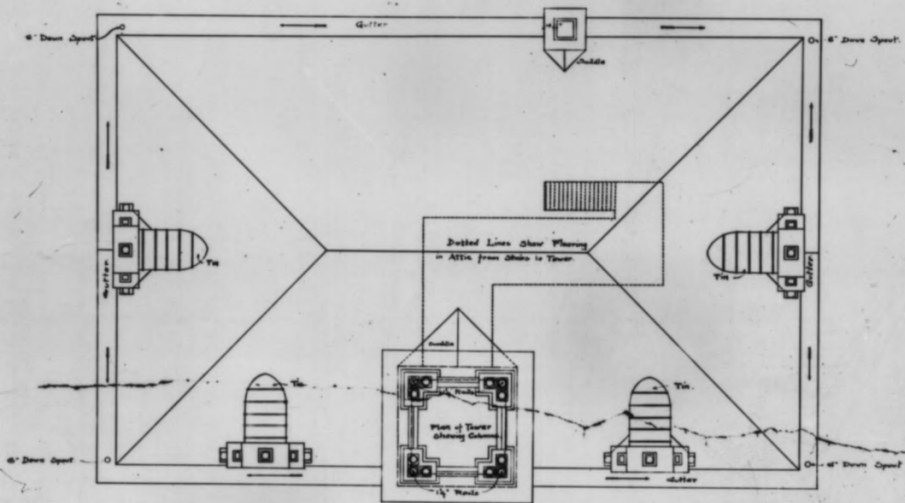

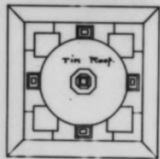

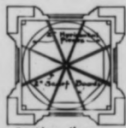
PLAN OF ROOF.

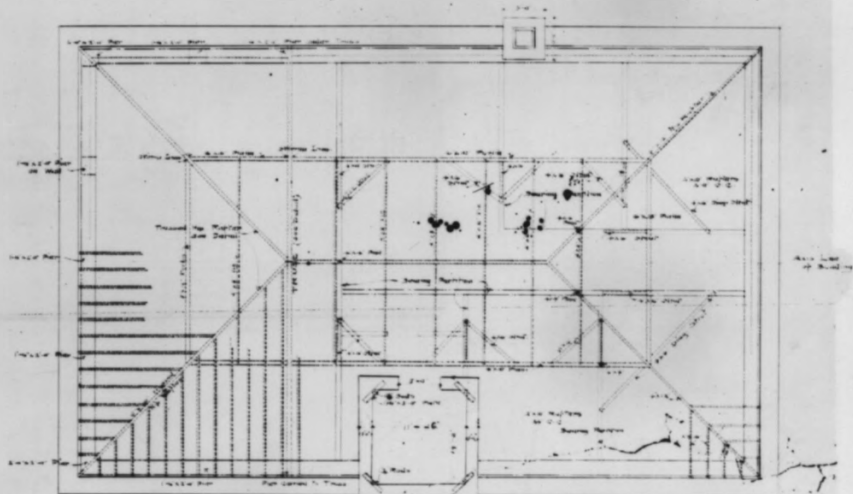

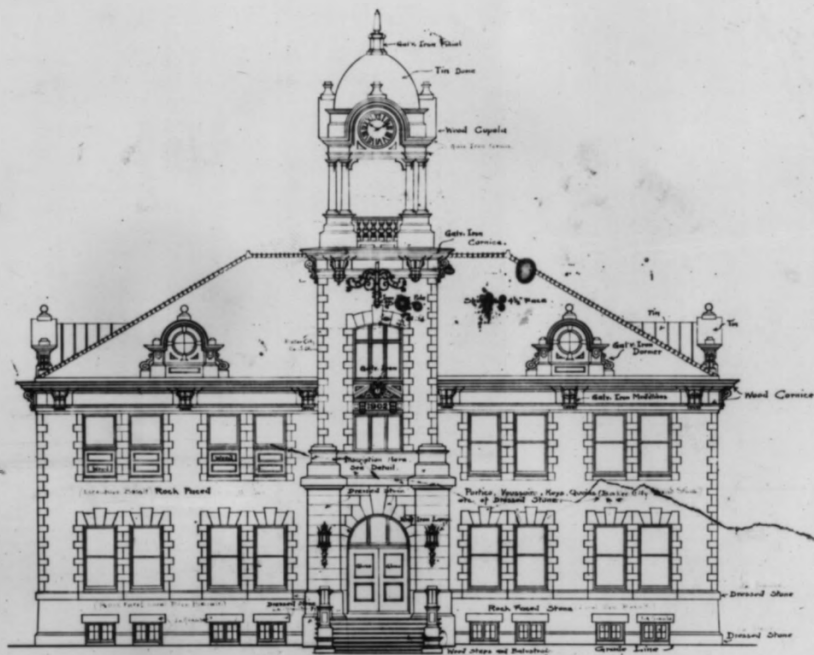

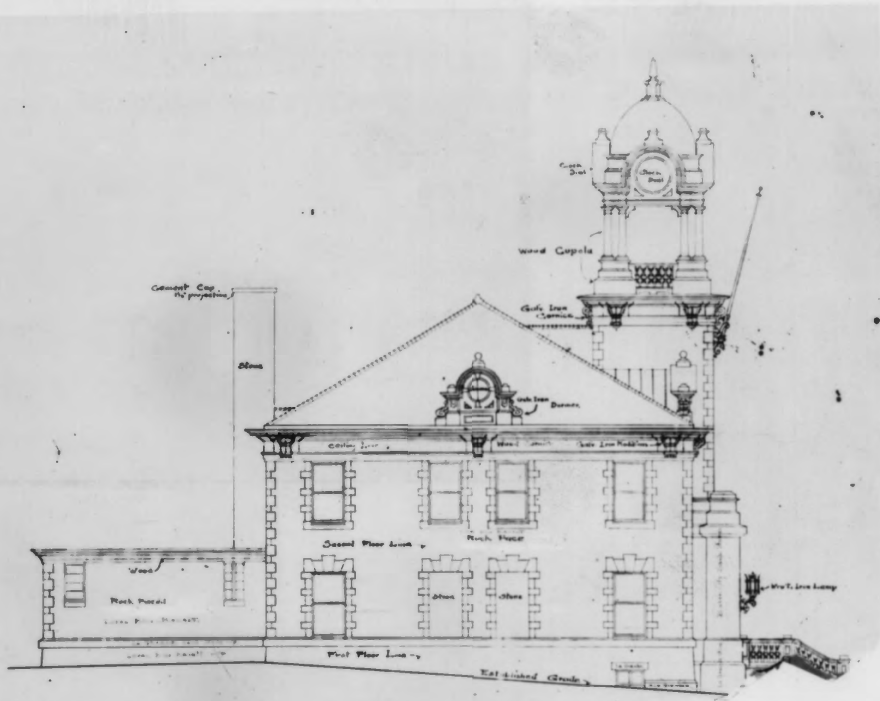

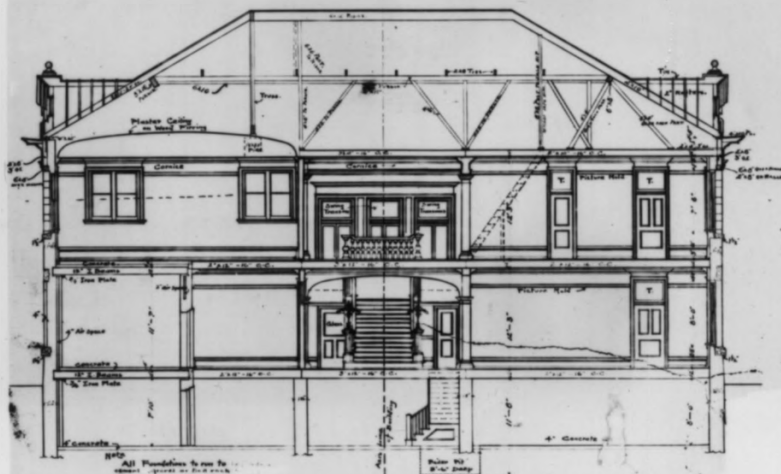

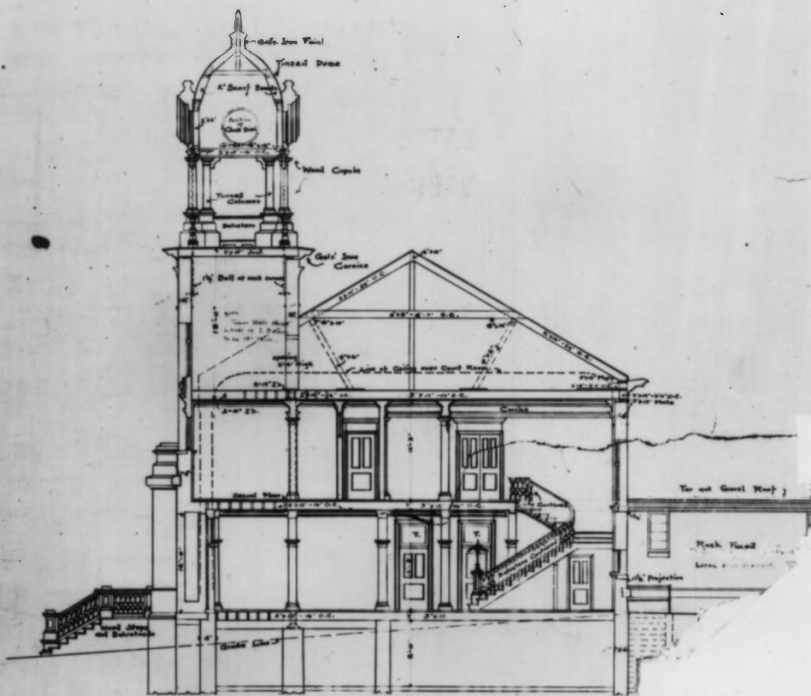

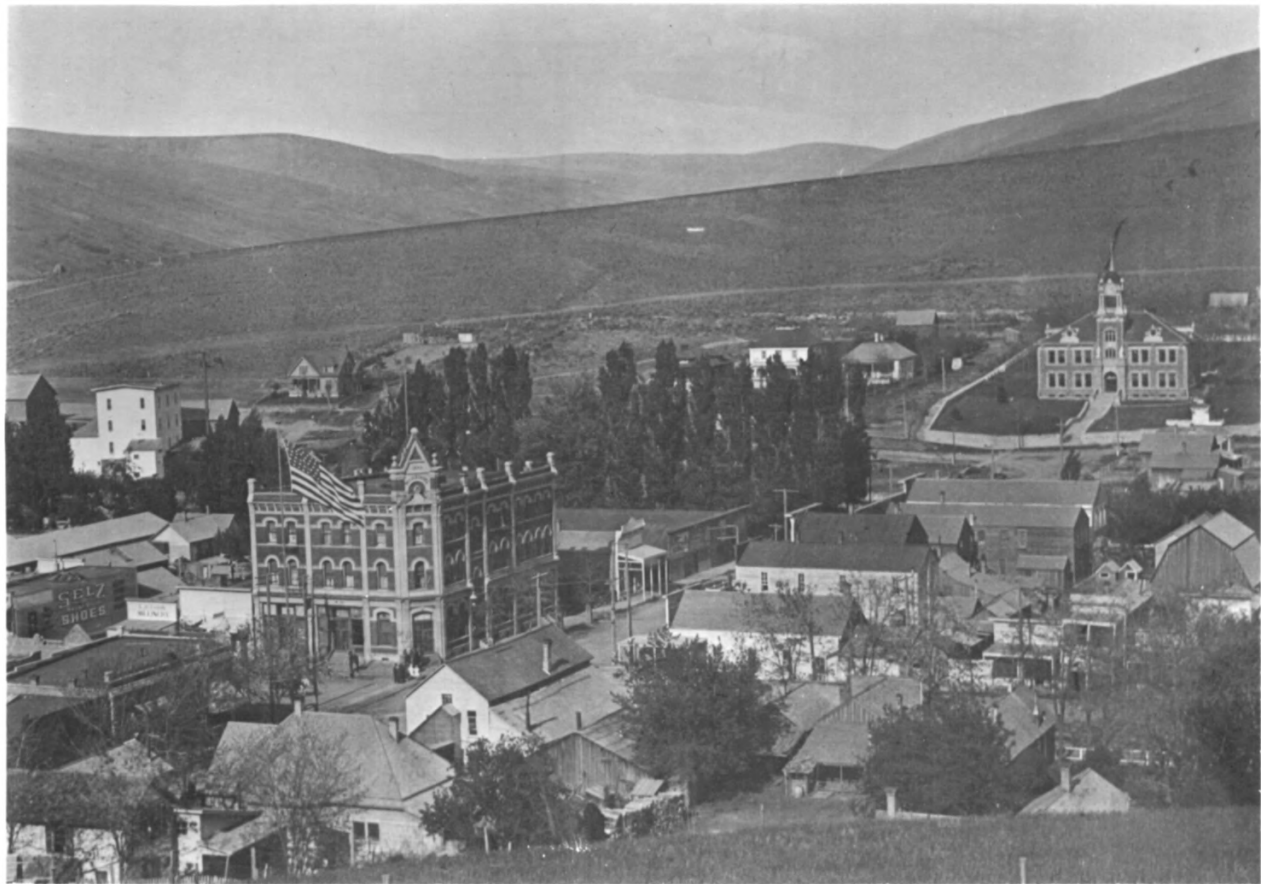

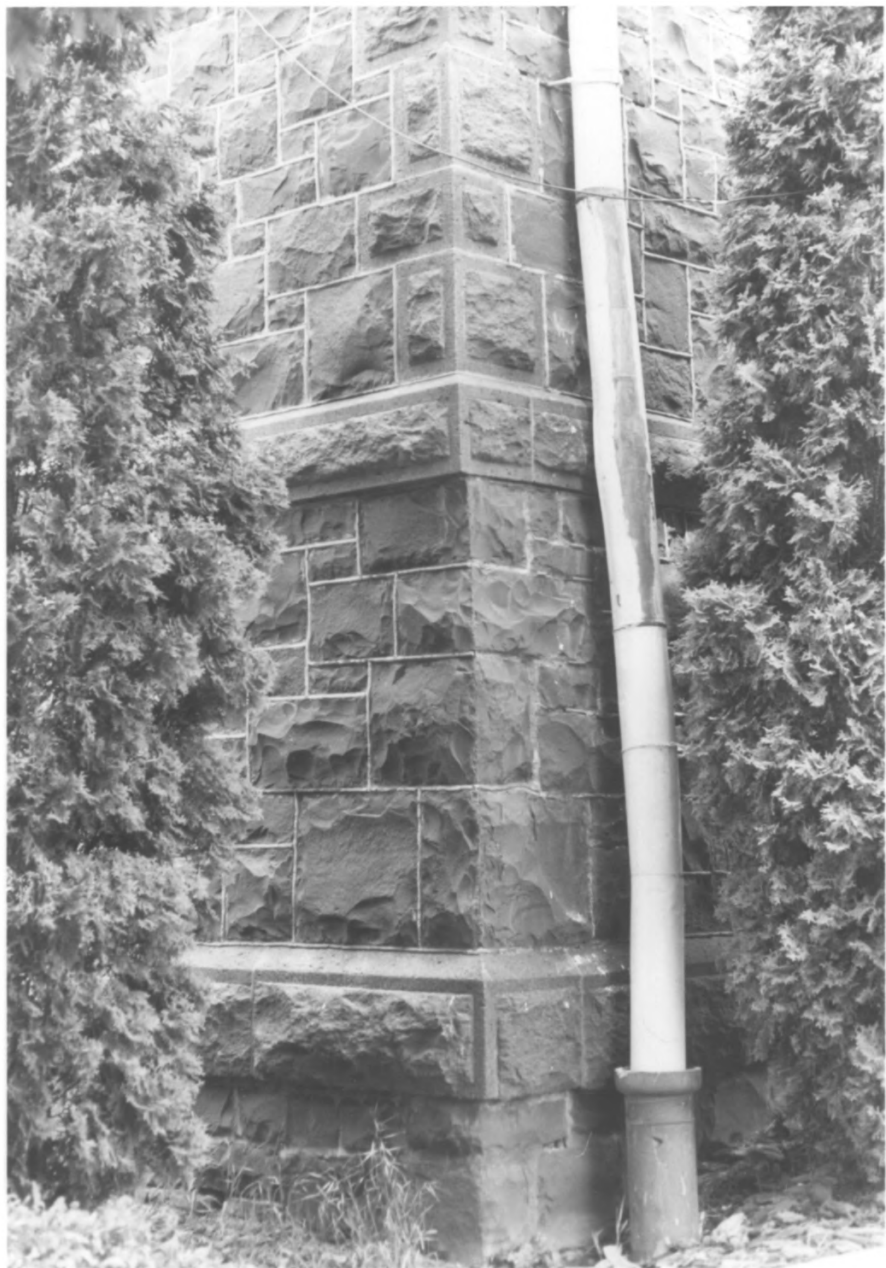

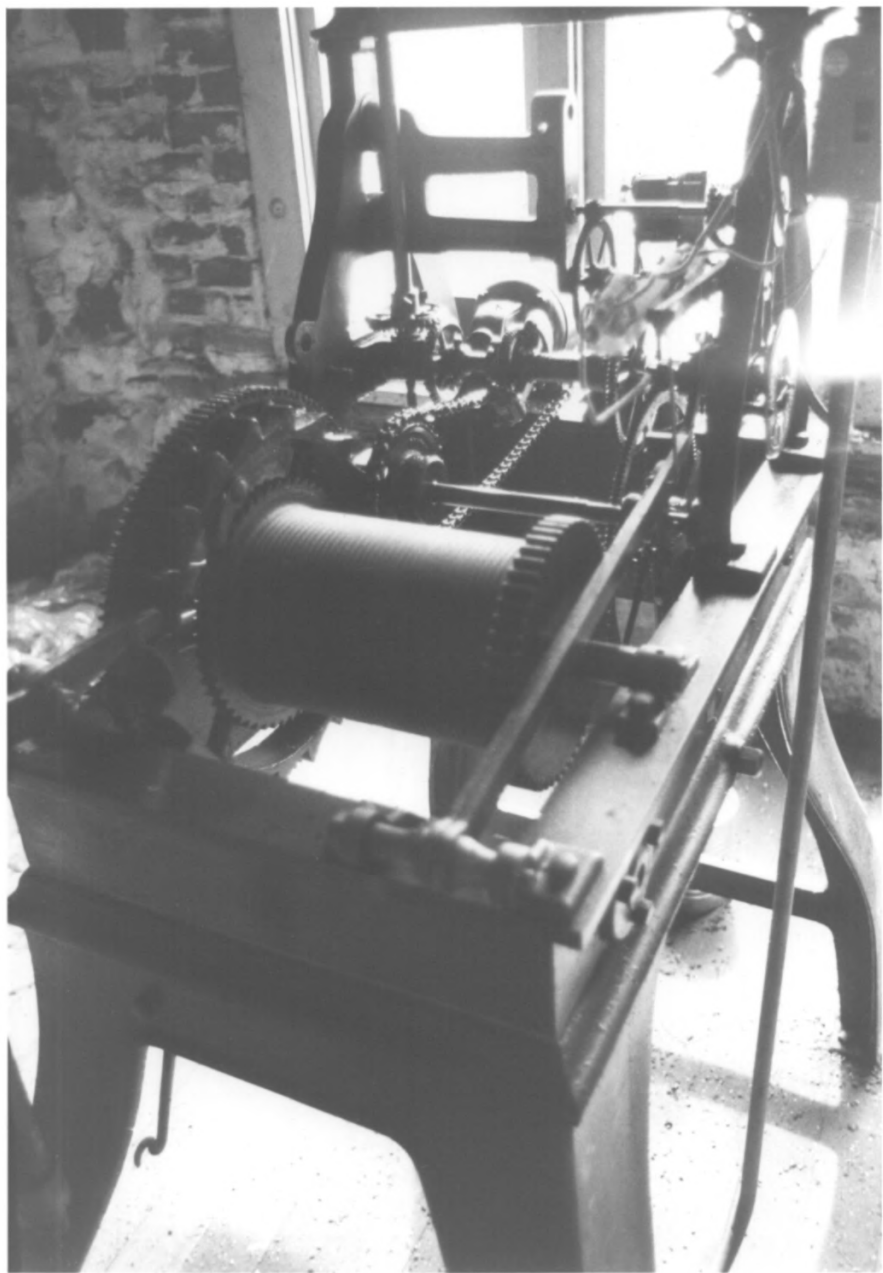

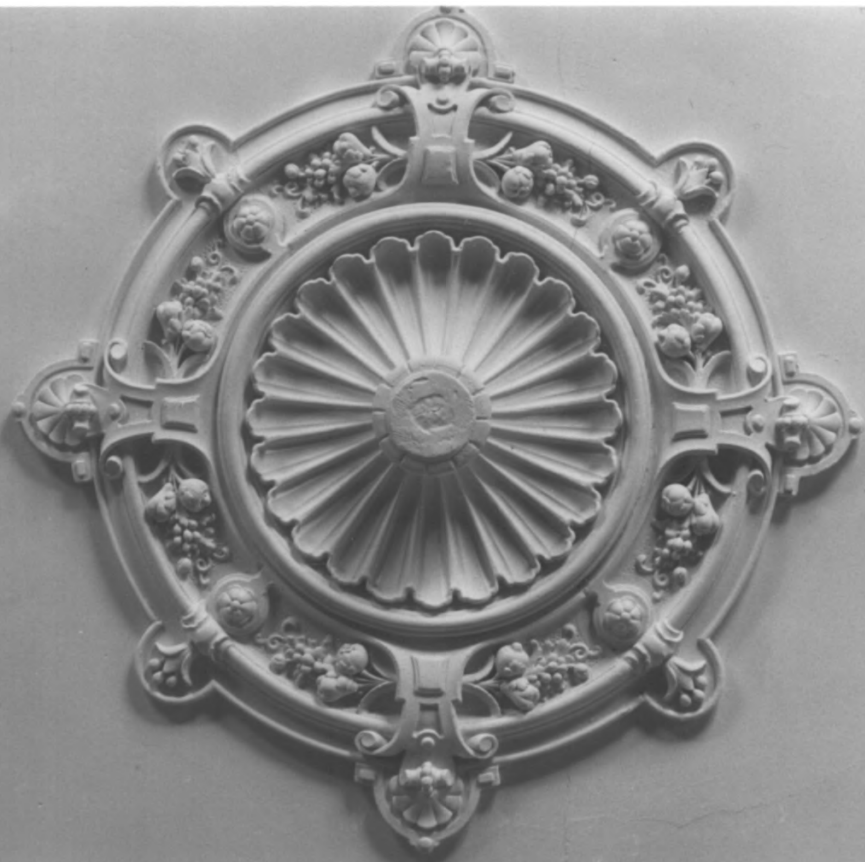

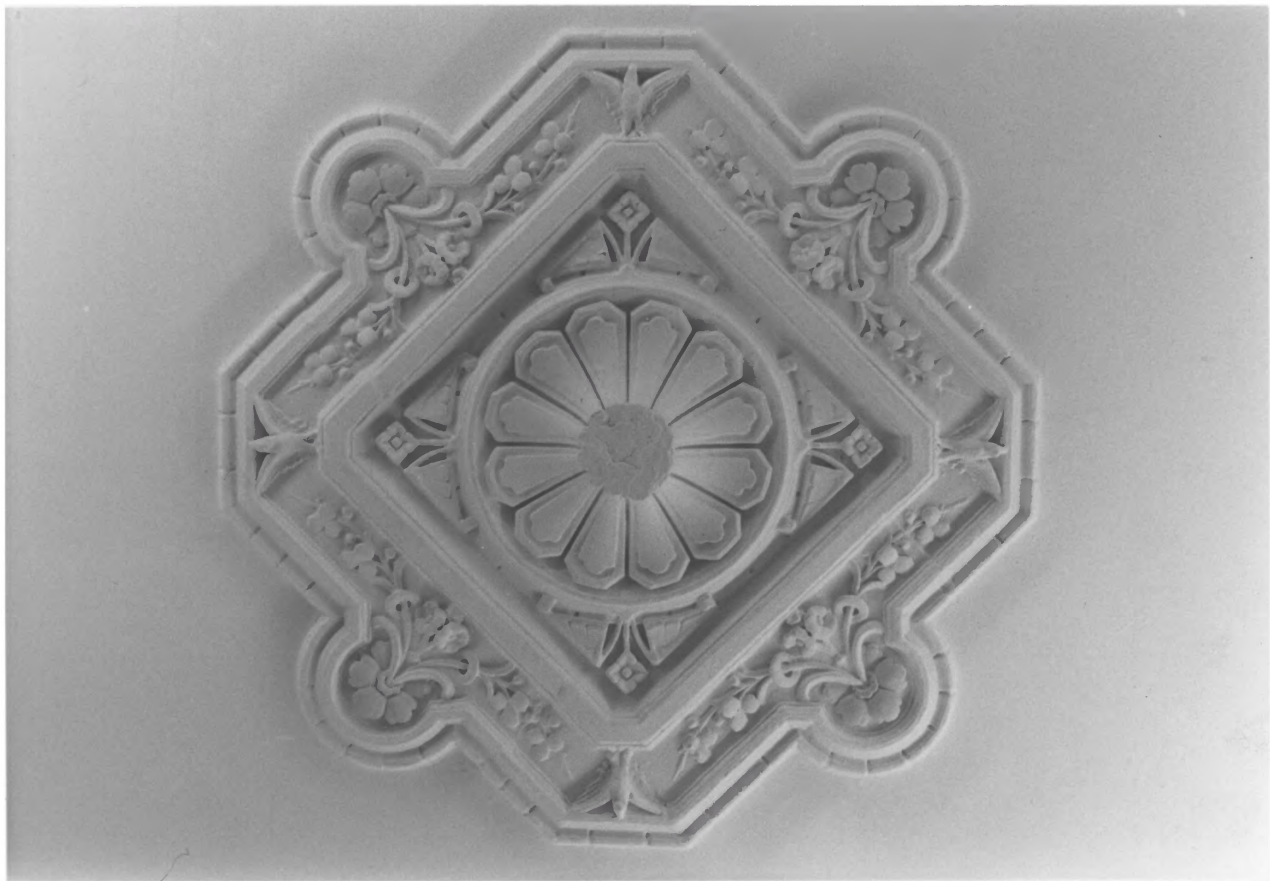
