**Describe present and historic physical appearance.**

Remington Village, southeast of the Remington Arms "Russian Rifle Factory" (now a General Electric manufacturing center), consists of 76 closely spaced duplex residences of ten distinct styles, all situated on three streets, Boston Avenue, East Avenue, and Willow Avenue, forming a tight residential enclave in a mixed-use residential/commercial neighborhood in the northeastern section of the city.

Although several of the buildings in this complex have incurred insensitive renovations, especially where porches and original surface material are concerned, because the district retains its essential massing, scale, and streetscape rhythm, as well as a relatively high degree of original materials, its integrity is such that it should be considered a contributing district to the Bridgeport/U.S. Housing Corporation Historic District.

In Remington Village ten distinct but related designs were built in a random pattern, giving the appearance of being erected over several years by separate owners. Most of the duplexes are rectangular in plan with hip or gable roofs. Most have three bays of paired windows with central paired entries, but some have fewer windows. One variation is articulated as a cross gable. In general, the most distinguishing detail is found in the variety of porch types. The various types will be discussed below and identified in the master building list.

Type "A" 6 structures (Photograph 1)

This type has a rectangular plan, is topped by a gable roof, and its paired, segmental arched entries flank small casement windows and are, in turn, flanked by paired sash. Four single 6/6 windows are found on the second floor. Its rather dramatic porch is articulated as a full-height gabled portico. Supported by Doric columns, the portico's closed bed pediment has a denticulated cornice and its tympanum encloses an arched vent.

Type "B" 9 structures (Photograph 2)

This type has a rectangular plan, is topped by a hip roof, has six paired first and second-story 6/6 windows, and is distinguished by a full-length, one-story porch with paired posts or columns.

Type "C" 11 structures (Photographs 2 & 4)

This type has a rectangular plan, is topped by a gable roof, the overhanging eave of which is articulated as a full, modillioned and triglyphed cornice. It has four second-floor windows and paired entries flank small casement windows and are, in turn, flanked by paired sash. A one-story porch with Doric posts or columns extends along the facade.

Type "D" 9 structures (Photograph 4)

This type has a rectangular plan, a gable roof with a simple cornice, and six paired first and second-story windows. A one-story porch with paired Doric posts or columns extends across the facade.

Type "E" 8 structures (Photograph 2)

This type has a rectangular plan, a gable on hip roof, and tripartite first-story windows. Its one-story porch extends across the facade.

Type "F" 6 structures (Photograph 3)

This type has an L-shaped plan and a steeply pitched cross-gable roof. In the ell is a flat-roofed, two-bay porch with rounded arches, and a projecting shed-roofed porch supported by simple posts shelters the entry.

Type "G" 10 structures (Photo 1)

This type is rectangular in plan and has a gable roof, the eaves of which are articulated as a modillioned cornice. It has four second-floor windows, and paired entries flank small casement windows and are, in turn, flanked by paired sash topped by blind brick arches. The entries are sheltered by a two-bay one-story porch supported by brick piers with a brick balustrade.

Type "H" 7 structures

This type is rectangular in plan and has a gable roof, the eaves of which are articulated as a modillioned cornice. It has four second-floor windows, and paired entries flank small casement windows and are, in turn, flanked by paired sash. The entries are sheltered by a three-bay, one-story Doric porch. Unlike most of the other structures in Remington Village, this is wood framed and wood surfaced.

Type "I" 7 structures (Photograph 2)

This type is rectangular in plan, is topped by a gambrel roof with a simple cornice, and has brick corner quoins and paired first-story windows. Its central paired entries flank small casement windows and are, in turn, flanked by paired sash. Its three-bay, one-story porch is supported by paired Doric columns.

Type "J" 3 structures (Photograph 4)

Rectangular in plan, this type is topped by a gambrel roof which has a simple molded cornice. It has four second-floor windows, and paired entries flank small casement windows and are, in turn, flanked by paired sash. A five-bay, one-story porch supported by paired Doric columns, extends the length of the facade.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Remington Village complex is significant as some of the earliest housing built in Bridgeport to house workers for defense-related industry. Built by the Remington Arms Corporation to attract and retain skilled employees to staff the firm's enormous "Russian Rifle" plant to the north, it is a highly conspicuous and tangible legacy of Bridgeport's most intense period of prosperity and growth brought on by World War I. Designed by the well-known architects Hiss and Weekes and Alfred Bossom, the area is architecturally significant and should be noted for its strong visual presence created by the variant modes of the Colonial Revival. It is a good example of period model housing that represents an enlightened architectural response to a local acute housing shortage.

## Boundary Justification

The Remington Village Historic District is located within a clearly defined neighborhood of Bridgeport outlined by the boundaries of the original land purchased by the Remington Arms Company in 1916. Distinctive architectural features, including overall building design, gable, hip, and gambrel roofs, varied wooden porches, and stucco and brick construction, identify the buildings associated with the Remington Arms development. Landscape features, such as sidewalks, symmetrical siting, and flowering trees, add cohesiveness to the district. The edges of the district are bordered by nineteenth and twentieth-century residential and commercial construction.
