DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Facing eastward, the Solomon Neill Brooks House is located in northern Bullitt County near the intersection of KY 61 (Preston Highway) and Hebron Lane, just east of I-65. The house is situated two miles south of the Bullitt-Jefferson County line. Brooks Run, a branch of Floyds Fork, runs in a northsouth direction to the west of the house, and the small community of Brooks lies just to the northwest on the Louisville and Nashville Railroad line.

Constructed in 1847, the Brooks House is a two-story, five-bay brick Greek Revival residence embodying a central passage plan. Six-over-six pane windows capped by jack arches pierce the east and west facades. Simple architrave molding frames the door which is surmounted by a four-pane rectangular transom and flanked by slender, three-pane sidelights. A recent one-story porch shelters the entrance. Interior chimneys are located on the north and south gable ends, and a corbelled cornice and tin hipped roof complete the building. The twostory ell is original to the main block; alterations have been made to the gallery on the ell. Shouldered architrave trim remains on the interior of the house.

Three outbuildings contemporary with the house remain. Immediately southwest of the house is a pyramidal-roofed brick smokehouse displaying an abstract Greek entablature. Adjacent to the smokehouse is a single-room, gable-roofed brick slave house. Further southwest of the main house is a brick granary/ springhouse.

The nominated property comprises approximately two acres designed to encompass the main house and the three outbuildings.

STATEMENT OF SIGNIFICANCE

Among the few remaining historic structures in Bullitt County, the Solomon Neill Brooks House is one of the oldest and most architecturally distinctive. Of the structures which meet the National Register criteria, the Brooks House is one of the county's two surviving brick houses. As such, the building embodies Bullitt County's finest example of Greek Revival architecture.¹ Adding to the importance of this house is the fact that the county has limited architectural resources, a result of its never having developed its own cultural identity. Instead, throughout its history Bullitt County's cultural and structural development has been heavily determined by the influence of adjacent counties, notably Jefferson. The majority of the historic structures have been destroyed; the remaining buildings and the ones that formerly existed convey a state of flux and a sense of economic immediacy that have been traditional elements in the county's history.

Bullitt County was created in 1796, and the early pioneer activity centered on the salt and iron industries. These were promoted and sustained for the most part by Louisville entrepeneurs who saw the opportunity to exploit Bullitt County's natural resources to the advantage of the business and commercial needs of the Louisville area. In 1779, the first commercial saltworks in Kentucky was established at Bullitt's Lick, and this saltworks became a major source of salt for several years, making the area the hub of the salt trade in pioneer times.²

In 1785, a second saltworks was established at Long Lick, and shortly thereafter Joseph Brooks,³ an early Bullitt County settler and an ancestor of Solomon Neill Brooks, developed the region's third saltworks at Mann's Lick. Thus from the county's initial settlement, the Brooks family has been continuously involved in the area's history, and the Solomon Neill Brooks House exemplifies the family's prominence in the county.

Displaying the traditional Greek Revival plan and retaining a noteworthy collection of contemporary outbuildings, the complex survives as an architectural landmark in Bullitt County.



¹Other buildings of note identified in the 1978 comprehensive survey of Bullitt County are the General Crist House, an early nineteenth century stone house, and a ca. 1830 brick dwelling.

²Robert E. McDowell, "Bullitt's Lick: The Related Saltworks and Settlements," <u>The Filson Club Quarterly</u>, Vol. 30, No. 3 (July 1956), p. 242.

³Brooks, a native Pennsylvanian, settled at Bullitt's Lick in February of 1781 and was involved in the saltworks until 1784 when he purchased property and built a house along the road between Louisville and Bullitt's Lick. The site became known as Brooks Spring, and it was on this land that his descendant, Solomon Neill Brooks, erected his house in 1847. The Brooks name continues to be associated with this area; the present community of Brooks originates from Brooks Station, established near the Solomon Neill Brooks House in 1858 when the Louisville & Nashville Railroad was extended through Bullitt County. 
