Name: Front Street (River Park Drive) Historic District

Location: Those properties located between and including 216 South River Park Drive and 700 South River Park Drive which are east of the alley which bisects 1 and 2 of the Prairie LaPorte Plat, and Blocks 1, 14, 15, and 26 of the Original Town of Guttenberg Plat, and west of the western shoreline of the Mississippi River, with the exception of the Public School and Lock and Dam complex.

Acreage: 10 acres.

Verbal Boundary Description and Justification:

Beginning at west shoreline of Mississippi River at point 90' south of south edge of Lessing Street, thence north along same shoreline to point where the extension of the southern edge of Prince Street to the east intersects, thence west along same south edge of Prince Street to point where that line intersects with center line of South River Park Drive (formerly Front Street), thence north along same center line of South River Park Drive aproximately 318' to point where an eastern extension of the north boundary line of Parcel 5, Block 2 (PLP) intersects with same center line of South River Park Drive, thence west along same north boundary of Parcel 5 to point where same intersects with center line of alley on Block 2 (PLP), thence southeast and south along same center line of alley through Blocks 1 (PLP), and 1, 14, and 15 (Guttenberg) continuing across Lessing to the point where a western extension of the south boundary line of Parcel 8, BLock 26 (Guttenberg) intersects with same center line of alley, thence east along same south boundary line to point where same intersects with center line of South River Park Drive, thence south along same center line 40' thence east to point of beginning. This district is bow shaped, being a chain of half blocks which front the Mississippi River and which include the majority of Guttenberg's earliest stone and brick commercial buildings. Excluded are the public school lot and the Lock and Dam complex. Included are the Conservation Commission buildings, and all buildings located on leased land to the east of South River Park Drive.

Two-story "stone filled" (vertical heavy timbers with stone filling in between) corner commercial structure, built above stone basement (flagstone floor) and stone vault (north end). Present building is totally obscured by combination of aluminum siding -2nd floor - and vertical roughboard - 1st floor. Original commercial appearance was a clapboard exterior with entrance on Goethe. Large 6' x 2" shop windows have been minimized. Front door was walnut. Original exterior is extant, pulp board siding is on that and present exterior dates from 1975. a Two-story frame addition. To west (built in two-story porch) Vertical stude are 16-18" apart, stone filled.

The structure has served as a commercial site since prior to 1858. The earliest owner known was Frank X. Wolter who owned the buildings to the west on this lot as well. The Sanborn Maps list the following operations: Boots and Shoes, Leather (1886-94, 1902, 1914); and store (1928). Wolters operated this store and probably John Wolter, father of F.X. Wolter, was the original leather store operator here (buys same 1867). Frank Wolter operated a candy and variety store later on during the 1920's and 30's. Emerson Wahler, who purchased the building in 1946, continued the same type of business until c. 1976. The building is now rented (downstairs) by A.C. This structure, in conjunction with the two structure to the south, forms an early business block that today lies somewhat north of the main business area of town. A lithograph of the period depicts the meat market at this site. Sanborn Maps indicate its use as a dwelling from 1886 and thereafter. Jeff Bellamy, pressman at Guttenberg Press lived here (no dates). The present owner purchased this building from Walter Jenkins. Jenkins operated a gas station immediately north of this site (concrete slab and tanks are intact) as late as the early 1960's. His wife, Alice(?), operated a

This is a National Register Property. A three-story commercial building built above a large double vaulted cellar which measures approximately 25' x 50'. The facade consists of seven bays, three doors with large arched windows dividing them on the first floor, and two floors of six windows and a central balcony door fill the front. A one-story frame and glass enclosed rear porch is a recent addition. Comprehensive renovation in 1971 totally gutted the interior with the exception of the original beams on the north end and center of the building. The original construction of interior partitions consisted of a stone and daub filling of a heavy beam skeleton. Large stairways were constructed and the cellar was converted for use as a bar. Six apartments were built into the structure. Most importantly, the 1900 coating of plaster which covered the facade, and had caused the building to be called "The Marble Front',

The Clayton County Herald dated June 5, 1855, tells us that the three-story stone building built "argely" by a man and wife over a three-year period was by this time complete, and that the builders were receiving a handsome income from the building's rent. The structure was designed to accomodate at least two businesses on the first floor, and the large central hall and entrance permitted entry to the living quarters on the two floors above. In August 1858, the same source announces that Alex. McKenzie has rented the "Albertus Building" for his American Hotel and the hotel opens on





THE "MARBLE Front", as we know it today, was originally the C: Albertus bu'lding, with a clo-thing and grocery store on the main floor center. Hottinger and Uning conducted a drug store in Heine conducted a drug store in the south addition, and a meat market occupied the north. A stone arch spans the 100-foot basement from north to south which is a marvel of stone masonry. The original doors show hand carving, and the ornamental iron on the porches was symbolical of a Heidelberg building of the day. The building was erected in the '50's.

September 21. Mandel's store sells out its stock and goes out of business to make way. The Albertus Building is also referred to as the "Lansman Building." An 1858 lithograph of the building block identifies the firms then in the structure as being a clothing store, first floor south, and a grocery store, first floor north. Above the third floor was incribed "C. Albertus Building". These firms combined with the drug store to the south and a meat market to the north would have constituted a major business block in an area that soon became largely residential. The Sanborn Maps indicate that this was a dwelling unit primarily by as early as 1886. In 1886, the south end of the lower level was used for a cigar factory. The Fred Aulwes family lived on the first floor (Fred Aulwes died 1896) from 1879 on, and the George Aulwes family lived on the second floor. During the 1920's-30's, F. Hinzman operated a shoe shop in the south side of the building. More recently, the Ratskellar Bar and Cafe was located here until c. 1975 (See Site #24). Today the building houses six apartments.

Two-story brick commercial structure with very early style store front on first floor. Door on left hand side serves second floor residence needs, store front door to right of center is indented, with two bays of 8-pane glass windows one to each side. A beam set into the brick divides the floors and probably supported signs. Four bays form the second floor facade. A simple cornice tops the facade. A side stairway and door also serve the second floor. A cellar entrance is behind the building.

A very early brick structure, built in association with the Albertus block. The building was standing as early as 1858 and probably earlier. In 1857, Ed Wagner operated a carpentry workshop here. By 1858, the store was serving as Anthon Hottinger and Leonard Heine Drug Store. This partnership was formed in 1856 and lasted until 1862. Heine later was a partner with Richard Vogel, but the location of either this second store or Hottinger's Drug Store is not known. The Sanborn Maps indicate that a grocery store was at this site in 1886, a cigar making factory in 1894, and after 1902, the building was listed as a dwelling. Wiley Frank operated a candy shop (PLEASE SEE CONTINUATION SHEET).



and bookstore here prior to moving to First and Goethe. A mother and daughter ran the Schultz Store in 1908. In the 1920's-30's, a drug store was at this site with a prominent Coca Cola sign out front. This firm closed in 1955. In 1935 following the end of prohibition, this building served as the first location for the State Liquor Store, managed by Emmett J. Dubbels (1935-43). Present owner purchased site in 1957, uses as warehouse.

The property abstract indicates the following owners: (few dates were available, this information was included in a summary of property ownership). Donald McKenzie, Nichols, Luhman, Ignatz Ahrends, Samuel Heine, Bernard Eilers (estate), Fred Block, Henry Eilers, John Clemmens (1906), G.H. Niemeyer, F.W. Schaeffer, John Jaeger, W.G. Schaffer to Eckert's Bank and John Jaeger (1917).

The 1858 map of Guttenberg locates Dr. D.P. Ginter's drug store on this lot (lot 2, block 2) that year. This possibly refers to the same building.

The single front dormer and decorated cornice serve to enhance the simple beauty of this structure. More recent uses included Opal Harvaugh's restaurant, Ahler's Restaurant (later bought hotel), and Kord's Cafe.



served as mayor, councilman, city treasurer, township clerk, school board secretary and president. H. Ihm early acquired the McGuire warehouse (stone basement and foundation, single story gable frame first floor) which stood by 1858 and which was located on the north side of the riverfront end of Prince Street (demolished c. 1936 for Lock and Dam). His sons operated the store. The first story of facade was modernized during the 1920's. It originally had two wide doors (see 314 South River Park Drive). The store had a big farm business, and offered credit through the year, being paid back during harvest in the fall. Three large barrels of whiskey were kept in the rear of the store during the winter. The poorest grade was given free to the farmers who came in with farm products. Bob Ihm bought the store c. 1950-1 and modernized it. He sold it to Albert Pink, who sold it to the Groths c. 1962-3. Pink owned and operated the "Style Shop", moving to this site following the loss of the stock in a 1951 fire at 312 South River Park Drive. The business continues in the building today. Edna Schultz currently owns the business.

Ihm and Matthias Weiner purchased the lot January 15, 1856, for \$900. Herman's wife Caroline owned the property until her death in 1929. Robert Ihm received the store from Carl (brothers Emil and Carl bought the store from Caroline Ihm, Emil died). Albert pink purchased the store January 9, 1952, and lived in the store (was a painter), renting the first floor. He now lives in St. Olaf.







The Clayton County Herald of November 1956 announced that this building, Charles Falkenheiner & Bro., had been erected during that season. An ad for the same firm in May 1856 indicates that the firm existed prior to the construction of this building. The ad noted that the firm operated a store in St. Louis and had a branch depot in Garnovillo. Jacob Falkenheiner operated the hardware store here as late as 1875-80, when Messrs. Minger & Kords took over for seven-eight years. George Freidlein & Sons ran the store to 1902 when Kuempel Brothers purchased the business. Edward and John Kuempel had lost two firms to fires in Clayton, Iowa. A furniture factory, (SEE CONTINUATION SHEET).

and a hardware store. After buying the store, John Kuempel ran the store, Edward did outside work and sheet metal work. In 1919, a partnership, Jack Kuempel (son of Edward) and Al Lake took over the hardware store. Mrs. H.G. Jenkins then owned the store and they rented from her. They purchased the building in 1923-4. They remodeled in 1929 removing the frame building used for plumbing storage and removing most of the central brick building. A Dec**or**ah contractor built the north addition for \$8,500. The partnership lasted for forty-two years. Jack Kuempel bought the business and today his sons run the firm. It is worthwhile to note that this structure was erected for use as a hardware store and throughout its history this has been its singular use.

According to Jack Kuempel, the building represents an original intention on the part of the German settlers to make the town "a little Cincinnati" with buildings of similar scale. The building was first lighted with kerosene, Minger and Kords put in an acetyline lighting system using carbide. The basement became filled with ash which Kuempel and Lake excavated. When renovation work took place, air hammers were required to go through walls. The oak timbers were found to be intact as when first put in place. Porches are the originals, the top railing was removed c. 1969 and a tall closed-in porch connects the two balconies (second floor) today. A modern heating plant was put into the basement along with a cement floor. Part of the floor is made up of rafting "key" planks (6-8' long, with 2" holes for lashing them together).

The second floor was used for theatricals and a Mr. Nolte occupied the street level floor. The name of William Sullivan is usually connected with this structure. River Park Drive. The Clayton County Register announced on October 26, 1858, that William Sullivan was getting materials together to build a warehouse (three-story) at the site of his old home, and that he planned to build that next spring. Evidently, Sullivan took over this structure in addition to the three-story store that he built in June, 1859. It was in this warehouse that the Grant family of Galena, operated a branch hide purchasing office on a seasonal basis. The firm used Schmee's office when they came to town. Schmees purchased flour from "Jefferson Mills" Jeffries & Bahlsinger Co., (not Guttenberg).

- 1. Kuempel Brothers, had hardware storage here, after sell of hardware firm 1919-20 the plumbing and heating company remained here on lower level. Kuempel and Lake used half of same level for storage as well. Kuempels operated a Ford auto agency here in 1902-3+. This was sold to Thompson Ford Motors, same to late 1940's, then Bussan Motors, which was bought out by Brown.
- 2. Benskin Boat House occupied the lower level until 1963. A large concrete fish tank remains on lower level.
- 3. Fred Friedlein used the warehouse in conjunction with his hardware store across the street, he sold the warehouse to Kuempels c. 1903. He operated a farm implement dealership here, Friedlein moved his firm to the now demolished Luther Stone Building on South First (post office site).
- 4. Burd Auto Service, here c. 1926, auto and tractor parts and servicing. Burd bought firm from Hamann & Stack, he in turn sold to a Mr. Brown who sold first Lincoln Zephyrs in town at this site.
- 5. Oscar and Clarence Hunstad had a Lincoln, Ford and Kordson tractor dealership here in 1926, bought by two men from Chicago, Thompson who owned the building decided to sell and not lease the building, sold to Evers.
- 6. Don Evers bought the building in 1959, formerly Tommy Thompson's garage (since at least 1955, Thompson had put in new rear wall). Evers operated a Jack and Jill Supermarket here on main floor, storage on second floor. Serviced barges with groceries. 1965 flood nearly reached second floor. Auto display firm had put in angled stone front with large windows. Evers put in all glass, extended front for store.
- 7. Barnhart and Klaes replaced Evers, moved their "Cellar Nook" gift shop from basement of 7 Schiller to this site. Remainder of building is currently empty.
- 8. An undated photo of this building identifies it as "Diamond Jo Warehouse" and as "Hunstad Brothers Garage". The Diamond Jo Line was sold in 1911 to Strckfus so the photo would have pre-dated that year (Petersen, <u>Steamboating on the Upper</u> Mississippi).
- 9. Swiekert's garage was here in 1937 (Guttenberg Centennial Brochure, 1937).







Liebeck, a vet, owned the building prior to selling it to the present owner.





Three-story stone warehouse along riverfront. Gambrel roof, stone lintels, two stories above street, two doors open out to street side. Well-preserved but in need of much tuckpointing work especially on southeast corner where some of wall has collapsed above one window. A line of lean-to bins with roofs line the structure on the south side. These date to the button company era and at one time a two-story frame structure (roof line visible on east wall) and a single story shed were east and north of the building.

The Clayton County Register announced that Wiest had begun a warehouse across from his hardware store by August 10, 1858. This would date this structure slightly later than the other warehouses. The 1858 city map locates the building, and the 1869 overview indicates that the building in its present state was standing then. The building served the Wiest Hardware Store and later the Class and Wiest store. It was later to be called Class Warehouse. Wiest also purchased local grain and produce and shipped these goods out by steamboat as did the other warehouses. In 1910, the third pearl button plant

opened in this building. The Empire Pearl Button Company of Muscatine installed electric driven cutting machines. Chris Frommelt was superintendent. This plant outlasted the other two plants and during the Depression, state funds subsidized a return to full operation and employment. By 1928, the name of the plant was "American Pearl Button Plant #1". The plant operated into the 1950's when plastic buttons put an end to this mode of button manufacture. Benskin Brothers purchased the building in 1963, it has been idle since "Hammer's Button Plant", which closed in 1957. It has since been used as a warehouse in conjunction with Benskin Boatline. Benskin leveled the mound of clam shells and removed some of the old sheds. The Boatline had previously operated out of the upper stone warehouse at 431 South River Park Drive (lower level). It was organized in 1953. The present floating dock and office were built in 1964.

NOTE: Three button-cutting machines are still located in the warehouse.







Two-story brick commercial building. Facade divided into three bays on second floor, stonequoins (original) decorate first floor sides of the front. The first story front has been modernized with smaller side windows, and new central entrance but preserved. Building date is stated on south face using metal numerals. Cast iron cornices decorate the tops of doors and windows. Stone basement is located beneath front of building.

Jacobs terms this building the first large brick building in town. It was another in a number of stone and brick buildings which Maurice and Augustus Fleck constructed for their various businesses during the 1850's-60's. The Clayton County Register notes May 13, 1858, that the brothers were laying the foundation for a new store, to be built with brick, measuring 25' x 100', two stories high. The front would be "nearly all of iron." On June 10, the store was nearly finished, by July 15 the walls were nearly completed, lower first story all cast iron. On August 31, the roof was on and

on October 6, the store was moved in and open. The store operated as a general merchandise store through 1889 (Maurice died 1889) when all of their operations were sold to George W. Kennedy, except this store which they sold to W.H. Kann and Gottfried Fassbinder. The Kann Family was a farming family, W.H. Kann was one of five brothers. He came to town and started into business. Fassbinder dropped out at same time. Kann died in 1933. Bill Kann operated a tavera, ice cream parlor, offices here, lastly a Western Auto store. Evers bought building 1958, present owner ran a bar here for them. Geuder buys soon after.
