Summary Paragraph

The Kirby-Adam House was constructed circa 1880 on Grand Isle by local builders, the Nacarri Brothers. The five-room house features wood mortise-and-tenon structure, center chimney, as well as tongue-and-groove floor, ceiling, and interior walls which provided anchor and rigid stability during storm events. The house has survived over one-hundred-thirty years of annual tropical storms, hurricanes, and flood events and provides testimony to the strength and appropriateness of its design and construction in its' sub-tropical environment.

Narrative Description

The Kirby-Adam House retains its historical integrity with original location, materials, structure, and appearance. Where materials have been replaced, the owner used same, similar, or sensitively incorporated materials with the exception of those below. The house is located on the chenier ridge near the center of the island with the front porch facing towards the beach (south) and the rear to the bay (north). The foundation and chimney are composed of clay bricks with lime mortar that shows considerable wear from wave action during storms. The current owner had the hearth and upper portion of the chimney rebuilt in 2001-2002 at which time it was discovered that the chimney foundation extends four (4) feet below grade serving as an anchor in the center of the house during flood events. Contrary to typical floating that occurs during high tide events, to the owner's knowledge, the house has never moved during a storm. The chimney is located in the center of the house and serves as a portion of the wall between two front rooms but has a hearth only on the west (living room) side. The bricks and hearth are original; the owner changed the former flat fireplace opening to a shallow arch to increase its structural stability after the damage that necessitated the rebuilding.

The main structure of the house is cypress wood with wood clapboard siding and wood floors. The windows and doors are wood. Windows are 2/2 and 6/6 double hung wood. All original exterior doors had been replaced when the property was purchased in 2001. The owner incorporated salvaged doors throughout but all are single-leaf; the original four openings on the front porch were all paired French style doors. The openings closest to the exterior walls now contain single-hung wood windows

with two-by-two lites and wood shutters (this change was done within the period of significance). The west door is a 6-lite, two-panel wood door with antique hardware. The east door opening has paired wood shutters. Both door openings and window openings match in height, width, and trim. Door and openings include a transom-like panel detail.

The Kirby-Adam House consists of the original building area without any external additions. The brick pier foundation supports a wood structure with side-facing gables. Exterior walls have wood clapboard siding and the roof is metal. The front faces towards the beach on the south with the rear towards Caminada Bay. The plan has two large front rooms with three smaller rooms across the back in a typical Creole style plan though the cabinets are considerably larger than the very small center space. The front gallery (porch) has two doors at center each flanked by a window and symmetrically arranged across the façade. The left door opens into the living room which has the only hearth in the building. The chimney is located in the center wall between the living room and bedroom, being flush with the wall on the bedroom side and projecting into the living room. A large framed opening provides access to the kitchen in the rear (northeast) corner *cabinet*. From the kitchen, a door opens into the small hall. From the hall, doors open to the bedroom, bathroom, and outside (rear) of the house. The hall retains at least two layers of wallpapers on the tops of the walls. The bedroom is the second large front room with a door to the front porch and exposed brick on the back of the chimney. The original stair located in the northwest corner *cabinet*, is now part of the bathroom. The stair has one step up to a corner landing then a steep, straight run up to the sleeping loft.

The owner stated that when the mason repaired the chimney, he revealed that the foundation extends four feet below the ground surface. Located at the center of the building, this would allow it to act as an anchor for the house during flood and wind events.

The cistern (see Photo 10) is located outside the rear of the house near the northwest corner. Although original to the island, it floated onto the property during a storm event and the owners agreed to permanently relocate it to the Adam house property. It is located over the brick circle foundation of an earlier cistern on a new foundation. At present, it does not contain water.

Historic Integrity - Adam House and Cistern: The house maintains its historic integrity with the original five rooms and no additions to the floor plan. Interior wood walls have been painted where originally wallpapered. Floors are exposed tongue-and-groove cypress. The brick chimney was repaired and an arch added to the top of the firebox after some bricks were damaged during hurricane Katrina. There is no wood or plaster over the bricks on the chimney and no mantel. The owner assumed these had been damaged by floods and removed by previous owners. The only major change to the house are the interior and exterior wall surface materials on the east gable wall. Due to storm damage, the exterior siding has been replaced with wood exterior grade plywood, and the interior horizontal tongue-and-groove boards have been partially replaced with vertical beadboard. Window unit air conditioners, indoor plumbing, and electricity provide modern amenities with minimal effect on the historical character of the structure. While the building retains many of its original design elements and is clearly a historic building, perhaps the most intact area of integrity is setting. As Photo 1 shows, the building is bathed in shade from nearby trees and looks much as it did in 1880 – an inviting home away from home.

Constructed in 1880, the Kirby-Adam House is significant on the local level under Criterion C: Architecture as a prime example of the Louisiana Coastal Vernacular style. The Kirby-Adam House has direct associations with the historic context from the Late 19th Century Gilded Age of Grand Isle (1880-1893) as defined in the "Louisiana Coastal Vernacular: Grand Isle, 1780-1968" Multiple Property Submission. It meets the registration requirements of the Building Property Type found in Section F of the MPS. The Kirby-Adam House is eligible under Criterion C as it retains many original

design features, materials, and examples of late 19th century craftsmanship. The period of significance is 1880, the year it was built.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

The Kirby-Adam falls under the building property type as defined in the Louisiana Coastal Vernacular: Grand Isle, 1780-1968 multiple property submission. Built in 1880, this house falls under the discussion of a Creole type house with interconnected rooms, with no true hallways. The building also has heavy braced timbers, a large attic space, and a generous gallery. On Grand Isle, there are also bungalow style buildings that often also had prominent gable roofs, overhanging eaves, large gabled porches, large windows, paneled rooms with beamed ceilings, and casual, hall-less floor plans. The Kirby-Adam House has all of these features, even including some of the features of the later bungalow style buildings, including the beamed ceilings, which are currently covered with a later covering. The beaded board and wood board walls can be seen in some spots underneath the later wallpaper.

The registration requirements for the MPS state,

"Buildings of French Creole and Bungalow styles must retain major elements of these styles as described above for eligibility under Criterion C. Status of elevation to meet Base Flood Elevation requirements should not completely disqualify buildings on Grand Isle if they meet a majority of other elements of the specified style, mainly because of the geographic location of these buildings on an island continually battered by flooding and hurricanes and because of the longstanding history of elevating buildings on Grand Isle. Applicants should show documentation of historical background relative to the community for those structures not meeting Criterion C for architecture to achieve Criterion A or B listing under community significance. Buildings should at least retain integrity of design, feeling, association, location, and setting. Materials may have changed some due to repairing storm damage, but overall, the building should retain its overall form, style, and layout."

The Kirby-Adam House meets the requirements under Criterion C as it retains the major elements that have been mentioned in the building property type description. Furthermore, it retains integrity of design, feeling, association, location, and setting, which is perhaps its strongest area of integrity as when one enters the property, they are almost transported back to Grand Isle's heyday. The Kirby-Adam House also retains integrity of materials, miraculously even after weathering all of the storms it has seen over the last 130 years. Its overall form, style, and layout it most certainly intact and thus, the building is eligible for listing on the National Register as a prime example of the Louisiana Coastal Vernacular of Grand Isle.






