1. <u>Name</u>: Maria J. and Juan Trujillo House, survey number 23

2. Location: approximately 50 feet east of Highway 61 and 1/4 miles south of the Eby Ranch Road.

4. <u>Owner</u>: Mae C. Montoya, P.O. Box 945, Silver City, N.M. 88062

7. <u>Description</u>: Photo 65; map 15; single file plan with zaguan (an open roofed passage); concrete foundation skirt; stuccoed adobe walls; corrugated metal gabled roof (original flat earthen roof beneath); 2/2. 4/4 double hung windows; 3 single doors. Current owner enclosed the zaguan and added the pitched roof in 1942. Summer kitchen: photo 69; concrete foundation skirt; stuccoed adobe, corrugated metal roof. Small wood frame shed.

8. Significance: The early history of this house is not entirely clear, although it was apparently present in 1882 when Maria Jesus Trujillo and Juan Evangelista Trujillo homesteaded the site. Maria Trujillo's granddaughter, Mae Montoya the present owner, reports that the house was built in 1836, that the roof vigas were carted from the Alamogordo area, and that the original flat roof was surrounded by a defensive parapet wall and was reached by an exterior stairway. Given the general history of the region, this early date of construction seems unlikely and the house probably dates to the 1870s and the early stages of the permanent settlement in the valley and therefor meets Criterion A as an example of that settlement. In addition, it meets Criterion C as an extremely important example of the Spanish-Mexican vernacular tradition with its 20 inch-thick adobe walls, linear plan and original flat roof in place under the later pitched roof. The arches of the original open zaguan passageway are particularly notable as one of the few historic examples of this building detail which have been identified in New Mexico. The adobe summer kitchen was built about 1890.
