### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#### A. Introduction

In contrast to most Bay Area towns, Richmond did not have its origins as a city in farming, trading, or lumbering; rather it started as a transportation and industrial center.

#### B. Physical Description

See Exhibit 1, District Boundary Map, on page 13. The original Point Richmond area or district is roughly triangular in shape and consists of approximately 94 acres. Beginning at the intersection of Route 17 and Washington Avenue, the District is bounded by Route 17 until its intersection with Tewksbury Avenue; then along Tewksbury until its intersection with Eddy Street; then northwesterly along Eddy Street until its intersection with Hillside Avenue; then northeasterly along Hillside Avenue to Contra Costa Street; then southwesterly along Contra Costa back to Tewksbury; then northwesterly along Tewksbury Avenue to the southerly boundary of the Chevron refinery; then southwesterly along the Chevron property and over the termination of Golden Gate Avenue to an unnamed alley approximately 100 feet south of and parallel to Golden Gate Avenue. At this point the boundary turns southwest and runs along the unnamed alley just southwest of the crest of the long narrow hill known as the Potrero.<sup>1</sup> At the intersection of the alley and Marine Street, the boundary turns northeasterly along Marine Street to Golden Gate Avenue; southeasterly along Golden Gate Avenue; easterly along Contra Costa street for one block; then along Golden Gate Avenue to the intersection with Mono Street, then northeasterly on Mono Street to West Richmond and southeasterly along West Richmond Avenue to the undeveloped portion of Mason Street, then continuing southeasterly along the platted right-of-way for Mason Street back to Golden Gate Avenue, then easterly along Golden Gate Avenue until its intersection with Santa Fe Avenue; then southwesterly along Santa Fe avenue to the intersection of Washington Court; then southeasterly behind a block of properties facing Washington Court to the intersection of Washington Avenue with Crest Avenue.

The southern boundary of the District follows a local road, Crest, which also follows a contour line. The crest ends at Nickols Knob and District boundary then turns northeast to join East Richmond Avenue.

The boundary is then marked by East Richmond until Railroad Avenue. The boundary then follows Railroad Avenue until it meets Route 17. Although there are no houses near Nickols Knob, it is included in the district because it is named after a man important in the District's historical development. The crest of the Potrero separates (see continuation sheet)

### STATEMENT OF SIGNIFICANCE

#### SIGNIFICANCE

##### A. Architecture and History

The Point Richmond District is significant in terms of architecture and history.

In the area of architecture the Point Richmond District is a coherent representation of a turn-of-the-century industrial town. The Point Richmond District, through coherence of urban design and maintenance of older structures, possesses the aura of a bygone day.

In the area of history the Point Richmond is the nucleus which formed the City of Richmond. It is also important to the San Francisco Bay Area as a whole because it represents a unique developmental history for the region. It still exists relatively unchanged from its beginnings and it continues to possess integrity and isolation. These latter two factors, in particular, contribute to its continued preservation.

##### B. Discussion of Intrusions

In general, intrusions have been identified as structures or uses which are clearly incompatible with the character of the District. This incompatibility may be in the area of scale (e.g., a high-rise apartment in a single family residential district), style (e.g., postwar design among Victoria-era buildings), material (e.g., cinder block building among frame or brick buildings), or use (e.g., warehousing in a residential area). It should be noted that "modernized" older buildings have not been viewed as intrusions. While modernization changes details, the basic scale of the building remains, as well as its original materials; restoration is often possible. Impact of intrusions is assessed below, relative to members and size of the intrusions.

The Point Richmond District has, until quite recently, been comprised of a small community center of shops, restaurants, theaters, taverns and churches, surrounded on three sides by

Explanation for change of title for application for nomination to the  
National Register of Historic Places

The original "Request for Determination of Eligibility for Inclusion in the National Register of Historic Places", submitted by the Environmental Planning Branch, CALTRANS, District 04 in 1977, was made for "East Yard District", in the City of Richmond, Contra Costa County, California 94801.

Subsequent research<sup>1&2</sup> has established the fact that the area for which District classification is sought has, historically, never been known as East Yard, but always as Point Richmond.

For a brief period around the turn of the century, a dispute occurred about the name for a post office in the Point Richmond area. The first Richmond post office was located at Barrett and A Streets, and in order to avoid confusion, when a second post office was needed in Point Richmond, the postal authorities called it "East Yard". This name was chosen because the Santa Fe Railroad was calling its San Francisco yards "The West Yards" and the Richmond yard, on the east side of San Francisco Bay, "The East Yard". So much opposition to this name resulted, from Point Richmond residents, that the postal authorities relented, and changed the name of the post office to Point Richmond.

In 1977 when the final environmental study and negative declaration was prepared (by the U. S. Department of Transportation, Federal Highway Administration and State of California, Department of Transportation) for a grade separation for California State Highway, Route 17 (from Canal Boulevard to Castro Street in Richmond, California), a portion of Point Richmond, which is southerly of the proposed project, was studied for determination of eligibility as a historical district. Coordinators, Mara Melandry (District 04) and Lois Webb (District 07). Subsequently (March 1978), an addendum was prepared by the Environmental Planning Branch (CALTRANS, District 04) in response to questions raised by the National Park Service, concerning boundaries. In addition, a discussion of intrusions in the proposed District comprised a portion of the March 1978 addendum.

On July 24, 1978, the Keeper of the National Register issued E. O. 11593, "Determination of Eligibility Notification for the 'East Yard District'" with the finding that the District is eligible. The Point Richmond Historic Association, in preparing this nomination, has drawn freely upon the original 1977 "Request for Determination of Eligibility for Inclusion in the National Register of Historic Places", and the 1978 Addendum. the District from the more recent construction on the southwest side of the hill which overlooks San Francisco Bay.

This boundary is also marked by sharp changes in the architectural character of the buildings located between the boundary and the shoreline of San Francisco Bay. The buildings near the shoreline are of more recent construction as can be seen by comparing the photographs of buildings within the District with those of buildings outside the District. They are numbered 7-20 to 7-23.

The Point Richmond District is situated partly on the steep northeast facing slope of the Potrero; the hillside overlooks the Santa Fe rail yards, the vast Standard Oil refinery, and the newer residential portions of the City of Richmond to the east. The District's center is located on a relatively flat portion of the area; it includes small shops and restaurants, several churches and a recently constructed community center, library, and fire station. The steep hillsides of the Potrero are dotted with houses lining the streets, which for the most part are narrow and winding. The predominant architectural style is turn of the century; there are Victorian houses of modest size, brick commercial structures, and brick or wood churches. See photographs in Appendix A.

The Point Richmond District is small in scale; few structures exceed two stories in height. The older hillside homes rise above the streets with steep stairways leading to the front doors. Newer housing is built downward along the slopes with garages at street level. This indicates the historical difference between the pedestrian-oriented designs of the past and the automobile-orientation of more recent construction.

The Point Richmond District has a distinct community center, a triangle, bounded by Washington and W. Richmond Avenues and Park Place. See Exhibit 2, Detailed Map of District.

Brick and wood buildings which house shops, restaurants, a theater, and taverns face a central three-sided plot of land. A community center and public library, combined in one building, and a fire station are located here. These cement masonry buildings are of recent vintage and contrast architecturally with the consistent use of brick and wood and coherent style of the older buildings facing the central plot of land.

Near the town center at W. Richmond Avenue's intersection with Martina Street is the First United Methodist Church of Richmond. It is the oldest permanent church building in Richmond and was built in 1906 on the site of an earlier frame building. Next door at 305 W. Richmond is Our Lady of Mercy Church (Catholic); it is the second church building in Richmond. See photographs in Appendix A.

C. Historical Description

Before the arrival of Europeans and for some time after, the Potrero was an island separated from the mainland by extensive mud flats and sloughs. See Exhibit 3, a USGS map from 1899 for the location of the sloughs and mud flats. In the late 19th century, the Potrero was further isolated from the mainland by the dredging of a canal deep enough to accommodate sloops traveling between Ellis Landing and San Pablo Bay. See Exhibit 3. By the end of the 19th century, the island became a peninsula because portions of the marshes had become solid land, through a combination of natural silting and intentional diking and filling. See Exhibit 4, a 1915 USGS map, for evidence of the development of a peninsula where an island had existed before.

Although no longer physically an island, the District has retained its isolation, the barrier of the sloughs and canal having been replaced by the Standard Oil Company refinery, the Santa Fe rail yards, and Route 17. The District is situated on lands which belonged to the San Pablo Rancho, after written history began in California.<sup>1</sup> This 17,000-acre holding was granted to Don Francisco Castro in 1823. See Exhibit 5 which shows the general area of the Rancho San Pablo. The headquarters of the Rancho were in what is now the City of San Pablo. Castro began a thriving business of ranching in his private fiefdom. After his demise in 1831, deaths, contested inheritances, imprudent borrowings, squatters, and inaccurate boundaries clouded titles to the land. As the various claimants struggled to establish title to an area with great economic potential, one of the most celebrated land cases in the United States began. Eventually, after a 40-year court battle, the lands were finally granted to 148 claimants in March 1894. The claimants were a mixed bag; some were holdovers from the Mexican period, others were of Irish or Scottish background, and still others were disappointed miners who had failed to find their riches in the gold fields. See Exhibit 5 for the names of the claimants who were successful. Many of the holdings were large enough to be developed as town centers. This was true of the holdings on the Potrero. During both the rancho and land litigation phases, the main successful economic activities were cattle-raising and hay production; the population remained small and scattered.

With the settlement of the land case, it was possible for ambitious men and expanding businesses of the industrializing United States to fulfill their dreams of

wealth. One of these industries was the Santa Fe Railroad. It had long sought a route from the central valley of California to the East Bay and hence to San Francisco. Persuaded by A. S. MacDonald, a local entrepreneur of considerable ambition and vision, Santa Fe decided to make the Richmond area the terminus of its transcontinental line. In 1897, Santa Fe purchased the bankrupt San Francisco and San Joaquin Railway which owned land in the East Yard area and which had already built a segment of track through the defunct Rancho San Pablo. Soon after its purchase, Santa Fe began to build a terminal, shops and yard for its operations in the area northeast of the Potrero. Thus, East Yard began as a small railroad town; at the beginning of the construction work, only 100 men were employed by Santa Fe, but later developments were to soon swell this figure. Santa Fe also built a tunnel through the Potrero to link the trains with the transbay ferry at Ferry Point. See Exhibit 4 for its location which is indicated as Richmond Point. Although the ferry operation in Richmond was not the first in the Bay Area, Oakland already having obtained that honor, the Richmond-San Francisco route was certainly more efficient; it cut 12 miles off the trip between the East Bay and San Francisco. Santa Fe had completed construction to Ferry Point by July 3, 1900 when the first overland passenger train arrived from Chicago en route to San Francisco. The transbay ferry service for railroad passengers continued until April of 1933.

A concomitant and equally significant development concerns the Pacific Oil Company, later to be Standard Oil. In 1901, the oil company, a mere infant of industry at that time, purchased 85 acres of land just north of the Potrero. It proceeded to construct a major West Coast oil refinery which produced its first oil in July 1902. From that time until 1940, Standard Oil was the single largest employer in the Richmond area.

The result of the Santa Fe and Standard Oil operations was a rapid population expansion in the Point Richmond District, as men sought work with the burgeoning businesses. Hotels, shops, and taverns were built; one tavern, the Baltic, which is still located in the town center and has been carefully restored, had a regular patron of world repute, Jack London. The oil executives had luxurious suites in the Hotel Mac or New Todd Hotel, both of which are still standing today; the workers lived in the modest housing in the District. See photographs in Appendix A.

However, A. S. MacDonald felt that the Potrero had limitations as the industrial center he envisioned for the future Richmond; it was too small and too hilly. Through various real estate deals with Santa Fe, he shifted the city center from Point Richmond to the mainland by subdividing the 550-acre Barrett Ranch. See Exhibits 3 and 4. The center of population shifted accordingly. Even so, when Richmond incorporated in 1905 with a population of 2,118, Point Richmond also included in the incorporated areas, was selected as the location of the first city hall. This first government center was located in one floor of the Critchett Hotel at the corner of Washington and Richmond Avenues. The building has since been replaced by a modern market. By 1909, the space had already become inadequate for the growing town and the city hall was moved to a building at 210 Washington Avenue. This building is still standing and is in use today. But in 1915, the city hall was moved to the mainland where the majority of the population now lived.

Thus, Point Richmond lost its role as both population and government center. Nevertheless, it was the nucleus for the formation of the City of Richmond. The town, born at the turn of the century because of Santa Fe and Standard

Oil, remains much the same in appearance. Little growth, other than on the bay side of the Potrero, has occurred since the shift of the city's center to the mainland. The Point Richmond District, through the zealous efforts of its preservation-minded residents, retains its identity. Many of the older buildings, both residential and commercial, have been restored, rehabilitated or otherwise improved. Vigorous participation in local government has preserved the Point Richmond District as a distinct community.

Architectural Character

During the principal period of development in Point Richmond (1900-1920) the home builders drew liberally from a variety of popular Bay Area architectural styles, including the Queen Anne, San Francisco Stick, Neo-Classical, Eastern Shingle, Brown Shingle, Craftsman Bungalow, and California Bungalow. All of these designs were executed principally in their diminutive cottage or row house form with subdued styling and ornament, as compared to contemporary development in the more affluent neighborhoods of Oakland or San Francisco. The Queen Anne Cottage and a number of variations of the Neo-Classical Row House are more numerous than the other styles, and the more decorative examples of Italianate and Stick-Eastlake are conspicuously absent. The variations in these rather modest designs required by a steep topography with upslope, downslope, and level siting creates an interesting and playful interchange in scale and accessories that contributes greatly to the attractiveness of the community.

With the exception of the four churches and a very small number of commercial buildings such as the Hotel Mac (designed by architect W. O. Clausen in 1910), there is little evidence of the use of professional architectural design on specific buildings in Point Richmond. Most dwellings and business buildings were likely constructed by small contractors or carpenters who had practiced their trade in the earlier building booms of Oakland and San Francisco with the help of mail order plans or pattern books, and the ever available selection of prefabricated structural and decorative building elements from the local mill. The commercial storefronts likewise indicate a carpenter adaptation of the styles of the day interpreted in either wood or brick with typically a two-story, flat-roofed building including parapets, upper bay windows, storefront windows and doors with clerestory and "light shelf" above, and retractable awnings over the sidewalk. Two brick buildings (the Hotel Mac, 1910, and the Richmond Fire Station No. 1, 1912) have sheet metal cornices complete with brackets, dentils, and egg and dart mouldings.

As the city of Richmond began moving inland in 1915, some of the same styles used in Point Richmond began to dot the flatland subdivisions. However, today the overwhelming architectural character of the portion of Richmond built up between 1920 and 1945 is set by later styles, including period revivals (principally Mediterranean) and the simple wartime tract house. Development in Point Richmond essentially stopped with the beginning of the 1920's and did not show any significant activity until the 1950's and 1960's when several small apartment buildings were constructed in scattered vacant sites. These intrusions built of wood frame and stucco, usually two stories with parking under and exposed to the street, were unfortunate additions to the Point because of their low quality and lack of design sensibility for the materials and scale of existing adjacent development from the earlier period.

(Architectural Character)

It is the consistency of scale, materials and architectural style that is essential to the unique character of Point Richmond and sets it apart as a distinct neighborhood, complete as a small town in itself, that is relatively unchanged from its appearance in 1920. Extensive settlement of Contra Costa County began only after the 1906 San Francisco Earthquake, and Point Richmond is the only distinct community in the county which sprang up early enough and with sufficient exuberance to reflect the last gasps of the dying age of American Victorian architecture.

modest late Victorian and early 20th century (bungalowoid) single-family dwellings. A few homes from the 1930s and 1940s are interspersed, but these support the District's architectural and historical qualities. Intrusions within the District fall into two general categories, both of which date from the 1950s and 1960s: modern single-family dwellings which differ greatly from earlier houses in terms of scale, design, and orientation; and modern multiple-family apartment units, which also differ from the District's turn-of-the-century hotel and apartments in scale, design, orientation, and location. The location of the intrusions are shown on Exhibit 7.

Intruding single-family dwellings are generally larger, of designs which are incompatible with the older, more traditional gable and hipped-roof designs, and use materials such as stucco and cinder-block and aluminum which differ from the older wood-sheathed homes. They are usually built downslope to allow for garages at street level, indicating an orientation away from the street, and at the same time, dependency on the automobile. Such intrusions are typified in photographs 7.7 to 7.10. These are also typical of the structures, located west of the District down to the shoreline, which may be seen in photographs 7.20 to 7.23.

Intruding apartment units also clearly detract from the District's qualities. Historically, the District's hotels and other multiple-family housing units were located in the core area near the community center. These were of architectural styles typical of the turn of the century and their proportions were in keeping with the nearby commercial buildings. They were oriented to the street. Intruding apartments are automobile-oriented, generally with parking on ground level with living units above. They are situated away from the core area, as can be seen on Exhibit 1, and like the modern houses, are built downslope so that their orientation is away from the street. They differ in

style and materials from the older units. Furthermore, the location of many of these modern units near the crest of the Potrero renders them an intrusion in an area which was traditionally single-family dwellings. An example of these modern units is shown in Photograph 7.13.

The impact of the intrusions on the District is moderate, and thus far, this impact occurs mainly along its irregular southwest boundary. This is due mainly to the location of new construction, both single- and multiple-family units, near the crest of the Potrero in order to take advantage of view qualities. Intrusion occurs to a much lesser extent in the core of the District near the community center. The impact of the intrusions is mainly visual: the size of the units, combined with their siting, makes them visible from almost the entire District. In the entire District, there are about 477 buildings, of which 64 are classified as intrusions.

C. Level of Archaeological Research

CALTRANS employed Archaeological Consulting Research and Services, Inc., to perform archaeological research. The research conducted revealed that no recorded archaeological sites are within the boundaries of the proposed improvements to State Route 17; their field reconnaissance, which noted the difficulties caused by large surfaced areas, structures, and debris, revealed no archaeological resources. Inspection of Exhibits 3 and 4 indicate that the project area was originally one of tidal marshes, mud flats, and sloughs. In the late 18th century, a canal for bay vessels was dredged in the project area. Later, through natural silting and intentional filling, the project area assumed its present topographic form. Given the above evidence, further extensive research seems unjustifiable. By National Park Service's own definition, the use of mechanical equipment

to survey paved or debris-laden areas is justifiable only "where the literature search has shown a high probability for historic or prehistoric resources" or "in areas where it is clearly impossible to demonstrate the absence or potential for absence of resources within the project area". The literature search fails to provide probability and the period maps reveal the character of the area to be such that the potential for absence of archaeological resources is demonstrated.

The "Request for Eligibility" prepared by CALTRANS indicated that the recommendations of Archaeological Consulting and Research Services, Inc. for surface inspections following the removal of debris, pavement, and buildings for construction of the project, as well as provisions for action to be taken in the event that archaeological remains are encountered during the project, are both justifiable and adequate.

**JUSTIFICATION FOR BOUNDARY CHANGE**

The Point Richmond Historic District was determined eligible for listing in the National Register of Historic Places on July 24, 1978; the determination was submitted as the "East Yard District" by the Federal Highway Administration. At the time the documentation for the determination was submitted, the southwestern boundary extended over the crest of the ridge and included an area which was composed primarily of open space and a few scattered structures. New construction was already occurring in this area, and has continued at an accelerated pace. This portion of the area was visited on site by representatives of the Point Richmond Historical Association and the California Office of Historic Preservation during the preparation of the present National Register nomination forms. It was immediately apparent to all parties making the inspection that the impact of new construction would require a reevaluation of the original boundaries in the area along the ridge. The Point Richmond Historical Association inventoried the buildings included in that particular portion of the district as defined in the Request for Determination and found that out of 18 acres and 50 buildings, only 10 potentially contributing structures existed in the area; all other properties were new structures which had no contributing historical value. The boundaries in this area, therefore, were revised on the basis of remaining integrity. The attached photographs document the present appearance of the area eliminated by the change of boundaries.





POINT RICHMOND










1899 USGS QUADRANGLE MAP  
(Portion of San Francisco Quad)







2. The data base was the Assessment Roll of Property in Contra Costa County for the year 1977-78, which was the latest available at the time of the survey.
3. A list of every property within the bounds of the District was prepared with the following data:
  - a. Assessor parcel number
  - b. Street address (if improved)
  - c. Owner's name and address
  - d. Owner occupied (from records of homeowner tax exemptions)  
The properties are listed in chronological order of assessor parcel number.
4. Every structure within the District was photographed. On 27 October 1978, Aaron Gallup of the California Office of Historic Preservation met with members of the Point Richmond Historical Association to select those structures which are "contributing" to the District. This was accomplished first by viewing the photographs and then by field confirmation.
5. A notation was then added to each property on the master list of the District to denote its historical status as either contributing, non-contributing or vacant.

**Amendment**

442 Golden Gate Avenue was listed as a contributor to the Point Richmond National Register District in 1979. The district was listed under Criteria A and C in the areas of growth and development and architecture during the years 1900 to 1920. Recent research and survey work by Carey and Co. Inc., on behalf of the owner, demonstrate the resource was not eligible at the time of its listing because it dates after the National Register district's period of significance.

The building is two stories with ground floor garage and second story dwelling unit. A one story addition is attached to the rear. The recent research suggests the building originated as a single story building between 1932 and 1945. A second story was added in 1956 and a rear addition completed prior to 1979.

Because 442 Golden Gate Avenue was not present in its current state or any earlier state during the district's period of significance (1900-1920), the building's status as a contributor to the Point Richmond Historic District should be changed to noncontributor.
