ARCHITECTURAL SIGNIFICANCE: from the Classical Revival period. Its architectural significanc lies in the fact that it was probably built to impress the owners' neighbors by sheer size rather than style, thus making a social statement on early 20th century Columbusites.

IV. Significance

Local History: While this house is significant as the home of John Bleecher, general manager of the Columbus Railroad Company, it is most often associated with Robert E. Dismukes, son of Elisha P. Dismukes (MRN #387). Robert was a lawyer in the firm of Dismukes and Worsley, and later, practicing by himself, he served Columbusites from 1902 to 1932. He was co-owner of the R.E. Dismukes Insurance Agency, Vice-President of the Georgia Manufacturing Company, which his father owned, and Director of Columbus Manufacturing, a local cotton mill. He served on the Columbus City Council for 16 years, as well as being a Columbus Commissioner and Chairman of the Muscogee County Democratic Committee. In effect, he was very involved in local politics and business, carrying on the family tradition. While his home is perhaps not of the most important architectural style in Columbus, as has been suggested, it is certainly significant as the home of this very important Columbusite.
