This home is an Eastlake cottage built in 1890. It is a story and half, wood frame building, with a full daylight basement. The owner occupies the house and it is in good condition. The rehabilitation work has been started and the house will be undergoing long-term restoration.

The house is located in the Ewauna Heights Addition to what is now Klamath Falls, formerly Linkville, Klamath County, Oregon. This Ewauna Heights Addition comprises a portion of Lot 5, Section 32, Township 38 South, Range 9, East of Willamette Meridian. This Addition was platted September, 1900. The house is located on a portion of Lot 2 and all of Lot 3, in Block 5 on High Street. The front view of the house faces southeast, overlooking downtown and Lake Ewauna. This neighborhood is one of the oldest in Klamath Falls.

Neither the architect (if any) nor the builder has been identified. This Eastlake cottage built in 1890 represents a distinct house type that was popular in the 1800's. Houses of this sort are typically built on a story and half, raised basement plan. The combination of Queen Anne and Eastlake decorative elements was common in houses built in this period. Their distinguishing features included gable and hiproofs, asymmetrical facade with centered entryway, recessed between a slanted bay window and screened porch. Turned columns are on the three corners of the porch.

The gable end above the slant bay window has imbricated shingles. The frieze panel in the center is a basket weave design, with sun bursts on each side. On each corner of the bay window are curved brackets with pendants. The screened porch gable also has fish scale shingles with a gilded sunburst in the peak of the gable.

The gables have round disks (or "paterae") set into the verge boards.

The east side of the house has a hooded and bracketed square bay window, with wainscotting above and below the window. The gable above also has fish scale shingles with a bedroom window in the center with half a sun burst at the peak, and round disks also set into the gable boards.

The windows are one over one, double-hung, wooden windows. Wide plane molding trims the exterior windows and doors. The modern cover is being removed and drop siding covers the exterior of the house. There is a corbelled capped flue in the kitchen, and the fireplace chimney is also corbelled capped.

Viewing the house from the front, there are three doors with transoms. They are three panel doors with ornate molding around each panel, with wood floral decorative design between the top panel and glass, opening onto the entryway. The door on the right opens into a screened-in porch, that has wainscotting on the walls and tongue-in-groove ceiling.

The door on the left opens into the parlor. The focal point of the Parlor is a Victorian corner fireplace, that is 7'6" high and 5' wide, with a french bevel plate mirror. The full length oak columns are 11 inches in circumference topped with beautiful ornamental caps. The upper boxed shelf has a floral decorative design in the center, composition lion heads above each column. It has green french tile, opening from woodwork to woodwork, with the hearth running the full length of the mantle. The combination grate for burning wood and soft coal has a heavy cast iron fire pot. The steel frame has projecting canopy at the top with an ornamental steel summer front, dated July, 1891.

The center door opens into the rest of the lower floor rooms, consisting of a family room which is a combination formal dining room and sitting room, hallway, kitchen, breakfast room, pantry, bathroom and bedroom. A 50' wide staircase from the hallway leads to the two bedrooms upstairs.

The ceilings are 9' high with the original 2" wide picture frame molding. The trim on the windows and doors are symmetrically molded frames with circular corner blocks. The baseboards are all capped with a simple molding. The floors are 4" tonguein-groove oak.

All the rooms inside have the original four-panel doors with the Mayfair design, door locks and butts. The hallway has an interesting round window. Between the kitchen and breakfast room is a wainscotted cupboard that provides access to a hand-cranked wood lift. The pantry has 12" thick walls insulated with sawdust, a built-in cabinet that has a tin floor bin and shelves along the wall.

The bathroom has a water closet with a loose board tank, and a six' tub with claw feet.

SHPO SUMMARY

The one-and-a-half story Queen Anne/Eastlake cottage located near the foot of High Street in the Ewauna Heights Addition of Klamath Falls that is distinguished by its gabled, polygonal facade bay overlooks the old industrial section bordering Lake Ewauna on the Klamath River. The house is thought to have been built about 1890, during the time the property was owned by Warren Mills and between two disastrous fires that destroyed much of the original business district. Nothing is known of the occupation or status of Warren Mills except that he held title to the nominated property from 1888 to 1895.

The Mills House represents good quality working class housing of the early period of development in the Klamath County seat. As a generally well preserved and singular example of popular pattern book type, locally, it meets National Register Criterion C.

Klamath Falls evolved from a trading post and ferry crossing on the Link River. By 1889, the year Linkville was incorporated, the river was providing power to mills and factories. When the Southern Pacific Railroad connected the community renamed Klamath Falls to national markets after the turn of the century, mills sprang up on Upper Klamath Lake and Lake Ewauna (separated by a fall of 60 feet) to manufacture dimension lumber and boxes from the vast resources of pine forests on the east slope of the Cascade Range.

As is pointed out in the Klamath Falls Cultural Resources Survey historical overview, the most prominent of factories on Lake Ewauna was that of the Ewauna Box Company, which commenced operations in 1912. After expanding facilities in the 1920s, the company employed as many as 500 people. The plant was considered one of the largest of its kind in the West.

As the population of Klamath Falls grew at the turn of the century, residential development expanded from level terrain surrounding the original settlement and climbed north. Ewauna Heights was platted in 1900, and a neighborhood of factory owners and workers took root.

The Queen Anne/Eastlake cottage around which the subdivision developed is characterized by a compact, rectangular plan, a gable roof and asymmetrical facade organization in which a gabled parlor section and a subordinate, gabled sun porch project at a right angle from the front roof slope. The front entry, approached by a long flight of steps from High Street, is centered between the two cross gable sections. Because of the sloping site, the southeastfacing building has a daylight basement at the front.

By its picturesque asymmetry, corbelled brick chimney, variegated siding and patterned stickwork, the cottage exhibits the essential characteristics of its stylistic type. The array of surface decoration includes vergeboards embellished with bosses, imbricated shingle cladding in gable ends, frieze and water skirt of vertical tongue and groove mill stock, bracketed jetties, spandrel panels of basket weave and sunburst patterns, molded string courses, fancy bed molding, scrolled composition relief ornament, and so on. The body of the exterior is clad with novelty, or drop siding. Until recently, it was obscured by non-historic covering, which was removed in the summer of 1992. Restoration of missing trim elements is underway. Window openings with plain surrounds are fitted with double-hung sash having one-over-one lights.

The interior of the Mills House is conventionally organized with a parlor to the left of the entrance, a dining room behind the screened porch on the right. Behind the parlor is a bed chamber/sitting room. A back staircase gives access to two upstairs bedrooms. The kitchen, pantry and bathroom are contained in a single-story lean-to section across the back of the house.

Original door and window trim and bases are intact. Along with stock elements of exterior decoration, the corner fireplace in the parlor, with its column-supported tabernacle frame for a mirrored overmantle and its art tile chimney front and pressed metal firebox fittings, hint of a mail order source.

The house was modified in later years by a concrete block basement with altered window openings, a replacement porch railing and nonhistoric siding. As previously mentioned, the present owner removed the modern covering in 1992 to reveal original variegated cladding, and is embarked on other restoration work.

the proponent's analysis of comparable properties, based on the Klamath Falls Cultural Resources Survey of 1986, turned up three other story-and-a-half cottages related in style to the Mills House. The subject house appears to be in the oldest in the sample and the sole representative of a distinctive and ubiquitous type having the asymmetrical slant bay front.

The nominated property stands in the community originally known as Linkville. Linkville, as Klamath Falls was first called, was established in 1867, when George Nurse opened a trading post and ferry on Link River. When the post office first opened in 1871, Linkville had a store, hotel, blacksmith shop, several homes and approximately 40 residents. In 1874, Linkville was named the temporary county seat of Lake County. In 1883, George Nurse sold Lot 5, Section 32, Township 38 South, Range 9 East, to W.I. Nichols. In 1888, W.I. Nichols sold the property to Warren Mills, who constructed or had the house built on the property in 1890. By that time, Klamath County had been formally recognize with Linkville as the county seat. The town had 384 people. As the economy thrived, disastrous fires, between September 1889 and July 1894, devastated the central business district. Consequently, houses in the surrounding neighborhoods are among the few buildings surviving from the 19th C.

The new century brought new life to Klamath Falls. A power plant was built on the east bank of Link River in 1900. The same year, the property this home sits on was platted and named Ewauna Heights. From 1901 to 1903, the first railroad to enter the county was constructed to serve the lumber mills. New additions were platted and some 80 buildings were under construction, including two large schools, a hotel, and several commercial buildings. The population, which numbered 447 in 1900 was counted as 2,758 by 1910. Lumber companies and box factories were steadily constructed; by 1913, there were 39 sawmills and 8 box factories which employed 4,200 people in the Klamath Basin.

In 1908 there were 62 homes in the First Addition and the Ewauna Heights area. Pine Street and High Street filled up first, then as level ground was built over, climbed to Washington Street and Jefferson Street. During the teens and twenties, the northern residential district, especially Ewauna Heights, became fashionable. The Daggett family, co-owners of Ewauna Box, built in Ewauna Heights in the 1920's.

The Mills House represents good-quality working class housing of the early period of Klamath Falls upbuilding. It is an intact example of a distinctive type now relatively rare locally, namely the story-and-a-half Queen Anne/Eastlake cottage.

The houses found in the Historic Resources Survey that compare in style and period have an individual personality, but do not have the original exterior details and ornamentation of mine. For instance, 532 Riverside is a one and a half story Queen Anne with basement. Alterations over the years have removed most of the original detailing and the front porch. The octangular turnet and highly ornamental gable are the only distinctive features that remain.

The home at 232 Cedar Street was built soon after the turn of the century. The builder incorporated several features, the shingles on the gable ends and multiple roof forms and ornamentation at the peak of the front gable.

The house of seven gables, 31 Pine, has a small tower with conical roof. Its four gables, each filled with fish scaled shingles and decorative barge boards. It has two bay windows, and a small oval front window.

The Benson home, 137 High, has hexagon towers, joined with a gabled roof with centered recessed entryway.

The Warren Mill s house, is distinctive architecturally and may be something of a rarity in Klamath Falls. There were either very few built here or very few has survived. It retains both character and integrity, thus enhancing its contribution as an important resource that conveys historic associations with the period of intense development in the community.

BOUNDARY DESCRIPTION

It is otherwise identified as Tax Lot 5300 at said location.

The nominated area encompasses the entire parcel of 6,270 square feet occupied by an Eastlake cottage believed to have been built in 1890 for Warren Mills.
