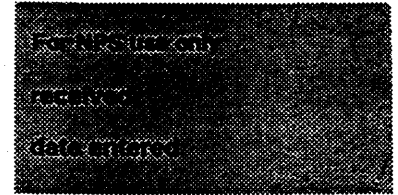

1. Name: Acklin Store, survey number 51
2. Location: north side of Highway 90 approximately 3/10 of a mile west of junction with S. Highway 61
4. Owner: Santa Fe Mountaineering Center; Route 4, Box 34c, Santa FE, New Mexico 87501
7. Description: Photo 45; 2-story L-shaped section with 1-story section in L; foundation unknown; stuccoed and unstuccoed adobe with clapboard on second story of facade and 1-story section; corrugated metal gable (2-story) and shed (1-story) roofs; 1/1, 2/2 double hung windows singly and in pairs, fixed display windows with transom; double doors, recessed behind screen doors, with transom. Two single doors on second floor of facade imply previous porch.
8. Significance: Henry Acklin, miner from Georgetown, moved to this location about 1920 and built this store. During the following decade he built a number of rental houses and the area became known as Acklin Hill. It became one of the commercial center for the mid-Mimbres valley area and this the major building in Acklin Hill therefor meets Criterion A. Since he also had an interest in a store at San Lorenzo, Henry Acklin was involved in selling goods and extending credit to many farmers in the area. The building, although built of adobe, employes a fairly typical vernacular commercial type with its centered door and large store display windows, and its residential space above on the second floor.

Verbal boundary: A rectangle, roughly 80' by 70', formed by lines parallel to and ten feet from the exterior walls of the building. Since this is an unplatted area, this boundary has been created to include only the store.
