7. <u>Description</u>: Photo 45; 2-story L-shaped section with 1story section in L; foundation unknown; stuccoed and unstuccoed adobe with clapboard on second story of facade and 1-story section; corrugated metal gable (2-story) and shed (1-story) roofs; 1/1, 2/2 double hung windows singly and in pairs, fixed display windows with transom; double doors, recessed behind screen doors, with transom. Two single doors on second floor of facade imply previous porch.

8. <u>Significance</u>: Henry Acklin, miner from Georgetown, moved to this location about 1920 and built this store. During the following decade he built a number of rental houses and the area became known as Acklin Hill. It became one of the commercial center for the mid-Mimbres valley area and this the major building in Acklin Hill therefor meets Criterion A. Since he also had an interest in a store at San Lorenzo, Henry Acklin was involved in selling goods and extending credit to many farmers in the area. The building, although built of adobe, employes a fairly typical vernacular commercial type with its centered door and large store display windows, and its residential space above on the second floor.
