

SUMMARY

The Threlkeld House is located on North Boston Avenue in Russellville, Arkansas, Pope County. The house is situated on a large corner lot at the intersection of North Boston Avenue and East "M" Street, and is located in a commercial/residential neighborhood approximately one thousand feet from the entrance to Arkansas Tech University. The one-and-a-half story clapboard home is designed in the Plain/Traditional style with a rectangular floor plan on a cut stone foundation. The interior of the house features original woodwork, one-over-one double-hung windows, and a simple brick mantelpiece. The Threlkeld House is the oldest and the only, intact example of the Plain/Traditional design within a two-block radius to the east, and a one block radius north and south. The bulk of the housing stock in the neighborhood consists of modern structures, dating from the mid-1940s to the 1980s. The block to the south of the home on North Boston Avenue contains three Craftsman homes, one of which is unaltered. Arkansas Avenue to the rear (west) of the Threlkeld House is solidly commercial, while the campus of Arkansas Tech is located to the west of Arkansas Avenue.

ELABORATION

The Threlkeld House remains significantly unaltered from the date of its construction. The front, or eastern façade of the house features a front-facing gable with an integral one-half porch accented with one boxed column on a cut stone pier. Cut stone half-walls enclose the three concrete steps leading to the porch. The foundation is composed of limestone blocks in a regular coursed pattern. Beneath the porch are a single window and a one-light door leading into the living room. A single window lights the northeast corner of the house. A pair of thin windows light the upper floor. This façade features minimal decorative embellishments in the form of cornice returns.

Two small one-light windows placed in the foundation at the southwest corner of the southern elevation light the cellar. A one-story shed roofed wing at the southwest end of the house contains a small one-light fixed window that illuminates the cellar stairs. Fenestration on the remainder of this elevation consists of a pair of short windows, a ribbon of three slender windows on a slight square bay, and a second ribbon of three larger windows. A one-light door opens from the southeast wall of the porch into a bedroom that is thought to have been a parlor.

The rear, western facade is fenestrated by a single window at the northwest corner and a small window adjacent to a shed-roofed porch that was enclosed in the 1920s. An open flat-roofed carport supported by metal posts was also added off the enclosed porch at this time. The rear wing extends west approximately two-thirds of the width of this

elevation. A one-light window, single-leaf door, and a six-light fixed window illuminate the porch. A pair of windows lights the upper story and the gable roof culminates in cornice returns like those on the southern facade.

The northern elevation from left to right, features a ribbon of three windows, two evenly spaced windows, a second ribbon of three, and a single window at the northwest corner of the home.

Although historic photographs of the property indicate that as many as three outbuildings may have existed at one time, none remain today. The last remaining outbuilding (a workshop) deteriorated and collapsed circa 1995 when the current owner purchased the property.

Interior

The interior of the Threlkeld House has been restored and the owner has changed as little as possible. The original pine flooring is still in excellent condition as is the other woodwork throughout the house. The structure's original twelve-foot ceilings were retained, as well as all the original molding, doors, door facings, and window casings. Additionally, many of the Threlkeld's furnishings remain in the home.

The stairway to the second floor is located in a central hall. The front portion of the second floor, originally attic space, has been converted into a bedroom. The rear portion of this floor is still in its original condition, with plank walls, pine floors, and a beaded ceiling.

The root cellar is accessed from the rear wing and is unchanged. It consists of a concrete floor, block walls, and concrete steps. Two porcelain basins are recessed into the floor, presumably for cold storage. In the 1970s the Threlkelds updated the home's electrical system and replaced plaster walls with sheetrock, but original wainscoting still exists in the bathroom, kitchen and service porch. The current owner converted a bedroom into a bathroom and installed central heat and air in 1995. Also at this time additional storage cabinets were added to the kitchen.

SUMMARY

The Threlkeld House remained in the Threlkeld family from its construction in 1914 until the present owner bought the house in 1995. Beginning in the 1920s North Boston Avenue became known as "Faculty Row" because teachers from what was then the Second District Agricultural School (now Arkansas Tech University) occupied homes along that street. The president of the school during that period lived in the home across from the Threlkelds. Currently the neighborhood contains houses mainly representational of Modern styles, and there are no other Plain/Traditional homes that have undergone as few alterations as the Threlkeld House in the immediate area around the home.

ELABORATION

The Quapaw, Caddo, and Osage Indians were the original inhabitants of the area now known as Russellville. In 1808, the Osage signed a treaty giving the territory east of a line drawn from Fort Clark on the Missouri River, south to the Arkansas River and the mouth of Frog Bayou, near Alma, Arkansas to the United States. By 1828, most Native Americans had been removed to reservations in Oklahoma.

P.C. Holledger built the first house in the area originally known as Prairie. The town was named Russellville after Dr. Thomas Russell who later purchased that house. Russellville began its modern-day improvements with concrete sidewalks, paved streets and street lamps around 1908. There were three weekly papers, coal-mining companies, a small electric light plant, several grocery stores, and many other businesses, including the railroad. At about the time the Threlkeld House was constructed in 1914 Russellville's population numbered five thousand and was recognized as a thriving city of the second class in Arkansas. Home to the largest horse and mule market in the state, Russellville also contained three banks, a modern creamery, large foundry and iron works, roller flour mill, two wholesale houses, a modern hospital, city band, paved streets, and handsome well-kept homes. Russellville was considered a metropolitan area of the state.

Vardy McBee Threlkeld, the original owner of the Threlkeld House, was a field agent for the Missouri Pacific Railroad for thirty-four years. Mr. Threlkeld invested in real estate in Arkansas and the Indian Territories of Oklahoma. In 1914, the Threlkelds purchased lots three, eight, nine, ten, eleven, and twelve in block three of the Harris Agriculture School Addition to the city of Russellville, from B.F. Harris for \$1,200.00. Mr. Threlkeld hired W.R. Shewmake to complete the majority of the work on the house and on October 18th, 1914, the Threlkelds spent

their first Sunday in their new home. When the family moved to the house the Threlkelds had four children. The two female children never married and lived in the house until their deaths.

The Threlkeld family occupied the house from 1914 to 1995, which could be a factor in the retention of original features through the years. The current owner has worked to keep any modernization efforts from disturbing the integrity of the home as well. The Threlkeld House is the only example of an intact Plain/Traditional residence within a two-block radius east and a one-block radius to the north and south. The buildings on North Boston Avenue surrounding the house are modern, dating from the mid-1940s to the 1980s. Three Craftsman homes one block south of the Threlkeld House are the closest in age, but not in style. The Threlkeld House is being nominated to the National Register with local significance under Criterion C for its Plain/Traditional architecture. The house possesses great integrity and remains a good example of early Russellville and the town's middle-class housing stock.




