SUMMARY DESCRIPTION

The Edgewood Store is a large one-story building with a full basement and a small attic. The building is set upon a field stone foundation with horizontal siding of milled lumber held together with square nails covered with horizontal aluminum siding on the south and west sides. The north and east sides have their original milled lumber exterior. The Store retains its original appearance except for modernizing the interior electrical and plumbing. The Store demands one's attention as it is a beautiful 19th Century mercantile. It is the only pioneer Store remaining in this area. The building retains integrity, interior as well as exterior, to its appearance during its period of significance.

SETTING, LOCATION

The Edgewood Store is located of the shadow of Mt. Shasta, nestled in of Edgewood, California. It is in the shadow of Mt. Shasta, nestled in an area noted for its pastoral beauty. Located approximately one and one-half miles east of Interstate 5 in Siskiyou County, it is approximately seventy miles south of the Oregon border. Edgewood Road runs north and south directly in front of the building. The Store is surrounded by cattle ranches. Across Edgewood Road (east) is a small pioneer school named Butteville Elementary which is still used. The Store maintains its original design and is located at the same rural setting as during its period of significance.

EXTERIOR ELEMENTS

The Store is a one story building made of pine wood.

<u>Front (East)</u> - The Store width is 45'. It has an open wood porch extending the width of the building. There is a set of wooden steps on the front leading to Edgewood Road, and a set of wooden steps on the north side leading to a dirt parking area.

A facade extends 15' above the porch roof. Centered below the facade and below the porch roof are the two original paired entrance doors, each measuring 5' wide x 8' high. The front glass windows are original. They are on each side of the original paired entrance doors. The windows are 9' wide x 8' high.

The feed/storage room door is on the left side facing east at the front of the building. The door slides horizontally on the original iron track. This area was used as a loading dock.

There is a door and window on the right front side facing east. This door was the entry/exit to the Post Office. The Post Office no longer exists.

<u>Side (North)</u> - The north porch, 60' long x 9' wide, was enclosed in the 1960's. Originally, the porch was open and used to display farm equipment, carriages, etc. It was enclosed and became a Post Office.

Railroad tracks are approximately 200' north of the building.

<u>Side (South)</u> - The building's south side is 60'. The original foundation, still visible, is made of field stone. From the top of the stone foundation, the building is pine ship-lap covered by vertical aluminum siding. The aluminum siding was installed in 1973. There are two original windows approximately 15' up from the foundation.

Back (West) - The building's west side is 45'. It is original pine ship-lap covered by horizontal aluminum siding. The aluminum siding was intalled in 1973. There are two sets of wood steps. There is L-shaped living quarters west to north. The owner lives here. Living quarters have been in the back of the Store since its origin.

<u>Roof</u> - The roof is 35' tall. Today, the original wood shingles are covered by vertical aluminum. When the Store is renovated, the original wood shingle roof will be restored. There is an original brick chimney on the west end which leads to the interior living quarters. It is obsolete. The front (east) roof butts the front facade.

INTERIOR ELEMENTS

The interior of the building is pine. It has the original wood ship-lap floor and ceiling. Wood shelves were added in the 1960's. It is assumed the tracks for rolling ladders were removed when the wood shelves were installed because the original ladder is in storage. Please see Exhibit A - Interior of Store.

DISCUSSION OF INTEGRITY

The Edgewood Store, in its totality, retains a majority of integrity to the period it achieved its significance. The character defining elements of the building have been left intact while the Store has been brought up to code to operate as a general store. The original Store front has remained the same for more than 100 years.

Other than the aforementioned installation of an aluminum roof over the original wood shingles (date unknown) and aluminum siding on the south and west sides (1973) and the enclosure of the north porch, the building retains a majority of its integrity.

In the building's interior, the major modification was the installation of wooden shelves in the 1960's. The electrical and plumbing were updated in 1972. Electricity has replaced oil lamps, and the outhouse is now a toilet.

HISTORICAL BACKGROUND

Edgewood, in the true spirit of frontier life, originated as a stage stop in the early 19th Century. It was a station on the California - Oregon stage road between Edson's (Gazelle P. O.) and Strawberry Valley (Berryvale P. O. - today's Mt. Shasta). Edgewood was first known as Butteville (1856), then Cavanaugh's (1860), and Edgwood (1870). The name was changed, for the last time, to Edgewood in 1902. Edgewood was considered the most important place on the line because it was centrally located between Gaselle and Berryvale. At the time, the Emporium was considered the community focal point. It was at the Emporium that people met, exchanged ideas and news. Neighbors and friends depended on this location for their social activities beyond home and family.

The first settlement in the area was made in late 1851 by William and Jackson Brown. In 1856, a man named W. Starr built a store and saloon. Joseph Cavanaugh purchased the store, saloon, and land from Starr in 1858. Cavanaugh then built a hotel. Other businesses and buildings appearing in Edgewood in the 1800's were: Bowles Lumber Mill (1854), later becoming a grist mill, Patterson's Bar and Hotel, Mountainview Creamery (1894), which was originally the Edgewood Creamery, Bob Campbell's Dance Hall and Saloon, Joe Rantz's Blacksmith Shop, Bagley's Dogtown Saloon (removed from Edgewood and stored at the Jacksonville Museum in Jacksonville, Oregon).

The Edgewood School (1865) is now Butteville School and is an active elementary school. Other businesses, etc., were the Southern Pacific Depot - bunk house for section workers, section house (1886), Town Hall (1875), Church (demolished in early 1900's), Post Office (1870), Jail (?), Shoe Repair Shop (?), Power Plant (1912). The Cemetery (1869) is still housing new occupants.

Butteville was the center of community life for Southern Shasta Valley from 1856 until the arrival of the railroad in 1887. In 1887, the townsite of Butteville shifted north and became Edgwood. Edgwood was a main stop for the railroad. The town prospered from farming, lumbering, town business and the railroad transportation business.

During the late 1800's, Joseph Cavanaugh's two sons began making their mark on the Edgwood landscape. Richard became a cattleman. Edward became a businessman. Edward built the Edgwood Emporium on its present site in 1888. The land on which the present Edgewood Store sits was built on approximately one-half Cavanaugh Ranch and one-half Jackson Ranch. Edward employed five carpenters (<u>Siskiyou Telegram</u>, July 26, 1890) to build his first store. According to the <u>Yreka</u> <u>Journal</u>, August 23, 1898, fire destroyed both the Store and Post Office. The <u>Siskiyou News</u>, January 28, 1899, states that Ed Cavanaugh rebuilt, bigger and better, in January, 1899. The <u>Yreka</u> <u>Journal</u>, March 14, 1899, says that "Ed Cavanaugh is fitting up and moving into his fine new store building at Edgwood this week on the site of the old store that burned down last Fall."

Troop trains passed through Edgewood during World War I, and the Railroad Depot was busy twenty-four hours a day. The Roaring Twenties followed the War, and Edgewood was the hub of nightlife even sporting slot machines. During World War II, a California State Militia unit was activated at Edgewood in 1943 and headquartered at the Cavanaugh Store building. Wartime activity ceased at the Store in 1947.

Today, Edgewood is a quiet little village boasting only the small Butteville School and the Edgewood Store. A half-mile south on Edgewood Road is the Edgewood Cemetery. Aside from the two remaining Victorian homes built by brothers Richard and Edward Cavanaugh, the Store is the lone commercial sentinel remaining in a once bustling pioneer town. The cattle industry still flourishes as it has since 1852 when Samuel Jackson (Jackson Ranch) registered the first brand in California. Large herds still spread out in fields adjacent to the Store.

SUMMARY STATEMENT OF SIGNIFICANCE

The Edgewood Store is eligible for listing in the National Register of Historic Places at the local level of significance under Criteria A because it is associated with events that have made a significant contribution to the history of the United States. The Store is historically significant because of its 19th Century development as a center of commerce for a pioneer community. The period of significance extends from 1899 -1953. Under Criteria A, the Store is significant as a commerical building/ institution.

Since its construction in the 1800's, the Store has been the single most important structure in commerce and community affairs in this community in Southern Shasta Valley. Its presence in an isolated landscape offered a sense of civility and stability for those considering moving to a remote area. It has served the community by furnishing the essentials of life food, drink, clothing, farm implements, etc. The Post Office was the link to the outside world.

Edgewood obligingly supplied the pioneer kitchen that is now housed in the Smithsonian Museum of History and Technology in Washington, D. C. The kitchen was part of a home built by pioneer George Washington Arbaugh on his ranch in the 1850's. The Jacksonville Museum, in Oregon, whisked away the Dogtown Saloon. The Edgewood Store is the only existing historical building remaining in this once robust pioneer community. Since 1879, it has served continuously as a store and the center of local and economic activity in this area. At times in its history, it served the community as a Post Office, meeting hall, and headquarters for the California State Militia. In its totality, the Edgewood Store retains a sufficiently high degree of integrity of location, setting, design, appearance, materials, workmanship, feeling and association to warrant listing in the National Register.
