Description: The Marshall Methodist Church, constructed in 1898, is a one-story, rectangular-shaped, detached, gabled roof religious structure with clapboard finish.

The facade (west side) has a wood paneled double door entryway in the bell tower. There are two double-hung sash windows to the south of the tower. The south side has four double-hung sash windows as does the north side. The rear (east side) has a hipped roof, three-sided bay with one double-hung sash window in each of the outer bays.

Decorative elements include several Gothic features including the pointed arch windows with simple traceries and decorative wooden hood moulds over all windows. The bell tower, located on the northwest corner, has a triangular arched transom above the entryway and a wooden hood mould over transom. The bell tower has a tent roof with square base. The roof has steeply-pitched slopes rising to a peak which is adorned with a finial. Although the belfry is no longer used, the original cast iron bell stands on a metal-framed structure immediately to the south of the church. The church was moved from its 1898 original site in 1902 when the whole town was moved near the Santa Fe depot. The building is in excellent condition, however, the exterior needs paint.

Statement of Significance: The Marshall Methodist Church is both historically and architecturally significant because: (1) it is the only original church building which remains intact in Marshall, and (2) it is the best example of Carpenter Gothic architecture in Marshall.

Constructed in 1898, nine years before Oklahoma statehood, the church was moved from its original location in 1902 when the whole town was moved three-fourths of a mile to be near the new Santa Fe Railroad depot. Its congregation was organized in 1895 and moved into the new building three years later. Angie Debo, noted Oklahoma historian, authored a book entitled <u>Prairie City</u> which describes her hometown of Marshall. Activities, including Sunday services, funerals, weddings, and prayer meetings, play a prominent role in her analysis of the history of churches in Marshall which includes the nominated property.

Elements of the Carpenter Gothic style are employed in the building. Gothic arch windows with simple traceries, clapboard wall finish, wooden hood moulds over windows, and the tent-roofed bell tower are among the Gothic principles used. Although the property needs paint, its architectural integrity remains intact. It continues to serve as the only remaining original church in Marshall, a role that it has assumed for more than 85 years.
