The Pelatiah Leete House is a landmark building in Guilford. It is important not only for its relatively early date and degree of preservation, but is significant as the homestead of one of Guilford's founding families. Pelatiah Leete built the house about 1710 on a tract of land which had been settled by his grandfather, Governor William Leete, at the time of the founding of the community about 1640. The Pelatiah Leete House is the oldest extant Leete family residence in Guilford, and is surrounded by numerous other Leete family houses of later construction. Pelatiah Leete fammed the property adjoining his residence until his death in 1768 at age 87.
