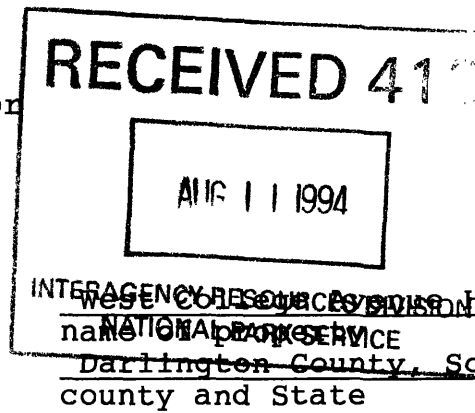

The West College Avenue Historic District is a collection of twenty-seven residences along West College Avenue in Hartsville, South Carolina. Twenty-two buildings contribute to the character of the historic district, while five buildings and two vacant lots do not contribute to the character of the district. The contributing properties represent a significant period of residential development in early twentieth-century Hartsville and were constructed from ca. 1906 to ca. 1930, with the majority constructed between ca. 1910 and ca. 1926. These properties generally conform to the description under the property type for "Residences" in the Historic Resources of Hartsville multiple property submission, and meet the registration requirements outlined under that property type.

The following properties contribute to the character of the West College Avenue Historic District:

- 1) 203 West College Avenue (ca. 1906): One-story gable roof frame residence with flat roof porch which wraps the east elevation to form a porte cochere and is supported by paired molded-wood posts set in brick piers; other features include single door with classical surround and sidelights and two interior chimneys.
- 2) 206 West College Avenue (ca. 1911): One-story gable-and-hip roof frame residence with hip roof porch which wraps around the east elevation and is supported by turned posts; other features include a gabled rear ell, gabled bays on the west and east elevations, an entablature over the facade entrance, and two interior chimneys.
- 3) L.B. Stephenson House, 207 West College Avenue (ca. 1907): One-story cross-gable roof frame residence with asymmetrical plan, with a hip roof porch which wraps around the east elevation and is supported by chamfered posts; other features include two interior chimneys. Built for L.B. Stephenson (1880-1956), who was secretary-treasurer of the A.M. McNair Company and who served as Mayor of Hartsville 1919-1920.¹
- 4) McAlpine House, 210 West College Avenue (ca. 1911): One-story gable-and-hip roof frame residence with hip roof porch which wraps around the east elevation and is supported by turned posts; other features include a gabled rear ell, gabled bay on the east elevation, and one interior chimney. Built ca. 1911 for Laurie McAlpine, who sold it ca. 1917 to his brother Thomas McAlpine (1893-1958), who came to

Hartsville in 1910, worked for the Peoples' Bank of Hartsville, and was treasurer of Hartsville Cotton Mill from 1916 to 1957.²

- 5) 211 West College Avenue (ca. 1909): Two-story hip roof frame residence with hip roof porch supported by Tuscan columns; other features include gabled ell on the west elevation, one interior and one exterior chimney.
- 6) 214 West College Avenue (ca. 1920): One-story hip roof frame residence with hip roof porch supported by turned posts with pierced brackets; other features include two interior chimneys. Built ca. 1920 for Coker Pedigreed Seed Company.
- 7) 300 West College Avenue (ca. 1914): One-story gable roof frame residence with flat roof porch which wraps around the east elevation and is supported by slim tapered columns; other features include two interior chimneys with decorative corbelled caps.
- 8) 306 West College Avenue (ca. 1914): One-story hip roof frame residence with flat roof porch which wraps around the east elevation and is supported by slender tapered columns; other features include alternating sawtooth shingles and elaborate sawn bargeboard in the front gable peak, two interior chimneys with decorative corbeled caps.
- 9) 309 West College Avenue (ca. 1919): One-story gable roof frame residence with engaged porch supported by battered wood posts on brick piers; other features include gabled rear ell and one interior chimney.
- 10) Carl M. McDonald House, 310 West College Avenue (ca. 1914): One-and-one-half story gable roof frame residence with gable roof porch which wraps around the west and east elevations and is supported by battered wood posts on brick piers; other features include central dormer with alternating shingles and decorative bargeboard, gabled peak with alternating shingles and decorative bargeboard, gabled rear ell and two interior chimneys. Carl M. McDonald (1881-1961), who moved to Hartsville in 1906, founded the McDonald Brothers Motor Company in 1913, which was the first automobile dealership in Hartsville, and also owned a wholesale grocery.³

- 11) 311 West College Avenue (ca. 1919): One-story hip roof frame residence with hip roof porch supported by battered wood posts on brick piers; other features include gabled peaks on roof slope at either side of facade entrance and two interior chimneys.
- 12) 312 West College Avenue (ca. 1917): Two-story hip-and-gable roof frame residence with aluminum siding, with hip roof porch which wraps around the east elevation and is supported by slender columns with simple balustrade; other features include gabled peak with alternating shingles over the porch entrance and two interior chimneys.
- 13) 316 West College Avenue (ca. 1916): One-and-one-half-story gable roof frame residence with asbestos siding, with gable roof porch over facade entrance supported by battered wood posts on brick piers; other features include two gabled dormers and two interior chimneys.
- 14) 318 West College Avenue (ca. 1916): One story cross-gable roof frame residence with aluminum siding, with one-story shed roof porch which wraps around the west and east elevations and is supported by Tuscan columns with balustrade; other features include gabled peak over the porch entrance and two interior chimneys.
- 15) 322 West College Avenue (ca. 1916): One-story hip roof frame residence with hip roof porch supported by turned posts; other features include two interior chimneys with decorative corbeled caps.
- 16) J.G. Wofford House, 324 West College Avenue (ca. 1916): One-story hip roof frame residence with hip roof porch supported by Tuscan columns with turned balustrade; other features include central gabled peak, gabled rear ell, and two interior chimneys with decorative corbeled caps. Built ca. 1916 for J.G. Wofford (1887-1945), who worked for the Hartsville Ice and Fuel Corporation, founded the Pee Dee Hatchery in 1927, and served as president of the South Carolina Poultry Association from 1932 to 1945.⁴
- 17) 403 West College Avenue (ca. 1910): One-story hip roof frame residence with engaged porch which wraps around the east elevation and is supported by square brick piers on wider brick bases; other features include large hip roof dormer with tripartite window and shed roof porch on the rear elevation.

- 18) J.D. Fox House, 404 West College Avenue (ca. 1930): One-story hip roof frame residence with engaged porch supported by battered wood posts on brick piers; other features include two interior chimneys. Built ca. 1930 for J.D. Fox, owner of Carolina Hardware.⁵
- 19) 405 West College Avenue (ca. 1926): One-story gable roof frame residence with hip roof porch supported by battered wood posts on brick piers; other features include two interior chimneys. Built ca. 1926 by Gabe Stokes (1863-1946), from lumber cut from his property in nearby Kellytown; one of twelve similar houses built by Stokes in Hartsville, and one of four which survive on West College Avenue and contribute to the character of the district.
- 20) 407 West College Avenue (ca. 1926): One-story clipped-gable roof frame residence with hip roof porch supported by battered wood posts on brick piers; other features include two interior chimneys. One of twelve similar houses built by Gabe Stokes in Hartsville, and one of four which survive on West College Avenue and contribute to the character of the district.
- 21) R.A. Terry House, 408 West College Avenue (ca. 1926): One-story clipped-gable roof frame residence with hip roof porch supported by battered wood posts on brick piers; other features include three interior chimneys. Built ca. 1926 by Gabe Stokes for R.A. Terry, treasurer of Sonoco Products Company; one of twelve similar houses built by Stokes in Hartsville, and one of four which survive on West College Avenue and contribute to the character of the district.⁶
- 22) 410 West College Avenue (ca. 1926): One-story gable roof frame residence with aluminum siding, with hip roof porch supported by battered wood posts on brick piers; other features include two interior chimneys. One of twelve similar houses built by Gabe Stokes in Hartsville, and one of four which survive on West College Avenue and contribute to the character of the district.

The West College Avenue Historic District is significant for its association with the residential development of Hartsville from ca. 1890 to ca. 1930 and as a reflection of the architectural styles and influences of that period. It specifically illustrates the residential growth of Hartsville from ca. 1906 to ca. 1926, a period of significant development which saw the town's population increase more than five times its size at the turn of the twentieth century.
