#### SUMMARY

The Captain Harold Jeffries House is located at 38537 5th Avenue in Zephyrhills, Florida. The two-story, vernacular house was constructed in 1911, and enlarged in the early 1920s and in 1940. The frame residence is constructed primarily of heart pine and rests on a brick pier foundation. Wood lattices fill the space between the piers. The exterior of the house is covered with drop siding. Gabled dormers are on both the west and east sides of the main gable roof, which is surfaced with tin. Most of the windows in the house are double hung sash. A non-contributing garage-apartment, constructed in 1950, is located at the rear of the property.

#### SETTING

The Jeffries house occupies three lots at the corner of Fifth Avenue and Ninth Street in downtown Zephyrhills, just three blocks east of U.S. 301. Fifth Avenue is a two-lane street, divided by a four-foot median planted with grass and holly trees. The house anchors the eastern edge of the downtown area. East of the Jeffries House are single family residences and two of the area's largest churches. Residences and the city police station are to the north. To the south are commercial buildings and residences.

The grounds around the Jeffries House on the east, west, and south have oak trees, a magnolia tree, dogwoods, a fifty-year-old sabal palm, and a large assortment of flowering bushes and ground covers. A prominent element of the garden is the original flagpole erected by Captain Jeffries. The ground on the north side of the house, covered in open-work brick pavers, is used for parking.

#### DESCRIPTION

A porch extends across the main (south) and east facades of the house (Photo 1). The porch roof is supported by simple Doric columns, joined by a simple railed balustrade. A small pediment, surfaced with wood shingles, breaks the roof line on the south facade, indicating the primary entrance to the house. The entrance door has a glass upper panel and is surmounted by a

transom (Photo 2). Flanking the door are 1/1, double hung sash windows.

The second floor of the south facade is fenestrated with a band of three, 1/1, double hung sash windows (Photo 3). The gable wall, above the windows, is surfaced with wood shingles. The wooden vergeboard is decorated with serpentine, scroll-cut, ornament.

The porch continues along the east elevation of the house (Photo 4). A multi-light entrance door is located on this elevation. Flanking the door are paired, 1/1, double hung, windows. Two large gabled dormers, each containing a pair of 1/1, double hung sash windows, are located on this elevation.

A single dormer, with a pair of 1/1, double hung, sash windows, is located on the west elevation (Photo 5). The end wall of the west elevation is fenestrated with three windows of varying size and style (Photo 6).

Extending across the rear (north) elevation is a one-story, 1950s addition consisting of a utility room, bath, and kitchen (Photo 7). The projecting kitchen area contains a door. Adjacent to the door are two pairs of casement windows. Another door is located on the north elevation of the one-story extension of the house to the west. A handicap ramp leads to this door (Photo 6).

The interior of the house features 10-foot high ceilings and pine wood floors. The main entrance leads directly into the parlor. A brick fireplace is located on the north wall of the parlor, facing the door (Photo 8). West of the entrance door is a staircase (Photo 9), handcrafted from heart pine, leading to second floor which contains two bedrooms and a bath. A door at the rear of the staircase provides access to the two bedrooms and bath on the west side of the house that were added in the 1920s. A storage area is located under the stairs. A double door leads from the parlor to the dining room. The dining room features a pass-through on the west wall that once led to the original kitchen (Photo 10).

#### **ALTERATIONS/ADDITIONS**

In the early 1920s, two dormers were added on the east roof slope and two rooms were added to the west side of the house. In the 1950s, the east porch was enclosed to create a Florida room and a kitchen, utility room and bath were added to the north (rear) side of the house. An entrance was added to allow access to the Florida room through the dining room. In 1992, the Florida room was removed and the porch was restored. A handicap ramp was also added, at the rear of the house, to meet city codes for use of the house as a commercial building.

#### NON-CONTRIBUTING BUILDING

A non-contributing, frame garage-apartment was constructed at the rear of the property in 1950 (Photo 11).

The Captain Harold B. Jeffries House in Zephyrhills meets National Register Criteria A, B, and C, in the areas of Exploration and Settlement, and Architecture. The Jeffries House is one of the oldest residences in the town of Zephyrhills, which was originally known as Abbott. It was the home of the founder of the community, Captain Harold B. Jeffries and his wife, Helen, from the time of its construction in 1911 until their deaths in the 1930s.

#### HISTORICAL CONTEXT

Between 1880 and 1885, the state of Florida experienced a population growth of 25%. Even though Hernando County, on the central Gulf coast, was fairly remote, it also experienced a gain in population and the founding of new settlements. In 1887, prompted by increasing growth in the area, the Florida Legislature carved two new counties out of portions of Hernando County. A northern portion of Hernando County became Citrus County; a southern portion became Pasco County. In the area that became Pasco County, several ports and farming villages were scattered along the Gulf Coast, including Hudson and Port Richey. The first railroad reached the area in 1886, making settlement easier and aiding in the economic expansion of the area. The local economy was primarily based on the production of citrus, watermelon, cattle, hogs, poultry, and eggs.

In 1888, Simon J. Temple purchased 280 acres from the Florida Railway and Navigation Company and two years later registered a plat for the town of Abbott, named in honor of Dr. J. M. Abbott, a physician who ran a drug store and practiced medicine in the area. Abbott was primarily a railroad station, and in February 1888, acquired a post office. A year later, Abbott had a population of 100. By the 1890s, the Consolidated Naval Stores Company of Jacksonville began buying and leasing land in and around Abbott for the purposes of gathering pine resin.

In 1900, brothers J. M. and J. W. Grier moved from Georgia to Brooksville, where they established a lumber mill. Their mill provided employment for many of the citizens of Abbott. Consolidated Naval Stores and the Grier brothers worked out an agreement that after resin was harvested from timber areas, the lands would be released to the Griers. By 1904, the Consolidated

Naval Store Company had ceased operations in the area, and, in a few short years the land surrounding Abbott was stripped of its virgin timber. Around 1906, the Griers worked with the Stebbins Realty Company of Tampa on a plan to sell thousands of acres of their property for development as citrus groves and home sites. In 1909, the Griers advertised their land in the National Tribune, a Washington, D.C. newspaper devoted to the interests of Union veterans of the Civil War. Shortly thereafter, they sold 35,000 acres in the area to Harold B. Jeffries.

#### HISTORIC SIGNIFICANCE

Captain Harold B. Jeffries was a journalist employed by the National Tribune. Born in Pennsylvania in 1843, Jeffries enlisted in the Union Army in April 1861. In December 1863, he married Helen McLeod of Carbondale, Pennsylvania. At that time he was a Lieutenant in Company E, 21st Pennsylvania Cavalry. the time he retired from military service, he had attained the rank of Captain. While working for the National Tribune he became interested in starting a colony for Union Civil War veterans. Several of his co-workers expressed interest in the project and it was supported by the newspaper, which printed articles about the idea. The National Tribune sent Captain Jeffries and Raymond Moore, a New York capitalist, to investigate several sites. The publicity generated by the National Tribune brought in donations of approximately \$200,000 from veterans who supported the project. Moore and Jeffries inspected land in several counties, including Alachua, Lee, De Soto, and Sumter. Initially, a site in Sumter County was chosen for the colony, but before negotiations were completed, it was decided to purchase land in Osceola County near St. Cloud instead. Jeffries was opposed to the St. Cloud selection and continued to search for land on his own, and Moore brought the Grier property in Pasco County to his attention. Jeffries wrote the Stebbins Realty Company and arranged to visit the area. By February 1909, he purchased 35,000 acres in the area of Abbott. Jeffries then organized the Zephyrhills Colony Company to advertise, sell, and lease the land to Union Army veterans so they could live on their small pensions and enjoy the warm Florida sunshine.

The name of the community was changed from Abbott to Zephyrhills. The plat of Zephyrhills generally followed that of the Abbott plat of 1888. Jeffries advertised the colony through

an advertising sheet called the <u>Zephyrhills Colonist</u>, which he sent out by the thousands. Five acre tracts were sold for \$75-100, with a city lot included at no additional cost. Payment plans were also available; land could be purchased for \$7.50 down and \$5 per month for 15 months.

The Zephyrhills Colony Company was formed by Jeffries to promote the town. The Company assisted those settling in town as well as those starting small farms. A custom began of making the new arrival feel at home as soon as possible. Every citizen exercised his duty of welcoming, introducing, and giving advice to every newcomer. The older residents of the community were eager for the success of the Zephyrhills Colony Company, for it provided jobs and an economic stimulus at a critical time when lumber and turpentine work was diminishing.

A 1910 account of the community's appearance was not very inviting. An abandoned turpentine distillery was near the train station. Opposite the station were a few houses for the railroad workers and a store. A school was nestled in the woods near the tracks. The only existing streets were Fifth Avenue and a few cross streets. Before long, however, the sounds of hammers and saws filled the air and the community began a period of spectacular growth. The population tripled between 1889 and 1911, from 100 to 300. During the next eight years a five-fold increase in population occurred, reaching 1,500 by 1918.

In 1910, a Grand Army of the Republic (GAR) Post was built in Zephyrhills. Soon after, the Zephyrhills Library Association was organized and the Zephyrhills Cornet Band was formed. The city's first newspaper, the Zephyrhills Colonist, was founded in 1911, taking its name from Captain Jeffries advertising sheet. The State Bank of Zephyrhills was established in February 1912, and the town incorporated in 1914.

By 1918 the town could boast of two hotels, a school, four churches, an electric light and power plant, telephone service, and a Board of Trade. During the land boom of the early 1920s, growth in Zephyrhills continued at a rapid pace. An ice plant was constructed and housing construction was active. Housing was scarce even though at one time it was reported that seventy houses were erected in seventy days. Winter residents moving to the area had nowhere to live, so many of the townspeople built additions onto their homes to accommodate visitors. During this

period, Jeffries added two rooms and a bath to the west side of his house.

Captain Jeffries had built his own home on one of the main streets of the community in 1911 and lived there until his death in 1936. During that time he was actively involved in the growth and development of Zephyrhills. He was aided in this endeavor by Raymond Moore, who also became his son-in-law. Jeffries was instrumental in the building of the GAR Post in 1910 and served as Judge Advocate General of the Post. He was deputy Commander of the GAR encampment and a member of the Board of Administration of the Grand Army Department of Florida. Jeffries was also a member and chaplain of Zephyr Lodge #198 F & AM, a member of the Oddfellows, and a member of the county and state Republican In 1920, he made an unsuccessful run for Congress. Mrs. Jeffries was also active in the community as a charter member of the Women's Relief Corps (auxiliary of the GAR post), president of GAR Circle #8, member of the Woman's Club, Vice-President of the Zephyrhills Library Association, and chaplain of the Crescent Chapter of the Eastern Star. Mrs. Jeffries often hosted meetings of the Woman's Club and the Library Association at her home. She died in 1931.

#### ARCHITECTURAL CONTEXT

Vernacular architecture embraces a diversity of folk and mass-produced building forms, designed and constructed by lay builders who drew upon traditional building techniques and contemporary stylistic preferences for their inspiration. Primary consideration was given to providing functional and comfortable spaces for the owners. Frequently vernacular buildings reflect a local adaptation to landscape, climate, and cultural patterns. Nineteenth century industrialism made it possible to standardize and mass produce building elements and disseminate them across the country. Decorative features were often applied liberally, exhibiting stylistic references without in and of themselves constituting a style of architecture.

#### ARCHITECTURAL SIGNIFICANCE

The Jeffries House is an excellent example of local vernacular architecture, and is one of the oldest remaining buildings in the Zephyrhills community. The wrap-around porch and the multiple windows for cross-ventilation are important adaptations for Florida's warm climate. It was constructed of locally available materials and incorporates only a few decorative elements, such as the decorated vergeboard and the use of shingled areas to add variety to the exterior wall treatment. The Jeffries House is a visual tie and reminder of the unique heritage of the community.




