The E.B. Bobb House is located in the city of Mitchell, Davison County. It is located in a residential neighborhood. The house was constructed from 1907-08 in the Colonial Revival style.

The two and one-half story house is clad with wood clapboards and has a quartzite foundation. The house consists of a rectangular gable roof main section with a two-story hipped roof section on the rear. The east elevation has a porte cochere.

The façade (north elevation) has full width one story porch. Seven smooth columns and two smooth pilasters support the shed roof of the porch. Six steps lead to the entry door with sidelights and transom at the northwest corner. To the west of the entry is a small rectangular stain glass window. To the east of the entry is a cottage window. The second floor has two one-over-one double hung windows. The third floor has a group of three one-over-one double hung windows. The gable peak has a square louvered vent.

The gable roof portion of the west elevation has three stained glass windows that follow an interior staircase. At the southern corner of the gable portion is a two story bay window. Each side of the bay window, on both the first and second floor, has a one-over-one double hung window. The bay is topped with a gable roof dormer. In the peak of the gable is a small one-over-one double hung window. The hipped roof portion of the west elevation has tripartite window on the first floor. The center is a cottage window with narrow windows flanking the main window. The second floor has a one-over-one window on the second floor.

The south elevation has a one story addition at the southeast corner. The addition has a one-overone double hung window and an entry door. To the west of the addition is a one-over-one double hung window. The second floor has three one-over-one double hung windows and a square stain glass window. At the southeast corner of the second floor is an entry door which leads to a balcony. The gable portion of the south elevation has two square louvered vents in the peak.

The east elevation has a porte cochere at the northeast corner. Under the porte cochere is a oneover-one double hung window on the first floor. The remainder of the first floor from north to south includes a cottage window, an entry door, and one-over-one double hung window. The second floor has a one-over-one double hung window to the north of the bay window. Each of the three sides of the bay window has a one-over-one double hung window. To the south of the bay window, is a smaller one-over-one double hung window. windows. The only non-historic alteration to this elevation is a one story enclosure to give access to the basement of the house. It is located adjacent to the historic entry door. This small addition has a door and small square fixed pane window.

Interior:

Interior decorative details include a grand staircase leading to the second floor, oak trim and pocket doors.

Garage:

The garage has a hipped roof and is sided with wood clapboards. The west elevation has two overhead garage doors. The north elevation has three four paned windows and an entry door at the northeast corner. Located in the center of this elevation is a gable dormer with no openings.

## **Statement of Significance**

The E.B. Bobb House is eligible for the National Register of Historic Places under Criterion C as it is an excellent example of the Colonial Revival style of architecture in South Dakota. It exhibits many distinctive characteristics of the Colonial Revival style. The E.B. Bobb House continues to provide a sense of architectural appeals that made it noteworthy in the early 1900's.

The E. B. Bobb House is located in Mitchell, a town of approximately 13,800 people in the James River Valley in southeastern South Dakota's Davison County. Mitchell was founded during the summer of 1879 when the Chicago, Milwaukee, and St. Paul, one of South Dakota's two most extensive rail systems, pushed a line westward from the South Dakota-Minnesota border to the Missouri River. The present site of Mitchell, just west of the James River, was acquired during the spring of 1879 by John D. Lawler, a real estate investor and the son of a Milwaukee Road stockholder who had advance notice of the Milwaukee Road's planned route. Lawler and the railroad company platted Mitchell in July of 1879 and began selling lots to the public in September. A regional U.S. land office was moved to Mitchell from Sioux Falls during September of 1880. The office served ten counties of eastern South Dakota and brought thousands of pioneers into the community to file land claims.

The Milwaukee Road was constructed through Mitchell in 1880 and reached Chamberlain on the Missouri River in 1881. Mitchell was named for the president of the railroad and, with this christening, began a long history as an important railroad community. In 1884 the Milwaukee Road opened a division headquarters and maintenance shop in Mitchell and became one of the city's largest employers. The Milwaukee complex evolved from a 14-stall roundhouse into an extensive collection of tracks and shops which spread along the southern side of the tracks. During the same period, the Milwaukee also built a major north-south branch line through Mitchell, which was dubbed the James River Branch. This line linked Mitchell with Aberdeen to the north in 1881 and with Scotland and Yankton to the south in 1886. The Milwaukee Road built westward from Chamberlain on the Missouri River in 1905, connecting Mitchell with West River towns such as Presho in 1905 and Murdo in 1906, and with the Black Hills in 1907.

The E. B. Bobb House is designed in the Colonial Revival Style. The Colonial Revival style is identified by an accentuated front door with a decorative pediment; a symmetrically designed façade with a central door, windows with double hung sashes. The Bobb House falls into a subtype of the Colonial Revival style as it has an off-center door, a treatment which was highly uncommon.

The Colonial Revival style was a common occurrence throughout the country for domestic architecture but its subtypes were not. The E. B. Bobb House exhibits classical elements of the Colonial Revival style as well as the rarer subtypes. It is eligible for the National Register of Historic Places under Criterion C for its architectural style.
