DESCRIPTION

The F.H.W. Briggmann House, which is believed to have been constructed ca. 1855, is a two-and-one-half story, rectangular, frame residence with a gable roof. The house has three exterior end chimneys of stuccoed brick; exterior sheathing is weatherboard; the foundation is brick pier with wooden lattice; and the roof is covered with corrugated metal. The dominant feature of the facade is a two-tiered porch which is recessed beneath the front slope of the roof. The porch is supported by wooden posts with necking and has plain balustrades. The porch shelters, on the first and second stories, central double-door entrances with sidelights and transoms. Windows are generally six-over-six. The house is basically intact. Alterations include a rear addition and the possible removal of a fourth chimney.

SUMMARY OF SIGNIFICANCE

The F.H.W. Briggmann House is significant as one of the few antebellum buildings remaining in the city. In addition, it is a reminder of Orangeburg's nineteenth century German emigrant population. The construction date of the house has not been documented, but tradition and available historical records indicate that it was constructed ca. 1855 for F.H.W. Briggmann (ca. 1824-1888).(1) Briggmann was a native of Hanover, Germany, who settled in Orangeburg between 1850 and 1854 and opened a business in the town.(2) He was the owner of F.H.W. Briggmann and Company, a prosperous general merchantile business.(3)

ACREAGE: Approximately .16 acres

VERBAL BOUNDARY DESCRIPTION: The boundary of the F.H.W. Briggmann House nomination is shown as the bold black line on the accompanying map entitled, "F.H.W. Briggman House". This map was copied from Orangeburg County Tax Map #21, drawn at a scale of 200 feet to the inch. The nominated property includes the historic building and the lot on which it is situated. The lot also includes a non-historic outbuilding.




