DESCRIPTION DATE 1905 ARCHITECTURAL STYLE early 20th century commercial 2-story rowhouse with 4 "duplex" units and one center unit; FORM rectangular plan, flat roof w/stepped parapet on sides MATERIALS brick segmental arches 1st, rectangular 2nd FENESTRATION corbelled brick beltcoursing; central full-height polygonal FEATURES bay; egg-and-dart molding on fascia of metal cornice; porches with partial cornice returns ALTERATIONS SITE corner lot in neighborhood commercial district

ARCHITECTURAL SIGNIFICANCE Washington Flats is a local example of urban rowhouse construction in Davenport. The form has a long history in the city, with several examples still extant from the mid-19th century. Washington Flats, one of the more recent examples included in this survey, displays a simplified neoclassical style common to many building types in turn of the century Davenport, the chief ornament being the fascia of the metal cornice. An interesting feature is the use of cut-out wood "screens" between adjacent entrances, which afford a modicum of privacy (or the feeling of same) to residents and visitors.
