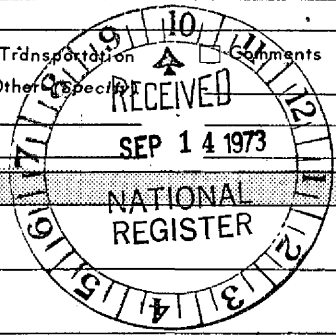

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Hubert Brown-Daniel Stout house on the Maple Grove Road is an example of pioneer craftsmanship. An unusual and attractive pioneer farmhouse, it was built by Daniel Stout and, according to a grandson who was still living in 1943, his son-in-law, JB, whose initials are carved in the keystone above the front door.

For the outside walls, Daniel used stone struck from the hills of his own farm, leaving the stones rough and laying them up meticulously in a random pattern. Of poplar, beautifully crafted are the wide doors, the mitred framework around the doors and windows, fireplace mantels and wainscoting. All the lumber for these, and other parts of the house, is believed to have been cut from trees grown on Daniel's quarter section of land to which he was given a land grant deed, signed by President James Monroe, in 1818.

Daniel Stout had a grist mill on his farm near Stout's Creek. He served under General William Henry Harrison in the Army and remained in his service afterwards when Harrison was appointed territorial governor of the Northwest Territory in 1800. It is believed Stout also helped build Grouseland, Harrison's home in Vincennes, Indiana which he occupied during his tenure as governor of the Territory, thus acquiring a liking for that style of architecture, and some knowledge of how to reproduce it in his own farmhouse on his farm.

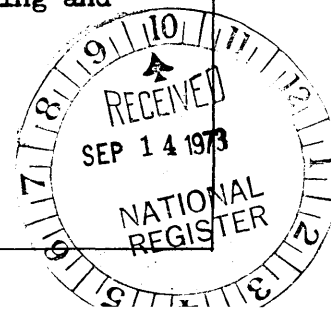
Originally there was a fireplace in each of the 4 rooms in this 2-story house. The two upstairs rooms were bedrooms, and reached by an outside stairway along the north wall. The two downstairs rooms were separated by a wall of random width poplar boards. The east room was the kitchen. Windows 22 inches deep were set on sills of wide stone slab.

The house went out of the Stout family in 1913. By 1943, when the Browns acquired the house, its outside stairway had been removed. Access to the upstairs bedrooms was by a crude ladderlike stairway and a hole cut into the ceiling of the downstairs west room. The fireplace in that room had been removed, the board wall between the rooms damaged beyond repair.

On restoring the house and adding a small wing to contain the essential kitchen, bathroom, hall and stairway, Hubert Brown used his own skill...an understanding of the nature and versatility of limestone...and carefully followed Daniel's original pattern of stone placement. Removal of the damaged wall made the downstairs into one large living-dining room with the large fireplace remaining, in the east end.

The house is comfortably equipped with modern convenience, livable, and does not have a museum look, but has retained its original feeling and character throughout.

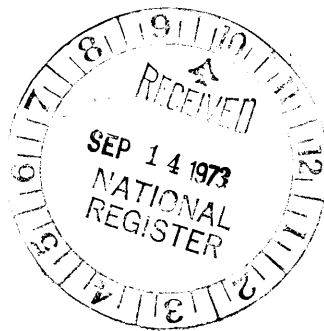

STATEMENT OF SIGNIFICANCE

The Stout-Brown house, built in 1828, is the oldest surviving house in Monroe County, a landmark along the Maple Grove Road, and significant in its portrayal of pioneer resourcefulness and good taste.

In describing this house, which is included in Wilbur Peat's Indiana Houses of the 19th Century, Mr. Peat says, "The small Federal town residences of the gable-roof type with three windows across the front and usually two stories high, tend to be, like their larger brothers, severely plain. Among the best examples from the standpoint of architectural design is the Stout-Brown country house, west of Bloomington, built of stone. The windows are capped with cut stone blocks in keeping with the treatment of windows during the English Renaissance and Georgian eras."

Restored and furnished in keeping with its period and style of architecture, the Stout-Brown house is a fine example of how pioneers used their own energy, craftsmanship, and the materials at hand, to accomplish what they wanted to do.

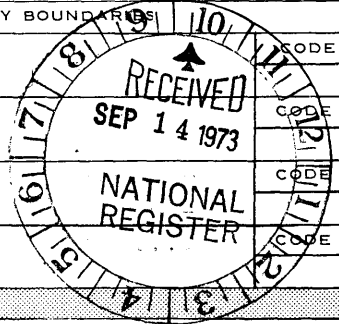

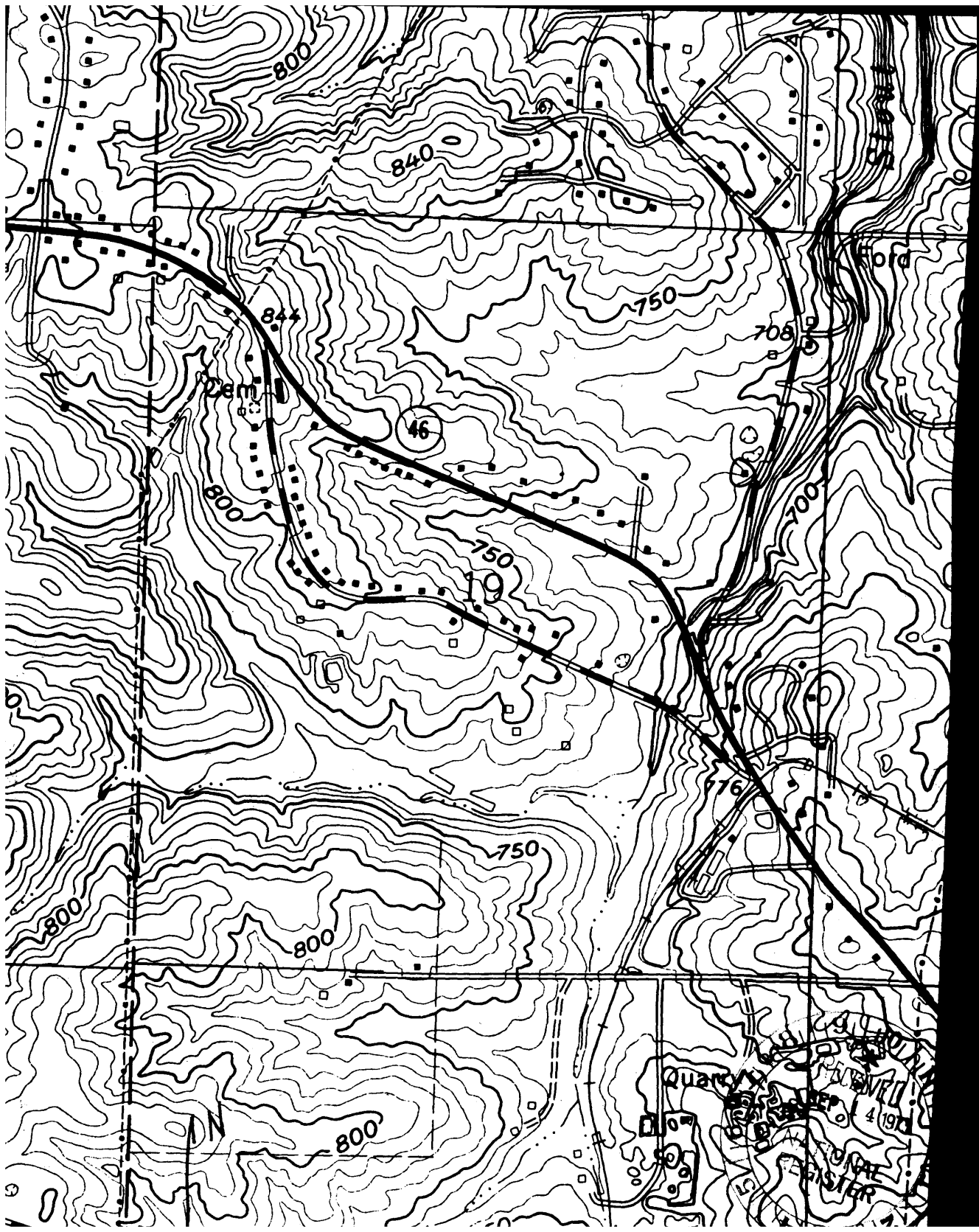
