Describe present and historic physical appearance.

The Beckley Jackson House is a one and a half story, Flemish bond brick, single cell, central passage plan residence. The house may have been built with an original rear frame ell but this ell appears to have been replaced ca. 1900 with the present ell. The house is sited on a slight rise facing Hwy 1069 which was known in the 19th century as the Jackson-Providence Road. To the south and west of the house are early to mid-20th century outbuildings which are not associated with period of significance for the property.

The house has a gable roof with exterior end brick chimneys and windows are modern six-over-six sash. Windows on the north and south facades are ca. 1900 four-over-four sash. In the half-story on the north facade are ca. 1900 four light casement windows. At the roofline of the original building is a triple row of corbelled brick with one row displaying cavetto molding. At the rear of the original brick section is a ca. 1900 one-story frame ell addition with six-over-six sash windows and an interior brick chimney. Later frame additions were also added to this section. On the main (east) facade is an added ca. 1920 gable roof enclosed porch with exposed rafters and sliding single light windows. The main entrance has a ca. 1940 multi-light glass and frame door. The interior of the house has been remodeled and no original detailing is extant. At the rear of the residence are four non-contributing frame outbuildings constructed in the early to mid-20th century.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Beckley Jackson House is significant for its association as an early stage coach stop and post office in ante-bellum Hopkins County. It is the only building from this period associated with early inns along historic road routes in the county. The house is also the only remaining ante-bellum brick building in the rural area of the county. However, because of alterations and additions to the original brick section it is not eligible under criterion C.

Beckley Jackson was born in 1788 and moved to Hopkins County in 1815. In the early minute books of the county Jackson is mentioned as a road surveyor and as an inspector of tobacco at Ashbyburg. Jackson became a prosperous farmer and in 1830 he built this brick residence on his farm. The house was originally one room deep and built in a central passage plan. It presumably had a rear brick or frame ell at the rear but this original ell was replaced ca. 1900. In addition to the construction of his house, Jackson also built a large log building across the road which served as an inn and stable for travelers on the Madisonville-Jackson Road.

For several decades the house was a well known stagecoach stop. Tradition states that most travelers stayed in the log building across the road except for more important guests who were invited to share Jackson's home. A post office for the area was also operated out of the Jackson House for many years. Jackson died in 1859 and it appears that his family closed the inn soon afterwards. The log building across the road stood until recent years when it became deteriorated and was razed. Around 1900 the preent rear ell was added and further remodelings have occurred to the property. The building remains the only property associated with ante-bellum inns and stage coach stops in the county.

Verbal Boundary Description: The location of the Beckley Jackson is illustrated on accompanying Hopkins County tax map # 75, lot 21 which is drawn at a scale of 1" = 400' and a sketch map of the property. The boundary is a rectangular parcel measuring approximately 50' by 100' with the house located at the western edge of the rectangle. The eastern boundary runs along the western edge of Hwy 1069 and the north and south boundaries run within ten feet of the house. The boundary at the southwest corner makes a slight jog to exclude a modern garage. The western boundary runs within ten feet from the rear of the house to exclude 20th century outbuildings.

Verbal Boundary Justification: The boundary for the Beckley Jackson House is drawn to include the house and adjacent lot that has historically been associated with the property. No outbuilding or other adjacent site feature is associated with the property's period of significance. HK-4. BECKLEY JACKSON HOUSE
