The Hilger Block Building is located in the downtown business district in Pierre, South Dakota. It is located at the northwest corner of the intersection of Dakota and South Pierre Streets. It is a two story brick building with a poured concrete foundation and a flat tar roof. The Hilger Block was constructed in 1883 in the Italianate Style.

The façade (east elevation) storefront has been altered from its historic configuration. The central recessed entry has been retained and is flanked by large windows with metal frames. Above the windows is a wood frame. The second story windows have been infilled with wood and smaller one-over-one windows. The windows have stone sills and segmented stone window hoods. Above the windows are corbelled bricks that lead to the cornice line. The cornice consists of brackets, dentils, and decorative moldings.

The south elevation has a display window at the southeast corner and a small garage door at the southwest corner on the first floor. The second floor has windows that have been infilled with wood and smaller one-over-one windows. The windows have stone sills and lintels. There is a flat plain parapet that runs the length of the elevation.

The west elevation shares a common wall with an adjoining building on the first floor. The second floor has a small covered entry that accesses the apartments upstairs.

The north elevation shares a common wall with an adjacent building.

The interior of the first floor is an open plan with commercial space occupying all except the very rear portion. The second story has been divided up into apartments.

The Hilger Block is located in downtown Pierre, South Dakota, in the main business district. It is located at the northwest corner of the intersection of Dakota Street and South Pierre Street. It is eligible under Criterion A in the area of commerce as it was the first brick commercial building constructed in Pierre and has housed several retail businesses throughout the development of Pierre. It is significant for the role it played in local commerce and economic development in the Pierre area for operating as a commercial business from 1883 to the present.

J.D. Hilger built the Hilger Block in 1883 and operated a clothing store in the building. He partnered with Anthony Hengel at a later date to form Hilger and Hengel Clothing Company which operated on the first floor of the building. The upstairs housed professional office and listed 12 teriants in the 1890 Pierre Directory. Herigel later became sole owner and named the business the Tony Clothing Company. The upstairs of the Hilger Block continued to house tenants including Doctors S.B. Stegeman, Chas M. Hollister, M.N. Farr, and Attorney Zell Guthrie in 1911. Over the years the upstairs offices would house mainly doctors, attorneys, and insurance agency representatives.

Settlement around the Pierre area took place in the late 1870s as prospectors were heading west during the gold rush in the Black Hills. The Yankton to Fort Pierre Stage terminated on the east side of the Missouri River at what was then called "east Pierre" before ferrying people and materials across the river to Fort Pierre. The city of Pierre was formed in 1880 when the Chicago and Northwestern Railway conducted a sale of land from the Original Plat of Pierre. The Territorial Legislature granted Pierre a charter in 1883 and city officers were elected. Pierre became the capital of South Dakota in 1890.

As the terminus for the railroad, Pierre grew quickly as people and supplies pushed west. The settlement of Pierre also coincided with the Great Dakota Boom of 1878-1887, an era of intense settlement in Dakota Territory that occurred during a period of good weather, proliferation of the

railroad, and the rush for precious metals in the Black Hills. With its railroad terminus status, Pierre developed as the economic and population center of south certral Dakota Territory. South Dakota was granted statehood in 1889 and Pierre was chosen as the capital the following year. The designation as the capital and the terminus of the railroad insured that Pierre would continue to grow into the largest town in central South Dakota.

The Hilger Block was the first commercial brick building built in Pierre. It was considered one of the most desirable business buildings in town because of its central location in the business district. It was also located in west Pierre, which was competing at the time for predominance with the businessmen of east Pierre. West Pierre eventually prevailed as the central business district making the Hilger Block one the most valued pieces of real-estate in town.

The construction of large commercial brick buildings in the downtown business district of community suggested a sense of economic vitality, security, and permanence. The Hilger Block did just this helping to solidify the business district in 1883. A year later, ten more brick business replaced wood structures on Pierre Street strengthening the town's economic prominence in the region.

The Italianate Style was popular in South Dakota from about 1870 to 1900. Characteristics of the Italianate Style found on the Hilger Block include long narrow window openings, elaborate window hoods, and a decorative cornice with brackets. Although the storefront and second floor windows have been altered, the retention of the stone sills, lintels, window hoods, and cornice allow the building to convey its historic sense of feeling and association that it achieved during the period of significance.

The Hilger Block is what Richard Longstreth labeled the two-part commercial block. Two-part commercial blocks generally have two to four stories separated by a distinct horizontal division into two zones.<sup>7</sup> The lower zone at the street level served as a public space, frequently as retail or commercial space; the upper zone generally housed more private space such as offices and meeting rooms.<sup>8</sup> The two-part commercial block was prevalent in small cities and towns nationwide from the 1850s through the 1950s.

Although the Hilger Block has been altered over the years, it still retains a high degree of integrity of location, setting, feeling, and association. It has been constantly occupied as retail space for over 120 years in Pierre and continues to represent the development and proliferation of commerce in the main business district. The Hilger Block is eligible under Criterion A for the role it played in the economic development of Pierre and for being the first brick commercial building in town. It location downtown in the commercial district has made it one of the most distinct businesses in Pierre.
