Section VII: Narrative Description

The Orange Avenue Historic District lies four blocks north of downtown Pascagoula, Mississippi and one block south of U.S. Highway 90. The historic district is bounded by Live Oak Avenue to the north; Orange Avenue to the south; Frederic Street to the west; and Magnolia Street to the east. The Orange Avenue Historic District features twenty-three, late-nineteenth to midtwentieth-century resources and two ranch houses built in the 1970s. Although some of the historic resources have undergone minor alterations, such as the addition of vinyl siding, the overall integrity of the Orange Avenue Historic District has not been diminished.

The Orange Avenue Historic District features twenty-three, latenineteenth to mid-twentieth-century resources and two ranch houses built in the 1970s. All are arranged on a grid pattern of streets defined by Orange and Live Oak Avenues and Frederic and Magnolia Streets. Nine historic houses (Resources #16 through 21 and 23 through 25) stand on Orange Avenue, five on the south side and four on the north. A ranch house (Resource 22NCR) also stands on the south side of Orange Avenue. Among the historic houses on Orange Avenue is the Thompson-Bugge House (Resource #25PL). Built circa 1890, the Thompson-Bugge House is a two story, wood frame Victorian that was individually listed in the National Register of Historic Places (NRHP) in 1991. The Frederic Street battery consists of eight historic houses (Resources #1 through 8). Most of these houses feature Victorian detailing, such as shinglework, decorative brackets, and turned posts. Four houses (Resources #9, 10, 12, and 13) and one bus depot (Resource #11) line either side of Live Oak Avenue. The Dr. Joseph Tabor House (Resource #13) has been recently converted to professional office space. It was individually listed in the NRHP. Similarly, a Victorian cottage (Resource #15) on Magnolia Street has been converted into a lodge in recent years. One other resource, a ranch house (Resource #14; NCR), is located on Magnolia Street. Sixteen of the resources are contributing; five are previously listed; and four are noncontributing.

Residences constitute an overwhelming percentage of the resources in the Orange Avenue Historic District. Of the twenty-three residences in the historic district, twelve (Resources # 1, 2, 5, 6, 7, 8, 9, 13, 15, 19 and 23, and 25) were built between 1880 and 1910. Most of these feature Victorian detailing, such as shinglework, decorative brackets, turned posts, and spindlework. The Thompson-Bugge House (Resource #25) is a full fledged

Victorian with its cross gable roof, asymmetrical floor plan, bay window, decorative brackets, and turned posts. Although built in the same period, Resource #21 draws its design from Neoclassical motifs. Eight houses are classified as bungalows (Resources #3, 4, 12, 16, 18, 20, 21, and 24). These houses feature such stock and trade bungalow characteristics as exposed rafters, tapered posts on piers, and commodious porches. Two dwellings (Resources #8 and 17) are defined as a massed plan cottage: a dwelling of several rooms in width and several rooms in depth typically crowned by a side gable roof. Another residence (Resource #10) hails from the minimal traditional vocabulary.

One resource (Resource #15) comes under the category of a lodge; however, the edifice was originally a residence. Built circa 1890, it features Victorian embellishment. One resource (Resource #11) has Art Moderne attributes, such as smooth streamlined surfaces, rounded corners, and large window openings.

Archaeological Component: Although no formal archaeological survey has been conducted in this district area, the potential for subsurface remains is minimal; however, buried portions may contain information that may be useful in interpreting the entire area.

Inventory

The following is both a description of the present and past status of the resources in the Orange Avenue Historic District. Each of the resources is assigned a number from 1 to 25. The resources are organized by street and number hierarchy. The buildings are divided into three classifications: those that contribute to the significance of the historic district, those that do not contribute to the significance, and those that are previously listed in the NRHP. Contributing resources are abbreviated (CR), non-contributing (NCR), and previously listed (PL). There are 16 contributing resources, 5 previously listed, and 4 non-contributing resource in the historic district.

Frederic Street

- 2. 3515 Frederic. ca. 1886. CR. One-story, wood frame galleried cottage with side gable roof of asphalt shingles, weatherboard siding, two interior wood and glass panel doors, flanking double hung sash windows, full-width porch/gallery with integral roof, wood posts, and closed rail balustrade.
- 3. 3517 Frederic. ca. 1940. CR. One-story, wood frame bungalow with hip roof of asphalt shingles, weatherboard siding, full-width porch with shed roof, and brick piers.
- 4. 3519 Frederic. ca. 1940. NCR. One-story, wood frame bungalow with hip roof of asphalt shingles, asbestos siding, off-center wood door, flanking 2/2 double hung sash windows, full-width porch with shed roof, and decorative iron porch supports.
- 5. 3603 Frederic. ca. 1906. PL One-and-a-half story wood frame, Victorian cottage with parallel gable roof, gable dormer, gables with shinglework, interior chimneys, weatherboard siding, off-center wood and glass door with transom, flanking double hung sash windows with shutters, partially enclosed wraparound porch, gazebo, turned posts, brackets, and spindlework balustrade.
- 6. 3607 Frederic. ca. 1884. CR. One-story, wood frame galleried cottage with side gable roof of asphalt shingles, weatherboard siding, two interior wood panel doors with transoms, flanking 6/6 double hung sash windows, full-width porch/gallery with integral roof, four rectangular columns, and brick piers.
- 7. 3611 Frederic. Marguerite Colle House. ca. 1895. PL. One-story wood frame, Victorian cottage with cross gable roof of asphalt shingles, gables with gingerbread trim, shinglework, weatherboard siding, two wood panel doors with transom, flanking 1/1 double hung sash windows, bay window, partial-width porch with shed roof, spindlework frieze, turned posts, and open rail balustrade.

The house was built as employee housing for the Colle Towing Company.

8. 3615 Frederic. ca. 1889. CR. One-story wood frame, massed plan cottage with side gable roof of asphalt shingles, asbestos siding, two interior wood panel doors with transoms, flanking 6/6 double hung sash windows, full-width porch with shed roof, and chamfered posts with brackets.

- 13. 520 Live Oak. Dr. Joseph A. Tabor home. ca. 1906. PL. One-and-a-half story wood frame, Dutch Colonial Revival with cross gambrel roof of asphalt shingles, gable dormer with horseshoe bracing and pediment, weatherboard siding, half story with double hung sash windows, first floor with off-center wood panel door with side lights, transom, flanking double hung sash windows, wraparound porch with classical colonnettes, and spindlework balustrade.

- 24. 517-519 Orange. ca. 1940. CR. One-story, wood frame duplex bungalow with front gable roof of asphalt shingles, vinyl siding, facade with two outer wood panel doors, two interior 6/6 double hung sash windows, full-width porch with engaged roof, wood posts, and carport.
- 25. 523 Orange. ca. 1890. Thompson-Bugge House. PL. Two-story, wood frame Victorian with cross gable roof of asphalt shingles, weatherboard siding, interior chimney, second floor facade with two 2/2 double hung sash windows, two story bay window, first floor facade with off-center wood panel door, flanking 2/2 double hung sash windows, partial-width porch with hip roof, brackets, turned posts, and open rail balustrade.

It was once the home of Captain S.H. Bugge, a prominent seafarer and river pilot from Germany.

Section VIII: Significance

Architecture

The Orange Avenue Historic District is eligible for listing in the NRHP based on Criterion C in the area of architecture. Represented in the district are locally significant examples of Victorian, Neoclassical Revival, Colonial Revival, and Art Moderne architecture. Possessive of a high degree of integrity, the historic resources reflect nation wide trends in architectural development that extend from the late nineteenth century to 1945, the period of significance Built between 1880 and 1906, a period of rapid growth for Pascagoula, nine residences (Resources #1, 2, 5, 6, 7, 8, 9, 15, and 25) feature such decorative Victorian details as shinglework, embellished brackets, spindlework, and turned posts. Built circa 1890, the Thompson-Bugge House (Resource #25) was individually listed in the National Register in 1991 as a locally significant example of the Victorian style. Resource #23 is the Orange Avenue Historic District's sole representative of the Neoclassical Revival style. It features a temple front with a pediment, raking denticulated cornice, and columns. Resource #11, a bus depot, is cast in the Art Moderne style. The bus station features a streamlined design, smooth surfaces, horizontal banding, and rounded corners.


