"Wars of America" is a monumental, bronze, group sculpture dedicated to the defense of the United States, created by John de la Mothe Gutzon Borglum (1867-1941), and located in the center of Military Park, City of Newark. Dedicated on Memorial Day, May 31st, 1926, the sculpture was commissioned according to the bequest of Newark businessman, Amos Hoagland Van Horn, who bequeathed \$100,000 for that purpose.

"Wars of America" is a heroic-sized, bronze grouping of fortytwo figures and two horses, all in motion. The action of the monument represents the American people summoned to the defense of their freedom. It shows the breaking of home ties, the hurried change of dress and the gathering of men into units moving forward into battle. The great leaders of the past join the group to transform it into an army. The group is placed on an incline, which emphasizes the struggle and shows the upward character of it. The pageant is headed by four figures, which represent the wars of 1776, 1861, 1898 and 1917. Behind this leadership appear the troops of all those years. Among these is a life-size representation of Amos H. Van Horn, the "Volunteer of 1861," who with his comrades, storms the heights "with heart that beats a charge." Other figures include a soldier bidding goodbye to his wife and child, the "top sergeant" arguing with the conscientious objector, a Red Cross nurse, the departing aviator in the likeness of John Purroy Mitchell saying farewell to his mother, and a father giving comfort and strength to his daughter whose husband has just joined the colors. For two of the models Borglum used himself and his son, Lincoln, and, likenesses of many of his friends can be found in other figures.

The monument was designed to occupy a central position in Military Park, the original military "Training Place" set aside by Robert Treat and the founders of Newark. Its setting is at the end of a long reflecting pool which produces the shape, as seen from the air, of a Tudor sword with the monument as its hilt. The entire plan of the monument is about 300 feet in length. The monument itself, which is set on a granite block

coping, is 42' long, 18' wide and 17' high (<u>Newark Evening News</u> 6/8/27; Wars of America Memorial Monument Dedication [program] 1926; Schaff 1984: 177-180, 222).

The casting was completed in Florence, Italy in 1925, and the monument was dedicated on May 31st, 1926. The monument was restored in 1990, and rededicated on May 31st, 1990. The reflecting pool has not been repaired and is dry.

Statement of Significance

"Wars of America" is significant under National Register Criteria C, because it is the work of Gutzon Borglum, a recognized master, and it possesses high artistic values. At the time of its construction, "Wars of America" was the largest bronze sculpture in the country. It is considered to be one of Gutzon Borglum's masterpieces, and his most eloquent work in bronze.

"Wars of America" was given to the City of Newark by the bequest of Newark businessman, Amos Hoagland Van Horn. Van Horn died on December 26, 1908, leaving \$100,000 for a memorial to the soldiers and sailors who fought in the Civil War. The site of Military Park was specified in his will. All else, including the design and the selection of the sculptor, was left to the discretion of his executors, Ralph Lum, John Martenis and George Wire (Van Horn Trust 1912: 12-13). The executors, and the previously selected "Seated Lincoln" Monument Committee, unanimously appointed Gutzon Borglum as the sculptor. They had been so pleased with his "Seated Lincoln" that they awarded him the commission, giving him complete artistic freedom, limited only by the amount of Van Horn's bequest.

The monument was dedicated on Memorial Day, 1926, with the Hon. John R. Hardin presiding. The monument was unveiled by Alice Mae Waer, great niece of Amos H. Van Horn. After the unveiling, Gutzon Borglum presented the monument to Ralph Lum, a trustee of the Van Horn estate. Lum, in turn presented the monument to Mayor Thomas Raymond. Addresses were made by Brigadier General Hugh A. Drum, representing the Secretary of War, the Hon. Curtis D. Wilbur, Secretary of the Navy, and the Governor of New Jersey, Hon. A. Harry Moore (Wars of America Memorial Monument Dedication [program] 1926).

Amos H. Van Horn

Amos Hoagland Van Horn was born in Warren County, New Jersey, on November 26, 1840. Educated in the Danville public schools, Van Horn received his earliest training in his father's general store. In 1860, Van Horn borrowed five dollars from his brother Edward, and opened a small furniture repair shop in Newark. When the Civil War broke out, Van Horn volunteered in Company A of the Twenty-Sixth Regiment, selling his business for \$25. During the war, his brigade took part in many battles and was commended for gallantry. He was mustered out of service on June 27, 1863.

Upon returning to Newark, Van Horn started his furniture business again and gradually prospered until his business required the erection of several buildings on Market Street. By the end of the century, Van Horn had expanded into the storage and warehouse business, as well as carpet cleaning. In July, 1906, his concern was succeeded by Cowperthwait and Van Horn, although Van Horn remained on the board of directors until his death. During his many years as a Newark leading businessman, Van Horn contributed generously to many civic and charitable causes and was an active member of Lincoln Post No. 11, Grand Army of the Republic (Van Horn Trust 1912: 5-11).
