Statement of Significance:

Criterion B - Commerce

The South Greenville Historic District is significant for its association with several 19th and 20th century merchants who lived within the district area.

\James Hilliard Dunklin\(\psi\)(#19) who operated a banking establishment, cotton warehouses and a mercantile business in Greenville during the mid-19th century and was elected president of the Alabama Board of Commerce.

W. J. Beeland (#27), R. A. Beeland (#19) and L. J. Beeland (#84) who owned and operated the largest mercantile store in Greenville, the Beeland Brothers Mercantile Company, during the late 19th and early 20th century.

Other important merchants who are associated with houses in the district include, R. A. Lee (#81), Jefferson Beeland (#81), Charles Neuman (#19) and J. R. Abrams (#18).

Criterion B - Government and Politics

The South Greenville Historic District is significant for its association with several government and political leaders of Greenville and Butler County.

James Hilliard Dunklin (#19) who served in the Alabama State Senate in 1876.

Dempsey Monroe Powell (#53) a noted Greenville attorney and was elected to two terms in the Alabama State Senate from Butler County in 1900 and 1903.

John Lee Long (#125A) who served in Greenville as a city councilman, treasurer and member of the school board. He also served as chairman of the Butler County Democratic Executive Committee, was a member of the State executive committee and chairman of the Congressional executive committee. He also was a delegate to the constitutional convention of 1901 and chairman of the State Tax Commission from 1911-1913.

Criterion B - Transportation

The South Greenville Historic District is significant for its association with two members of the community who were instrumental in the development of the railroad through Greenville: John Hilliard Dunklin (#19) who was a charter member of the Mobile and Montgomery Railroad when it was founded in the early 1850's and John T. Milner (#83) who was elected chief surveyor and engineer of the company in 1858 and in that capacity until his retirement from the railroad in 1872.

Criterion C - Architecture

The South Greenville District represents Greenville's largest 19th and early 20th century moderate income residential area (c 1850-1936). Architectural styles exhibited in the district are good examples of Greek Revival, Queen Anne, Arts and Crafts, French Creole, Colonial Revival and Bungalow-type cottages. Also included is a fine Gothic Revival Episcopal Church (1896) and an eclectic Victorian Methodist Church (c 1880).

Description:

The South Greenville District comprises Greenville's largest collection of 19th and early 20th century residential architecture. The district is characterized by largely middle class housing exhibiting Queen Anne, Greek Revival, Bungalow, Gothic Revival, Arts and Crafts, French Creole, and Colonial Revival architectural styles. Also included are numerous vernacular cottages and two turn of the century churches, one of which is late eclectic Victorian and the other is Gothic Revival. The houses, for the most part, are relatively modest and placed close to the narrow streets on lots of one-fourth of an acre or less. Scattered throughout the district are a few larger Queen Anne style homes situated on slightly larger corner lots.

Historical Summary:

The South Greenville Historic Residential District developed southward away from the main commercial area of Greenville, which was located around the courthouse around 1850. The earliest survey plat map of Greenville which dates from August 1854, indicates that the lots that faced Walnut Street were the southern limits of development at that time. Located at the extreme southwest boundary of the town was located the community burial ground. The first community church in Greevnille is believed to have been located at the western edge of the plot and was later removed to make room in the cemetery which expanded to cover the area between Walnut street and what is now Danklin Street. The cemetery now called Pioneer Cemetery (#139) contains the remains of many of Greenville Pioneers and includes the grave of Captain Samuel Butler for whom Butler County is named. Butler's body was exhumed from its original burial site in the county and was reinterred in the cemetery with great ceremony in 1858.

During the late 1850's the residential area within the district boundaries was located primarily around Herbert Street with some development on Caldwell, Church, and Hickory Streets. The houses were situated in many cases on large lots as there had been little or no street development south of Walnut Street. During the 1850's development in this section was aided by the introduction of rail service into the

town. This introduction created a boom period in commercial development as well as residential building. The houses constructed during this period were primarily for merchants and tradesmen such as James Hilliard Dunklin (#19) who operated a drugstore in the rapidly developing commercial area around the railroad depot: the Abrams House (#18) which was built for Reverend Jonathan Bell but was purchased shortly afterwards by local merchant J. R. Abrams and the Lobman-Herbert House (#17) which was built by Henry Lobman, a German emigrant who operated a furniture factory in Greenville. Also constructed during this period was the Milner-Spier House (#83) which was built for John T. Milner who served as chief surveyor and engineer for the Mobile and Montgomery Railroad and who also was involved in the timber industry in Butler County.

Following the Civil War development in the area occurred at a relatively slower pace caused primarily by the depressed economic condition of the area. The best examples of development during this period include the Lee-Beeland House (#81) on Dunklin Street and the Hammond-Cumbie House on South Park Street (#42).

During the late 19th and the beginning of the 20th century the development continued in its southward movement. A continuation of the earlier trends were seen as a large number of houses were built for professionals, primarily merchants, as well as some for doctors and lawyers. Most were of relatively modest scale and detail and reflected the Victorian Cottage from which was in vogue during the peirod as may be seen in inventory (#1) and (#12).

The houses within the district which date from this period of development closely conform to John Buckner Littles description of Greenville housing of the late 1880's:

"The private residences are mostly neat, comfortable and substantial structures of the cottage order of architecture and are especially adapted to this locality and climate. But few are of the palatial order. All, however, impress the deserver with the fact that they are constructed in accordance with the most improved patterns of workmanship and are built for beauty of design and far great convenience to those who occupy them."

This development of moderate sized housing continued into the first decade of the 20th century with the best example of this development being located along South Park Street where such Greenville merchants as A. W. Metcalf (#88) and Henry Seale (#40 & #55) as well as Dr. J. L. Bryan (#57) constructed houses along the street. Other examples in the district of early 20th century development on a larger scale is the Beeland-Mallett House (#84) on the corner of Hickory and Danklin Street which was built for local merchant L. J. Beeland in 1901 and Inventory (#118) located at 252 South Conecuh Street.

Two major Greenville Churches were built within the district area during the 1880's and 1890's. The First Methodist Church (#34) was constructed during the early 1880's. The roof was destroyed during a 1901 fire and was replaced and the present two tower configuration added during the repair and renovation of the building in 1902. In 1896 the St. Thomas Episcopal Church (#23) was constructed on the site of the frame Episcopal Church building which was located beside the rectory (#24) which was erected during the 1880's. Construction of the church was overseen by Rector G. R. Upton who supervised both the laying of brick as well as the selection of timber for use in the building.

The development of the district was largely complete by 1910. There were, however, a number of bungalow type houses added to the districts after that time. The most noteable of these is the Kate Judge House (#22) located on Herbert Street beside the St. Thomas Episcopal Church. According to an article in the Greenville Advocate of July 21, 1909, this house was built by contractor B. F. Jones and was the first of its type ever constructed in Greenville. Other notable bungalows include inventory #75 located at 3335 Pine Street and inventory #123 located at 269 South Conecuh Street.
