



7. Narrative Description:

The Weston townsite and associated bluffline (CN-4) are located at the mouth of Camp Creek on the Ohio River (River Mile 864.5 from Pittsburg), in Crittenden County, Kentucky. The broad creek bottom meanders into the Ohio between two sets of flanking high bluffs, the easternmost of which is set immediately along the Ohio River bank, with the most adjacent high ground rising some 60 feet above the river.

The town of Weston was situated on a shelf of land which lay to the east and north of the creek. The townsite fronted on the Ohio River. The town was a thriving village as of 1860 but today it is an unincorporated fishing and river access settlement, with about 8-10 houses. These houses are clustered close to the river. At least one house is a large Victorian-era home. The townsite has no businesses, but there is a gravel boat ramp. The village is not the focus of this nomination but the surviving homes do mark the location of the larger mid-19th Century townsite.

While Weston was the scene of one minor Civil War event, the focus of this nomination is the bluffline or hill which stands immediately upriver from the townsite. The elevation is well defined on all sides. It consists of a shaley rock which is fractured and difficult to climb. The river front is steep and the bluff includes a number of steep rock chimneys and sheer walls. On top of the bluff is a cemetery and a new road is being completed to the cemetery by the ALCOA Company. The bluff descends precipitously to the east, beginning just beyond the cemetery. It similarly drops in elevation to the south and towards the Weston site to the west. The river level is 324 feet and the bluffline rises 500 feet, or 175 feet above the water level. The Civil War water level would have been considerably lower in an era before the navigation dams.

The river front includes at least one lower shelf and a trail runs along this level. Otherwise the bluff top dominates the river and is well within musket range of the river. What is particularly striking is the great vista which the viewer can enjoy from the cemetery area. This vantage point views up the bend of the river toward Caseyville and west towards Cave-in-Rock and points beyond. The view is for miles either way so the bluff is an excellent observation point.

The cemetery which is located on top of the bluff is not counted as a contributing resource.



8. Significance Statement:

Located just upstream from the townsite of Weston, Kentucky (CN-4), this bluffline along the Ohio River is nominated as part of a Multiple Property Listing entitled "Caught In The Middle, The Civil War Years on the Lower Ohio River," within the contexts of "Federal and Confederate Military Operations On and Along the Lower Ohio River; the War on the River, 1861-65," and "Federal and Confederate Military Operations On and Along the Lower Ohio River; the War on the Land, 1861-65." The property is locally significant as an example of the property type "Scene of Military Conflict." The property meets Criterion A, with respect to that property type because this property was the scene of a large-scale military skirmish on June 21, 1864, the largest military action in Crittenden County during the Civil War.

The property meets those registration requirements set forth in the associated historic context through its retention of the physical integrity of the location and setting of the associated scene of conflict. The bluffline was directly associated with the documented conflict and the cumulative integrity aspects of feeling and association are clearly retained.

This skirmish was significant militarily because it presaged the shift of active Confederate military attentions to the Crittenden-Union County sector of the river beginning in mid-June 1864. While one of a number of larger military encounters, this attack on river shipping was an early indication that Confederate offensive attention would be focused against that river traffic.

The following detailed account is offered as the best description (although one from the Federal perspective) of the skirmish, taken from the *Evansville Daily Journal* of June 23, 1864 (original mis-spellings are retained):

"Guerrillas on the Ohio--The Steamer Mercury Fired on--The Gyrills Catch a Tarter...

At two o'clock this afternoon [June 21], when five miles below Ford's Ferry, we were hailed by the officers of the Nightengale who informed us that they were fired on be guerrillas at Ford's Ferry. The 7th Ohio Volunteer Infantry being on board were ordered by their commanding officer, col. Saml. McClelland, to prepare for action.

On reaching the Ferry all was quiet. When we reached Preston [Weston], a short distance above, the ladies of the village waved salutes. On the northern extremity of the town is a bluff which our boat neared, as the channell at this point is close to the Kentucky shore. Suddenly the sharp crack of rifles and the whiz of bullets bore testimony that Kentucky neutrality had culminated in rebellion. Rocks, trees, houses, barns and sheds formed shelters for our Kentucky foemen. A well directed volley was poured into the lurking places and the rebels, when several were seen hastilly retreating. Some took shelter behind a house. A volley was fired at the house and it was literally riddled. The rebels were now retreating in every direction carrying their wounded with them.

Hearing that two of the soldiers below were wounded, I hastened down to administer to their comfort. Desultory firing commenced ere I reached there, and finding some men behind temporary breastworks formed of piles of shingles, I asked one of them for the privilege of a shot at the rebels. He handed me the gun, and soon after pointed out a guerrilla whose horse had become restive. The rebel had dismounted and was endeavoring to curb his horse and conceal his person behind a tree, both of which he could not accomplish. I stooped down took deliberate aim—the distance was short—I pulled the trigger steadily and fired. The horse went off riderless. I received the congratulations of several of the soldiers for the act. If the man was wounded or killed it could not be éasily known who performed the deed, as the firing from the boat was continuous.

The Colonel desired to go on shore and burn the town, but the Captain of the boat had positive orders not to land on the Kentucky shore.

...Will not the Government interfere and by swift and justifiable retribution terminate this attempted blockading[?]"

The Bell Coal Mines diarist, just upstream from the scene recorded what was most likely this same event, but credited it to June 22, noted "Guerillas shooting into boats at Weston."

Weston was the scene of another wartime event on September 14, 1864. Fourteen Confederate prisoners overpowered their Federal guards on board the steamer Colossus. The boat was heading up the Ohio River from Smithland when the prisoners revolted, killed two and wounded two of the six-man guard, forced the boat ashore at Weston and escaped inland with the arms of their former guards.

10. Geographical Data

Verbal Boundary Description

A legal description has yet to be obtained. For now, the boundary begins along a tree line which marks the ALCOA boundary rises east up the bluff to the 450 foot elevation contour line and encircles the slightly higher blufftop and cemetery in a counter-clockwise fashion, following the eastern slope of the rise. The boundary then descends to the river bank and follows that shoreline downstream to the Weston Light and from that point follows the tree line to the place of beginning. This includes about 10 acres.

Verbal Boundary Justification:

This nomination includes only the prominent bluff which featured in the associated military conflict. This bluff is well defined by its physical separation from any nearby bluffline or elevated point.
