

#### **Narrative Description**

The First Scandinavian Baptist Church is located on a country road 2.5 miles south of Trent, South Dakota in Blinsmon Township. The Big Sioux River flows 100 yards west of the church. It is located in a very rural area with very few houses in the immediate area. The First Scandinavian Baptist Church is an excellent example of a rural country church.

#### Architectural Description:

The First Scandinavian Baptist Church, built in 1888, is a gable front clapboard building with a steeple on the west end of the façade. The one and one-half story frame building was constructed on a concrete foundation. The façade of the church has two entry doors in the steeple with a simple wood arched hood above the doors. Concrete steps lead up to this entryway. Slightly off center of the façade is a two-over-two double hung window with the same simple wood arched hood. At the east corner is an entry door. At the gable peak is decorative bargeboard. The peak of the steeple has a decorative finial.

The east elevation has three evenly spaced two paned windows at the basement level. The sanctuary level has five evenly spaced, eight-over-eight, double hung windows. The north elevation has a shed roof addition that was made in 1952 to provide access to the basement. The entrance to this addition is on the east elevation. A new concrete block chimney was added to the north elevation in 1952 as well. The gable peak has a simple decorative bargeboard detail.

The west elevation has three evenly spaced windows at the basement level. The sanctuary level has four evenly spaced eight-over-eight double hung windows. In the steeple portion is an eight-over-eight double hung window.

#### Interior:

The dark wood flooring and wainscoting highlights the interior of the church. Wood railings and steps separate the platform from the main floor of the sanctuary. The church has a simple vaulted ceiling. The church's full basement has a Sunday School room and a modest kitchen at the rear of the building.

Privy:

To the rear of the property sits a clapboard sided asphalt shingled gable roof privy. At the center of the side gable are two vertical board doors. The privy is divided into two individual stalls.

# **Narrative Statement of Significance**

The First Scandinavian Baptist Church is significant under criterion C for its association with the as a well-preserved example of simplified vernacular gothic architectural style and represents the first generation church construction in the eastern portion of the state.

Although Danes are scattered over South Dakota, to the extent that almost every county in the state may count several of them among its inhabitants, there are only two areas in the state with a large Danish population. Most of the state's Danish population is located in the southeastern portion of the state, including Moody County. Due to the rich bottomlands in this region, it was the scene of the earliest Danish settlement in the Dakota Territory in the early 1870's. The first Danes came to Moody County, South Dakota, from the Aalborg/Jutland area of Denmark in 1872.

The Danes settled in the Sioux River Valley in Blinsom Township, located between the towns of Dell Rapids and Trent. One of the first Danes to settle in the area was Nels J. Norgaard who emigrated from Denmark in 1872. He established his homestead and after he completed his home, other Danish families began to arrive. As there was no place to practice their Baptist faith, they gathered in homes and dugouts until the church was constructed in 1888.

The First Scandinavian Baptist Church is also significant under Criterion C as is typifies the "first generation" of church construction in eastern South Dakota. Scholars of church architecture in the Great Plains have divided the evolution of church buildings in the region into several distinct phases. These phases tend to happen in generational cycles and so they have been termed generations. Typically a parish or congregation would be established in a given area as soon as there was sufficient population. As its first order of business, a newly organized church body constructed a

suitable church building. As a result, most of the initial or first generation churches were simple frame buildings constructed by local carpenters or builders. In eastern South Dakota, first generation churches tend to date from the late 19<sup>th</sup> century with most buildings constructed during the Great Dakota Boom, 1878-1887. The planning process for The First Scandinavian Baptist Church started during the Great Dakota Boom and construction was finished in 1888.

The church retains a high degree of architectural integrity and has suffered few alterations. The north elevation has a shed roof addition that was made in 1952 to provide access to the basement. A new concrete block chimney was added to the north elevation at the same time. The privy is still at its original location. Few examples of this building type with a high degree of integrity remain in South Dakota. Many have suffered alterations such as modern siding, new windows and removal of the steeple. The First Scandinavian Baptist Church survives as an excellent example of this vernacular building type.

The First Scandinavian Baptist Church is eligible for the National Register of Historic Places under Criterion C as an excellent example of a first generation, vernacular gothic building.

#### **Verbal Boundary Description**
