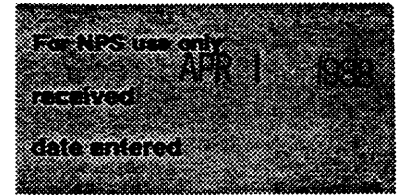

1. Name: Menard-Galaz House, survey number 38
2. Location: west side of the San Lorenzo alternate route of Highway 90, approximately 6/10 of a mile south of San Lorenzo.
4. Owner: Robert Galaz, Route 15, Box 2375, San Lorenzo, N.M. 88057
7. Description: Photo 44; single file plan with rear shed roofed addition; level stone foundation; stuccoed adobe; corrugated metal hipped roof; 2/2 double hung windows; single door.
8. Significance: The homestead patent on this property was awarded to John A. Menard in 1895. Construction of the house likely preceded that date and the house therefor meets Criterion A as a representative of the early settlement of Grant County. It is located on an area south of the mouth of Noonday Canyon known as San Lorenzo Flats. The land below the house is irrigated and eminently suitable for farming. In 1908 the property passed to Manuel Galaz and has stayed in the Galaz family since. The house is a classic example of the New Mexico Vernacular tradition based on the Hispanic tradition but incorporating Anglo-American elements and also meets Criterion C. The linear plan and use of adobe are traditional, the facade symmetry, leveled foundation and corrugated roofing represent later developments.

Verbal boundary: A rectangle, roughly 60' by 50', formed by lines parallel to and ten feet from the exterior walls of the building. Since this is an unplatted area, this boundary has been created to include only this house.
