Re: Howe-Waffle House and Carriage House. NR # 77000320

The National Register currently has the "Current Function" for this property as "Vacant/Not in Use." We request that this be changed to "Operating House Museum and Historical Society Offices" (or something similar showing that the House is open and used).

The Dr. Willella Howe-Waffle House and Carriage House was restored over a period of about 10 years from 1974 to 1984 by the Santa Ana Historical Preservation Society. About 1984, the Society began to offer regular open houses of the property to the public and continues to operate the property as a House Museum to this day. The House has been furnished with period furniture and typical medical instruments and ephemera of the time that Dr. Willella Howe-Waffle was practicing (1890 to about the 1920s). The Society also uses a room in the House as our main office and headquarters. The Society is an all-volunteer, 501c3 organization.
