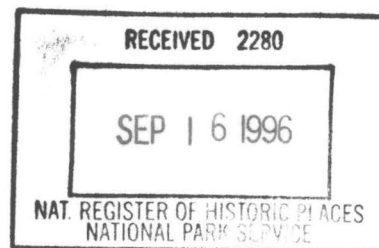

Description

The Faust House (at 114 Richmond Hill) is a single-story, wood frame and brick masonry residence designed in the Spanish Revival style. Its western or front elevation is dominated by a full-front porch composed of a ceramic tile shed roof over three broad arched openings divided by brick columns and spandrels, forming an arcade, with two more single arches at the northern and southern ends. A single-leaf front door and two pair of casement windows punctuate the brick wall behind, which is itself capped with a stepped parapet and coping. A single brick chimney is placed against the wall just east of the porch on the northern elevation. The house is fenestrated with an assortment of one-over-one sash and casement windows throughout, and a non-historic metal carport has been added to the rear. A continuous brick foundation supports the brick walls and flat asphalt roof.

Significance

Criterion C, local significance

The Faust House (at 114 Richmond Hill) is locally significant under Criterion C by virtue of its status as the best example of a Spanish Revival style residence in West Helena. Constructed just east of the ninety-degree turn at the eastern end of Plaza Avenue in one of the residential areas of the city developed slightly later than those sections immediately to the west, it is associated with the historic context *Historic Resources of West Helena, Arkansas, 1900-1945* as one of the few surviving historic homes with any degree of integrity, and as the best known extant example of this style.

ABSTRACT/SUMMARY COMMENTS:

The Faust House at 114 Richmond Hill is significant under National Register criterion C (Architecture), as an excellent local example of early twentieth century residential construction. Completed in 1924, the one-story brick home is a handsome well-preserved example of Spanish Period Revival-style design that recalls the prosperity of West Helena's boom period (1910-1930).
