Summary Description:

The Erickson Lakeside Cabin is a 516 square-foot American Chestnut log cabin which stands on the west side of Lakeside Drive facing east, in Lake Wallkill, Sussex County, New Jersey. The building is a 1- story domestic dwelling with a cathedral ceiling, built in 1934. The John R. Sheckler and S. Clayton Shepperd (real estate developers) cabin was designed by Herb Smith, the architect for the development corporation, and is constructed of logs harvested locally from the free-standing dead trees that resulted from the American Chestnut (*Castanea Dentata*) blight in North America in the early 1920s. The demise of the American Chestnuts was the result of a disease brought to this county through the import of a Japanese variety at the turn of the century. The Japanese variety carried a disease called *cryphonectria parasitica*, for which these trees had no immunity and became severely susceptible. The disease spread rapidly, particularly in the northeast of North America and eradicated the northeastern population by the early 1920's.¹

Description

The Erickson Lakeside Cabin is an original hand-hewn, American Chestnut log cabin (photo #1a). Each log was harvested from dead-standing timber on Lake Wallkill land. The cabin is sited on a small (approximately 80 ft. deep x 40 ft. wide) partially wooded lot with a rising grade towards the rear (photo #1), that affords it a view of the lake. The north/south gable roof is covered with hickory-colored asphalt shingles. The exposed logs (photos #10, 11, 12), with concrete chinking, rest on a fieldstone foundation (photos # 08, 09) which was constructed from a variety of locally-harvested stones. The exterior of the logs is painted with a weatherproofing dark wood stain, and all concrete chinking is painted white.

The main level consists of a single great room (photos # 24, 25), with interior walls and ceiling of exposed logs. The interior logs are treated in clear polyurethane and the chinking is painted white. The floor is original 4" oak plank. The vaulted ceiling has a main structural ridge log which runs in the north-south direction and to which the log rafters are tied, while a support beam runs in an east-west direction (photo # 23). The windows of the main level great room are original wooden 6-light casements which swing into the room (photo # 15, 17), while the window near the vaulted ceiling is an original 4-light casement (photo # 16).

The original fieldstone fireplace stands on the north wall of the great room and is constructed from a variety of locally-harvested stones, while its mantle is a large hand-hewn American Chestnut log (photo # 27, 28). The fireplace and chimney were repointed in the 1990's (photos #4 & 5). The local stone

used in the fireplace, chimney, and foundation is predominantly various types of granite from the Precambrian period of roughly 1 billion years ago, making them the oldest rock in New Jersey, and which underlies about 50 percent of the Highlands area of North Jersey, but also may include: gneiss, a metamorphosed rock with a banded texture and which underlies roughly 45 percent of the area; marble, which occurs in about 5 percent of the region; graphite, a metamorphism of carbon from the remains of organic matter; light gray dolomite, particularly prevalent near the Wallkill River; medium-grained pink Mount Eve Granite, found in the Pochuck Mountain area; flesh-colored willemite (zinc silicate) and black franklinite, which is usually found within strains of marble and causes the marble to fluoresce bright green and red in ultraviolet light.²

A bathroom, located on the west elevation, is adjacent to this main room and was enlarged in the 1950s to include a proper shower. An enclosed sleeping porch/sunporch, which runs the entire width of the cabin on the east-facing façade, is also located off the main level great room (photo # 20, 21, 22). The sleeping porch is separated from the main part of the house by an original wood door (photo # 18). The windows of the enclosed porch are aluminum one-over-one double hung with plastic divider-light inserts (photo # 13), and were installed on the porch at an unknown date in lieu of screens.

An original Dutch door, located on the ground level of the north elevation (photo # 31), is the main entrance. The screen door was added sometime in the 1980s (photo # 07). A stairway at this entrance ascends to the main level (photo # 19), and descends to the kitchen area on the lower level (photo # 32). The lower level is, otherwise, an open space which consists of a kitchen, small closet, a hot water heater and electric wall mounted radiators (photo # 34, 35). The floor is the original concrete, painted in a checkerboard pattern (photo # 33). The windows at the ground level are 4-pane jaulosie windows (photo # 14). There is no indication of an alternate use of this space.

The precise number of cabins constructed by Seckler and Shepperd as part of the Lake Wallkill community is not known. Of the originals, which randomly encircled the lake, many were destroyed by fire, crushed by falling trees, or replaced with alternate home designs. Today, there are only 56 American Chestnut log cabins in existence at Lake Wallkill, the majority of which are in a rather sad state of disrepair, but are listed below as the last existing examples of a rare species of resort construction:

• Four (4) similar, 1 and ½ story, American Chestnut log cabins with original footprint and structure.

Statement of Significance

Summary Paragraph

The Erickson Lakeside Cabin, built in 1934 at 103 Lakeside Drive in the Lake Wallkill section of Vernon Township, Sussex County, is a very well-preserved example of an American Chestnut log cabin constructed in the resort architectural style of real estate entrepreneurs John R. Seckler and S. Clayton Shepperd. It was constructed from local American Chestnut timbers, dead-standing after the North American blight of the 1920's.¹ The state of preservation of this house has been carefully maintained inside and out, and the cabin appears almost exactly as it did when built. For its association with early 20th-century lake resort architecture in New Jersey, this property is locally significant in architectural history under National Register Criterion C, with a period of significance of 1934.

Architectural Background

American Chestnut trees were once one of the most abundant and important species in North America and dominated the forests of the eastern half of the country, comprising as much as a third of the forest and considered a "keystone species".² It was an essential component of the entire area as the single most important food source for a wide variety of wildlife from bears to birds, and it sustained rural communities as a cash crop to feed livestock. But its primary value came from its timber and bark, and with the arrival of railroad lines, the lumber became a major component of rural economics in some areas of the eastern half of the country.³

A mature American Chestnut tree grew straight and branch-free for 50 feet, grew over 100 feet tall and could have a trunk diameter of up to 14 feet. Chestnut heartwood is legendary for its rot resistance, and for 300 years, many barns and homes were made from the American Chestnut because of its natural strength and resistance to fungus. However, the chestnut blight hit the forests like a biological wildfire, and within forty years it had killed some four billion trees, causing the wood to virtually disappear from the market and only able to be found as reclaimed lumber.⁴

The availability of this chestnut timber coincided with the introduction of rustic log cabins were introduced into summer lake resorts in the 1920's and 1930's,⁵ promoted by developers interested in attracting seasonal residents from the not-too-distant New York or Philadelphia areas. In New Jersey, log cabins of this type can be encountered in isolation in resort areas, but they found their most conspicuous expression in communities like Lake Walkill, often with a few hundred such cabins apiece. Such communities included Medford Lakes and Rancocas Woods in Burlington County, and Pinecliff

Lake in Passaic County. No comprehensive survey of such communities is available, but enough of them are known to be confident of the trend that these cabins represented. These new resort cabins used whole logs, usually of relatively narrow cross-sectional dimensions, and emulated the log architecture of the Adirondacks and American West^{**,6}, retaining some common elements such as massive stone fireplaces and chimneys, and dormers in some of the larger cabins.

The Lake Wallkill community was begun in 1926 by a trio of Sussex developers: the Banks brothers, Clarkson A. Potter and William H. Dailey.⁷ The summer cabin development took off when the Paterson partnership of John R. Seckler and S. Clayton Shepperd joined the local businessmen in 1929, and on July 4 of the same year, Lake Wallkill formally opened.⁸ (see postcard #1).

Seckler was the financial and promotional expert, while Shepperd was an experienced builder. "Not Just a Lake, but a Beauty Spot" became Seckler and Shepperd's slogan for Lake Wallkill,⁹ (see postcard #2) in order to attract clientele from outlying areas of the region. Interestingly, the stock market crash and the Great Depression did not stop Seckler and Shepperd's development, as it appealed to "a solid middle and upper class clientele". ¹⁰ Lake Wallkill was so successful in the 1930's that Seckler and Shepperd then began the search for a new venue for their lake community vision. "To satisfy the demands, they set their sights on an even larger scale and in 1933 they inspected a small lake at the top of Breakneck Mountain, and on this *high land* they decided to build their new *lakes*," ultimately to be known as *Highland Lakes*.¹¹

The Lake Wallkill Community has thrived as a private lake community organization since 1929 with 320 homes recorded within the community. Since the 1870's, this area has always been an attraction for campers, and even more so later in its development due to better highway access with the construction of U.S. Interstate Route 80 and the George Washington Bridge in 1931, which substantially encouraged the growth of summer country retreats that appealed greatly to New York City folk desiring a weekend or summer getaway. As a result of the popularity of the log cabin lake community they initially developed, Seckler and Shepperd used manufactures log kits, ¹² later in their development history, to keep up with demand. Those cabins display more conformity than the original American chestnut log cabins with their irregular, natural sizes.¹³

The community has had a dam, pier boardwalk, diving docks, main office and clubhouse, drinking water lines and telephone service since 1929. Today there is also a beach playground with waterslide, gazebo

and large community stone barbecue. The main office is adjacent to the beach, but is not the original cabin, (see postcard #3). The clubhouse is original American Chestnut log construction as well, (see postcard #4), and is still in use today for community events. The clubhouse is also the venue for Sunday mass in the milder seasons and there is a small general store within. Surrounding the clubhouse are football, baseball and soccer fields with tennis courts and a playground. As described at the time of development, according to Ronald J. DuPont , Jr., Seckler and Shepperd's dream of Lake Wallkill was to offer the opportunity to own a "grand view of Sussex and its surroundings, while the backgrounds are the high-walled rocks and precipices of the wildest part of the old Pochung". ¹⁴

Similar in concept to the Lake Wallkill development is the Medford Lakes resort community, located in Burlington County, NJ, which was developed in the 1930s and 1940s. However, Medford Lakes differs from the Lake Wallkill cabins in that they were fashioned as palatial homes and constructed of cedar logs. The Gustav Stickley log home, located at his Craftsman Farms in Morris Plains, Morris County is, likewise, an example of the extent to which log home design has evolved.¹⁵

With the death of S. Clayton Shepperd in 1959, John R. Seckler became the sole owner of the development corporation. Not long after that, the Club Charter was amended which ultimately made the voting Board (a governing body comprised of property owners) responsible for the activities and dues of the lake community. In 1962, Seckler transfered ownership of all Club-operated properties to the Board, ending the corporation's oversight of the lakeside community.

Significance of the Lake Wallkill Log Cabin

Because of the decimation of the American Chestnut tree in the early 20th century, homes constructed of chestnut logs are rare. To illustrate that rarity, and the significance of 103 Lakeside Drive, the Lake Wallkill Log Cabin is one (1) of only two (2) similar-style American Chestnut log cabins, with original footprint and structure, that still exist and are in excellent condition, and which speaks to its worthy inclusion in the National Register of Historic Places under Criterion C for Architectural-Late 19th and Early 20th Century American Movements/American Chestnut Log Cabin.

The sale of the Lake Wallkill Log Cabin from Lake Wallkill Inc. to Harold and Sophie Erickson, the initial owners, was dated 1935 in the deed which was recorded in the Sussex County Hall of Records.¹⁶

Throughout the years of multiple ownerships, the internal and external integrity of the original construction and materials of this property has been diligently maintained, and as a result, the cabin appears almost exactly as it did in 1934. The apparently sole exception to this is the alteration to the bathroom which was completed before 1960.

Although small local ski slopes were in operation in the 1920's and 1930's in the general area, the population increased dramatically in the early 1960's when the modern ski industry was introduced to the area with the construction of multiple ski resorts and recreational complexes. ¹⁷ By the end of the decade the building trend had converted from the small seasonal cabins to year-round homes built in various styles, effectively ending the preference for the tiny resort cabin that once was so popular in the 1930's.
