This is a two story Corinthian tetrastyle building. The columns are fluted, the entablature is plain and the pediment features an oculus in the center. A balcony is over the segmentally arched entrance and is framed by engaged Corinthian columns. Windows are segmentally arched on both floors. The cornice is composed of five rows of raised brick set at an angle. The building is constructed close to the street, so steps go up each end of the porch rather than the traditional flight up the front.

Because it was built for a hotel, the foyer still resembles a hotel lobby complete with fireplace. A wide wooden staircase leads to the second floor. The courtroom is on the first floor, which is most unusual in Georgia. It was once the old hotel dining room. Small panes of stained glass - green, violet, red, blue, and yellow edge each top window pane. Behind the judge's bench is a framed copy of the Ten Commandments and a framed picture of George Washington. The walls are plaster with dark brown wainscoting. This is an adapted structure. It was the Old Hyatt Hotel that opened on June 23, 1898, modified in 1934 into the courthouse. It is the only adaptive structure in use as a courthouse in Georgia.
