"Indian and the Puritan" Newark, Essex County, New Jersey

Description

The "Indian and the Puritan" is a marble and bronze lamp standard dedicated to the founders of the City of Newark, and located in front of the Free Public Library on Washington Place. Created by John de la Mothe Gutzon Borglum (1867-1941), the sculpture was commissioned by the City of Newark, as one of a group of three monuments, commemmorating the 250th anniversary celebrations of the founding of the city in 1916. The other two sculptures include "First Landing Party of the Founders of Newark" in Landing Place Park and the no longer extant Branford Place shaft.

The "Indian and the Puritan" is a 22' high, bronze lamp standard flanked by the life-size marble figures of a Puritan and an Indian. The shaft is bolted on to a marble base seated in a raised ellipse, and gradually tapers upwards until it reaches a double tier of lights ornamented to resemble marshmallow blossoms. Each of the nine bronze lamps holds globe light. shaft is also ornamented with cattails native to the marshes of Newark. The marshmallow leaf designs and the cattails are suggestive of the growth along the banks of the Passaic River at the time Robert Treat and his followers landed. The inscription on the south side of the shaft reads: "1666 The founders set aside the park near by as the town's market place. Never has it been put to any use other than for the common good. To the North and Westward the Indians lingered as if reluctant to depart." The north side of the shaft reads: "1795 The bridging of the rivers eastward and the rude road built across the marsh was an enterprise of patriotic citizens; an epoch-making event. It awoke the industries and made the present city possible." Below each of the inscriptions is the city seal with a swag inscribed 1666 - 1916.

The "Indian and the Puritan" was moved from its original location, an isle of safety in the middle of Washington Place, to the tip of Washington Park, also in front of the Free Public Library in 1977. The moving of the sculpture was necessary due to a federal intersection reconstruction project. The former site also allowed for damage of the sculpture by automobiles.

Statement of Significance

The sculpture "Indian and the Puritan" is significant under National Register Criteria C, because it is the work of Gutzon Borglum, a recognized master, and it possesses high artistic values.

The "Indian and the Puritan" was commissioned by the City of Newark as part of the celebrations commemmorating the 250th Anniversary of the founding of the city. A Committee of One Hundred, a group of distinguished citizens from all walks of life, was appointed by the mayor to prepare a program to celebrate this noteworthy event. As part of the program, the city would dedicate three new monuments, all by Gutzon Borglum. The citizens of Newark were so delighted with his "Seated Lincoln," Borglum's tribute to Abraham Lincoln, dedicated in 1911, that they automatically chose Borglum as their unofficial city sculptor, granting him the three commissions without competition.

Although the Committee of One Hundred gave Borglum a free hand as to the design of the monuments, some members were helpful in providing suggestions. Carl Bannwart, the secretary of the Shade Tree Commission, provided Borglum with information as to the type of marshmallow and cattails of the region (Newark News: n.d.). These became a conspicuous part of the shaft embellishment on the "Indian and the Puritan."

The "Indian and the Puritan" was unveiled in the fall of 1916. The cost of the three 250th anniversary sculptures was around \$15,000 (Newark Evening News 3/11/16).


