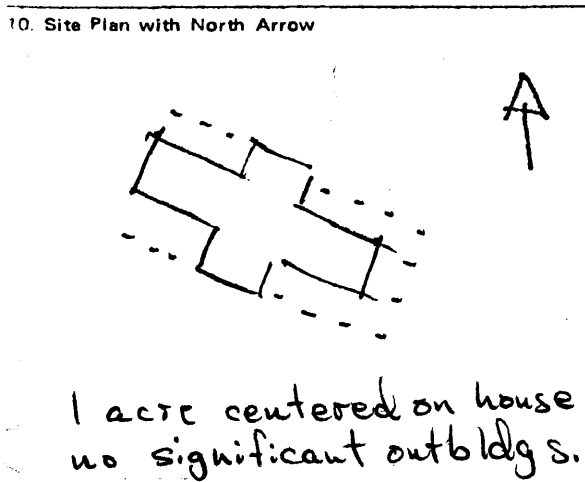

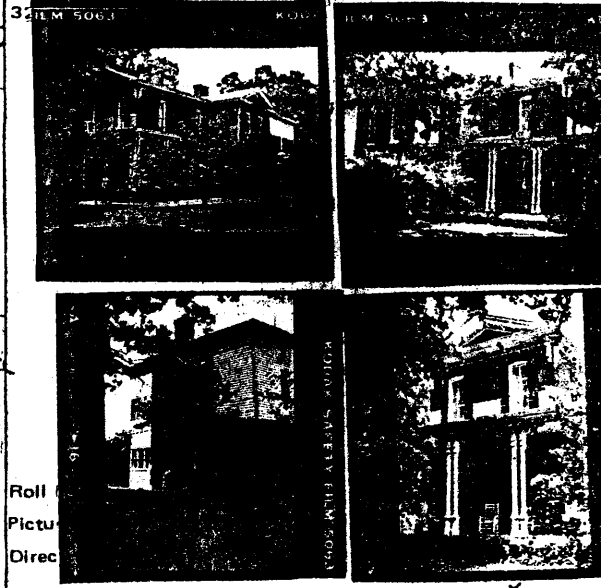

165. One of the few dwellings in Warren County in a nominally Italianate style, this building is also one of the few to exhibit this particular kind of T-plan or cross-gable plan (see Wa-163). All of the interior and exterior has survived. The extensive use of one-storied porches and double galleries is highly unusual in the area and contributes to the well composed, varied mass of the building.
