Describe the present and original (if known) physical appearance

The Hutchins house of Waldoboro, Maine, built c.1879, is one of the most dramatic houses in the state of the Mansard style with extensive Stick style detail.


The House is of frame construction with  $2\frac{1}{2}$  stories, a  $3\frac{1}{2}$ -story tower, bracketed cornices, slated roofs with dormers, clapboard siding, and a central Tudor-style chimney cluster.

The facade faces northwest and contains a double-doored entrance at the base of the tower, covered by a one-story porch. The tower itself has a crested roof with four small dormer windows. To the left of this tower is a wing which is one bay wide and one bay deep. To the right is a projection of like form. To the right of this is another wing balancing the one to the left of the tower; this, like the tower, is fitted with a one-story porch.

Rectangular projecting first-story bays are located in the facade to the right of the tower and in the northeast end of the wing to the left of the tower. These bays each contain five tall 1/1 windows beneath tracery of Gothic inspiration.

Fenestration throughout the house varies from 2/2 to paired 1/1 in virtually a random pattern.

## 8. Significance



#### Statement of Significance (in one paragraph)

Of its type the Hutchins House is one of the most distinguished residences architecturally in the state. Regrettably, no amount of research has managed to unearth the name of the architect who designed this handsome Victorian dwelling.

The ostentation evident in the design was apparently intentional. The house was built for "Aunt Mary Hutchins", as she was known, widow of Capt. Joseph Clark, builder of the famous Palmer fleet of five masted schooners in Waldoboro. According to local lore Aunt Mary and her sister had been in constant competition since childhood. When the sister married well and caused her husband to build her a fine house in town, nothing would do but that Aunt Mary should surpass her. Left wealthy by her husband she set out to do this. That she succeeded is clearly demonstrated by the handsome residence here nominated.
