Lon Rogers House (32), 2008 Lexington Avenue. Dwelling, circa 1920.

Description:

The stuccoed building features cross gables at the ends of a rectangular block, a vernacular-based form that was popularized by English architect Charles Voysey. Unlike Voysey, the designer of the Rogers house embellished his building with a fanciful mixture of historical details, including a Renaissance loggia and a flowing green shingle roof. The latter has obvious picturesque connotations and in early-twentieth-century architectural publications was referred to as a thatched roof.

Significance:

About 1920, financier and coal operator Lon Rogers built this, perhaps the most unusual house on Lexington Avenue. Rogers was involved in the development of the street in the 20's, and he built two residential courts of detached houses nearby. The house provides an enlightening example of the diffusion and alteration of an internationally-known architect's model by less well-known architects and builders. It is a prominent local example of the picturesque quasi-cottage style of early-twentieth-century domestic architecture.
