Site Description

The former United States Post Office building in Cedar Falls, Iowa, is located on the northwest corner of Washington Street and W. 3rd Street and faces east. The building is one block west of the state-recognized downtown Cultural and Entertainment District. A mid twentieth century City Hall is located immediately to the west within the same city block. Immediately west of the City Hall is Overman Park, which is part of the Overman Park Neighborhood and also within the Cultural and Entertainment District. The Post Office provides an important visual bridge between Main Street and the Overman Park Neighborhood. Immediately to the north is a brick building that was built in 1923. It currently houses the Cedar Falls Municipal Band. 1

Property Description

Exterior

The exterior of the Cedar Falls Post Office exhibits a Classical Revival style executed in a light rough-textured face brick laid in a Flemish bond (headers and stretchers in each row) with Bedford limestone trim. The cornerstone is located on the southeast corner of the facade in part of the limestone belt course separating the main floor from the raised basement wall. A roofline parapet surrounds the building, and features a partial roofline balustrade above the central bay of the facade. Stylistic features include inset panels, roundels, and a stone entablature. ²

This one-story building with raised basement is composed as a modified rectangular plan. The primary facade faces east onto Washington Street and is symmetrically arranged to read as a subtle three-part composition with a slightly recessed central bay, with slightly projecting side bays at the north and south portions. ³

A granite stair fronts the center bay, which is flanked on each side by a limestone buttress supporting a cast iron lamppost. The center bay contains three minor divisions, consisting of a round-arched central entryway and two symmetrical, round arched flanking windows. The entrance doorway, set within the center division of the central bay, features a wood frame door with side lights and a transom window, all single-pane replacement windows. ⁴

The two flanking windows each have a central window with sidelights. The central windows in both have 1/1 double hung sash windows that appear to be original. Frames and mullions in the entry door and each flanking window are fluted pilasters and headers resembling Classical entablatures. ⁵

The arches above the central doorway and each flanking window compositionally recall fanlight windows, but are each filled with a wood relief in a double fan pattern. Between and slightly above the three round arches of the central block are two circular limestone roundels. Each of the subordinate wings feature one window (1/1 double hung sash replacement), accented by a limestone panel set just above the opening. ⁶

Each side of the building is similarly planned, with three single 1/1 double hung sash windows (replacements for original 6/1 double hung sash) and one triple window near the rear of the building. These triple windows on both sides have been reduced in size with panels and replaced with fixed plate glass. Nevertheless, they fit within the original masonry openings.⁷

The rear elevation includes a central projecting bay that originally served as mail docks. This elevation shows the most remodeling, which includes the enclosure of the service docks (now used as a main building entryway) and the installation of a handicapped-accessible ramp. ⁸

The original arched basement entryway, located at the bottom of an outdoor staircase, is extant. Windows on the rear main floor have been reduced with panels and replaced with fixed plate glass, the entirety fitting within the original masonry openings. At least two of the basement windows on this side are original 6/6 double hung sash.

The building was specified and constructed for high design integrity and long life. The specifications called for the exterior brick to approximately match the color and value of the limestone trim and that it be of the pressed brick surface texture. Use of a variety of stone options was allowed but we know that the Bedford Limestone utilized was provided by the Mathew Brothers Company of Bloomington, Indiana. The source of the brick could not be found.

The exterior wythe of finish brick and stone was backed up with brick of lesser visual quality but of equal structural capability. This applies to all visual surfaces of the main floor walls and also where required at the lower floor walls where visible at stairways and window wells.

Basement walls were of solid brick all of the way through, varying in total thickness of 13" to 22 1/2". The basement floor is of reinforced, cast in place concrete, thickened where needed under bearing walls. Footings in all cases are reinforced cast in place concrete. The main floor is also of reinforced, cast in place concrete thickened to form beams where needed to span between columns at the basement ceiling level.

Columns are of steel at both levels, surrounded with brick at the basement level for fireproofing and surrounded with terra cotta tile at the main floor for fireproofing.

The roof structure consists of steel columns supporting steel I beams which in turn support steel channels. 4x4 wood nailers are bolted to the steel channels to serve as anchorage for the 2" thick wood plank roof sheathing.

The original roofing material was of the built up type with asphalt and roofing felts, topped with granite ballast.

Interior

Most of the important original features of the public service area have survived intact, with additional significant features found in the workspaces of the building. The entrance vestibule retains its original multi-paned windows, doors, and hardware. More than half of the service windows are in place, with original woodwork, hardware, and frosted glass. All three original light fixtures from the room are in their original locations. The marble wainscoting wraps around the front and side walls and wood paneled doors with frosted glass lead into the office. The ceiling is plastered and trimmed by crown molding. A narrow opening for the supervisor's observation platform is visible. The platform is accessible by a ladder from the office. In the work areas, some original wood paneling and radiators remain. The most striking features are two walk-in fireproof vaults with metal doors and external light fixtures. They are shown on the floor plan in Figure 4. The interior staircase retains its vintage metal and wood stair rails. The 6/6 windows in the rear basement are also original. ¹⁰

Finish materials were specified in the original documents but their sources were not. White oak, pine, fir and cypress were specified for various locations throughout the interior. Plaster source was also not specified.

Past alterations and current condition

The Post Office interior underwent several alterations in the past as it was used for City of Cedar Falls office space, a school, and for records storage. It is in use as a retail bicycle shop

as of the date of this nomination. Fortunately, the alterations were reversible such that the historic public space is almost entirely intact.

The exterior of the building appears original from the street with the exception of small signs advertising the bicycle shop. There are no signs on the front, ie, the east elevation, of the building.

The glazing and window sash have been replaced in the east elevation in the interest of energy efficiency. The window frames are original. Minor window frame, window sash, and glazing alterations on the west, north, and south elevations of the building were also made in the interest of energy efficiency. The roofing is not visible from street level.

A wall separating the historic public space from the historic work area was removed decades ago and has not been replaced in the interest of tenant functionality. There are other advantages to this arrangement, discussed below.

Some of features of the public space were removed at some point in the past to accommodate City office functions. This is apparent in the included photographs.

There is no mail processing equipment in the building. It was likely removed when U.S. Post Office operations were moved to a new building in 1961, which currently still serves as the Post Office. None of the equipment from the historic Cedar Falls Post Office survives today.

The original woodwork and floors were cleaned and repaired as needed, and the walls and ceiling were repaired and painted in preparation for the current tenant.

Original lighting in the historic public space has been supplemented by modern, high efficiency lighting. The original lighting in the historic work space was removed and disposed in the past. The current lighting was installed for the current tenant and is also high efficiency.

Integrity

The significance of the Cedar Falls Post Office is conveyed through all seven aspects of integrity: location, setting, design, materials, workmanship, feeling, and association.

Location and setting: The Cedar Falls Post Office is in its original location near the historic downtown.

The Cedar Falls Post Office is located between downtown and Overman Park. Overman Park is just three city blocks west of downtown, so there is a close visual connection. This setting

creates an attractive historical environment for the area. Next door to the north is a 1923 building that adds historic appeal.

Design: The integrity of design is quite good.

The exterior has not been significantly altered and access to the historic public lobby of the Post Office is maintained. As mentioned above, a wall separating the historic public space from the historic work space has been removed. However, this allows the viewing of two vaults and two observation platforms that were integral to Post Office operations. The observation platforms are accessed via ladders near the vaults. There was no external access to the platforms as was the case with some Post Offices of the era. The vaults would not have been apparent to the Post Office customer, so the absence of the separating wall does affect the original design. One advantage of this situation is that the observer is further informed about the association between the Post Office and its original function.

Another advantage of opening the floor plan is that today's public can experience the large amount of natural light that must have been appreciated by postal workers of the day.

Workmanship: The historic Post Office was built using materials and according to the design, including the degree of ornamentation and finish materials, dictated by the Department of the Treasury. This fact is a major contributor to the significance of the historic Cedar Falls Post Office, and is discussed further in the Statement of Significance.

Feeling: It is apparent to customers of the bicycle shop now operating in the building that they are approaching a building that had a different purpose in the past. They see the original façade and enter through the historic entryway into the historic public space, directly exposed to the post office boxes and service windows. To walk in and get the feeling of entering an old Post Office is not difficult.

Association: The Post Office has become known locally as "The Old Post Office" or, simply "the OPO", indicating a clear association with its historic past. The historic public space evokes the feeling of a Post Office. The period appearance of the front of the building is completely maintained. The building retains a high level of integrity and would be recognizable by its architect, builder, and the original patrons.

Recent Developments

In early 2015, the City of Cedar Falls leased the building for 39 years to a community based local development group, the Cedar Falls Development Group, dedicated to the preservation of downtown Cedar Falls. The building was rehabilitated to the condition described above according to The Secretary of the Interior's Standards for Rehabilitation and on Feb 01, 2015 was sublet for use as specialty retail space, a bicycle shop.

The Cedar Falls Development Group has applied for state and federal historic tax credits.

The integrity and the historical and architectural significance are being preserved in a financially secure manner.

Statement of Significance

The Post Office is eligible for the National Register of Historic Places under Criteria A and C for its local significance. The period of significance is 1918-1961, beginning when it was placed in service and ending the year the building ceased being used as a Post Office.

The Cedar Falls Post Office is historically significant locally for its association with community planning and development in Cedar Falls. As the first federal government building in Cedar Falls, the post office reflects Cedar Falls' importance as an early $20^{\rm th}$ century commercial center.

The Cedar Falls Post Office is architecturally significant under Criterion C for its intact Classical Revival Style reflecting the earliest years of post office and federal building standardization.¹² The building retains a high level of integrity and would be recognizable by its architect, builder, and the original patrons.

There is a direct correlation between the architecture and construction materials of the building and the city's economic status in 1917. Therefore, the Cedar Falls Post Office is locally significant under Criterion A for its historical association with community planning and development in Cedar Falls. As the city's first federal government building, the post office reflects Cedar Falls' importance as a commercial center just prior to World War I. Throughout its history Cedar Falls officials and boosters had often cited their post office as a measure of the city's commercial success. When construction of the new post office was well underway, a headline in the November 23, 1917 issue of the *Cedar Falls Record* said it all: "The Post Office Here Reflects City's Hustle." ¹³

In 1916, Congress appropriated \$95,000.00 for the construction of a new post office in downtown, the first federal building in town. Frederick Weitz, a Des Moines contractor, built the structure in 1917 and 1918.¹⁴

The vibrancy of business in Cedar Falls was noted in a 1917 news article: "Black Hawk County is the only county in Iowa containing two post offices reporting direct to the U.S. post office Department. Cedar Falls is the only town in Iowa situated in the immediate vicinity of a town five times as large, whose post office is not required to make its report to the larger

post office....This is conclusive evidence that Cedar Falls with its eight thousand population is one of the "live cases" among Iowa's many live municipalities...." 15

The disproportionately high mail volumes are attributed to several causes including the Iowa State Teachers College and the publishing of *Dannevirke*, a widely popular Danish language newspaper, published from 1880-1950. ¹⁶

The first known location of the Cedar Falls Post Office was on Main Street, opposite Wallace Drug Store. It was in this location by 1861 when Andrew Mullarky, the first merchant in Black Hawk County, served as Cedar Falls' third postmaster. Mullarky's store, in the 100 block of Main Street, also served as the first Black Hawk County Court House, county records being kept in a second floor room. The store may also have functioned for a time as the post office - it would have been convenient for the community and for the postmaster.

The Post Office remained on Main Street in the midst of the business district near the corner of Third and Main through the tenures of postmasters S. H. Packard, R. P. Speer, George H. Harris, Henry A. Perkins, William H. McClure, Frederick Boehmler, and W. M. Morrison. Each of these men played a significant role in the development of the community and have compelling, although perhaps invisible, personal stories.

Between 1874-1891 the post office moved to 121/125 Main Street, where it was located when Solomon B. Humbert, Henry H. Markley, and Edward A. Snyder served their terms as postmaster.¹⁷ The Post Office was still in this location in 1916 according to the 1916 Sanborn Map.

The Post Office was constructed during the pre-Depression period when federal building design was controlled by the Department of the Treasury, which had a classification system that specified the size and architecture of the building in proportion to the city's postal receipts.

There are not an abundant number of examples of Post Offices built in the pre-Depression period (see table below). Whether the Cedar Falls Post Office was counted in 1917 or 1918 is unknown.

Of 37 currently existing Iowa buildings originally built as Post Offices, only five were built 1912-1920. They are located in Cedar Falls, Chariton, Iowa Falls, Oskaloosa, and Webster City. ¹⁹

The closest example to Cedar Falls is located in Iowa Falls, approximately 50 miles west. It was built in 1914 and is listed in the Federal Register of Historic Places. Many more Post Offices, such as the Waterloo, Iowa Post Office were built during the years of the Works Progress Administration. It was built in 1937²¹ as one of 303 government owned Post Offices built that year²². It is listed on the Federal Register.

The Cedar Falls Post Office is locally significant under Criterion C for its intact display of the distinctive Classical Revival style architecture reflecting the earliest years of post office and federal building standardization accomplished under the direction of U.S. Treasury Secretary William McAdoo and James A. Wetmore, Acting Supervising Architect. The attractive building reflects both a federal style and the confidence of the federal government in the Progressive Era, the age of Teddy Roosevelt and Woodrow Wilson, whose Secretary of The Treasury (and son-in-law) William McAdoo's name is inscribed on the cornerstone.²³

In 1915, "McAdoo sponsored the development of a classification system for federal buildings. This system categorized buildings according to the level of annual receipts, their

location within a city, and their inclusion of a post office of the first or second class". ²⁴ James Wetmore was head of the office but was not an architect. Therefore, his title was Acting Supervising Architect. ²⁵ Wetmore was a trusted career bureaucrat who moved into the position when Supervising Architect Oscar Wendroth resigned. Wetmore respected the work of architects, leaving the matter of architectural design to his staff while focusing on policy and administration. ²⁶

In March 1916, receipts at the Cedar Falls post office totaled \$40,933.12, more than enough to place it in the first class," which classification took effect on July 1, 1916. That same year, Congress appropriated \$95,000 for a new Cedar Falls post office, an amount that placed the building in the lower middle range of McAdoo's classification system.²⁷

McAdoo's classification system also dictated the degree of ornamentation and finish materials used in the construction of this Classical Revival style post office. Hence, the building received a Bedford limestone base, light rough-textured Pennsylvania face brick, and stylistic adornments such as the roofline balustrade and the limestone ornamentation. The interior marble finish was also likely a material expense allowed in this class of building. The architectural design and extant historic fabric of the Cedar Falls Post Office, then, reflects its status as a first class post office in 1917 and recalls an era of economic prosperity in the history of Cedar Falls just prior to World War I. ²⁸

Research Methodology

Prior to the preparation of this National Register of Historic Places nomination, the historic Cedar Falls Post Office in Cedar Falls, Iowa was the subject of survey and evaluation made possible by Technical Advisory Network (TAN) grants through the Historical Resource Development Program (HRDP) administered by the Iowa State Historic Preservation Office. The property was determined by the Iowa SHPO to be eligible for listing on the National Register at that time.





Figure 1. 1916 Sanborn Fire Map.



Figure 2. 1926 Sanborn Fire Map.










Figure 11. HISTORIC IMAGE - Interior view looking southwest at Post Office boxes, circa 1918, Cedar Falls Historical Society.


