#### SUMMARY STATEMENT

The Vinsonhaler Blacksmith Shop was built between 1911 and 1938. The associated garage to the north was probably built at a later date - in the 1930s or 1940s. Both buildings are one story vernacular structures in Nyssa, OR located two blocks west of the railroad - industrial corridor of the town.

# SITE

The Vinsonhaler Blacksmith Shop is located in the Original Townsite of Nyssa on the north side of the 100 block of Good Avenue near the northeast corner of South Second Street. The site includes the blacksmith shop building and a two car garage/storage building at the alley to the north of the shop.

#### **STRUCTURE**

The Vinsonhaler Blacksmith shop is approximately thirty feet wide from east to west and fifty feet long from north to south. It is one story in height. The cast in place concrete at the lower walls extends to the height of the window sills. The brick, in a running bond at the upper walls, extends to the eaves of the wood frame roof and the wood frame false front on the south facade. The window lintels are concrete.

#### EXTERIOR FEATURES OF BLACKSMITH SHOP

The south facade facing Good Avenue presents a wood false front which rises above the height of the gable roof. The false front is lower on the each end and steps to a higher center section. The signage at the false front reads "BRYAN VINSONHALER" which is painted in black lettering in a gentle arch. Beneath this name is painted a blacksmiths anvil. Below the anvil is the word "SMITH" in larger lettering. A photo from the late

1940s displays the name in the same location with "BLACKSMITHING" beneath and the words "WELDING and HARDFACING" at the bottom.

The south entrance of the shop is a pair of large swinging doors which reach the top of the brick, approximately ten feet. The doors are covered with corrugated metal siding. The late 1940s photo depicts the doors as wood with cross bracing at the top and bottom of each door. Three strap hinges per door extend half the width of each door. These entrance doors are offset to the left with a triple set of windows to the right. The windows are arranged with a large 6/6 double hung window in the middle and a 4/4 double hung window at each side.

The east and west facades have four pairs of symmetrically arranged 6/6 double hung windows.

The north facade has shiplap siding at the gable end. The north entrance aligns with the south entrance, this being a pair of large swinging doors which are wood with cross bracing at the top and bottom. The left door has had a smaller passage doorway cut into it. To the left of the doors is a pair of 6/6 double hung windows.

The roof has exposed rafter ends and is finished with composition shingles. Two brick chimneys are located at the east wall. Each chimney is corbeled. The south chimney has a tall metal stovepipe with guy wires.

#### INTERIOR OF BLACKSMITH SHOP

The interior of the building is one large shop space. The floor is concrete and the ceiling is open to the roof structure. The space has not been used for blacksmithing since the mid 1960s. At that time all the tools and equipment were sold. The following list represents the tools and equipment that were used in the business: Trip hammer for forging plowshares, two or three anvils, a forge, an iron shear, two vises, a drill press, a thread cutting machine, an emery wheel, an ironworker for bending steel, two welders - one arc welder, one acetylene welder - work benches, and an iron rack for material storage. Vehicles and equipment could be moved into the shop from either the north or south doorways. The tools and work area were located along the east wall. The existing chimneys

were not used to exhaust the forge. A larger metal stack was used and has since been removed. <sup>1</sup>

#### EXTERIOR OF GARAGE

The garage is approximately twenty feet by twenty feet and one story in height. The floor is concrete. The lower eighteen inches of the walls are concrete, the upper walls are constructed of brick in a Flemish bond pattern. The brick construction suggests that of a rowlock cavity wall with the coursing of the bricks in alternating shiners and rowlocks. The gable roof has exposed rafter ends and is covered with corrugated metal roofing. The gable ends are finished with wood shingles. A stovepipe punctuates the roof at the west side.

The north facade has two pairs of swinging doors for vehicular entry. Each door has three vertical panels at the bottom with 3/3 fixed panes of glass above which have been boarded over from the inside. The east and west each have one 3/3 fixed window centered in the wall. The south facade has one window offset to the right and a passage door at the left corner. Both the door and window have metal awnings for shade.

Stylistically, the garage appears to have been built at a later date than the blacksmith shop. The brick pattern and care in its construction lends itself to other similar 1930s and 1940s era residential structures in the surrounding neighborhood that display the same masonry construction. The building was used as a dwelling as indicated on the 1949 Sanborn map. Bryan Vinsonhaler and his wife lived in the structure for a few years according to his son, Delos Vinsonhaler. The building is now used for storage.<sup>2</sup>

The Vinsonhaler Blacksmith Shop is locally significant under Criteria A and C. The business was dependent upon the success of the sugar beet industry in the late 1930s and contributes to the development of this industry in Nyssa and Malheur County. The business catered to the needs of the area's farmers; the welding and repairing of farm equipment, and construction of beet beds. Located in the Original Townsite of Nyssa and constructed between 1911 and 1938, the blacksmith building represents the agricultural boom that the area experienced during the second half of the 1930s and early 1940s. To meet Criteria C, the building portrays a vernacular character in its construction and its function as a blacksmith shop.

It is not known exactly when the blacksmith shop and garage were constructed. The manner in which the cast in place concrete was used on the shop building would align its construction date with two other early concrete structures in the Original Townsite: the Hotel Western, c. 1904 - 1906, and the Blacksmith/Green Lantern Saloon, c. 1906 - 1909. However the shop building is not shown on the 1911 Sanborn Map, which means it was of a later date than the other two buildings.

It is known that in 1938 J. C. Olsen of Buhl, Idaho purchased the property.<sup>3</sup> Mr. Olsen was a blacksmith and apparently operated the business with two others until the mid 1940s.<sup>4</sup> In 1944 the property was purchased by Bryan W. Vinsonhaler from Frank Coats, J. C. Olsen, and Joseph D. Smith. Transferred with the property were "all tools, machinery and equipment....all of such property being in or used in connection with the blacksmithing business now being conducted on the said described premises."<sup>5</sup> Information concerning Frank Coats and Joseph D. Smith is not known. Bryan Vinsonhaler had been a blacksmith previously in Kansas and Colorado before World War II and pursued the blacksmith business upon moving to Nyssa after the war. He stayed in business until his retirement in the mid 1960s when he sold all the tools and equipment...<sup>6</sup>

The blacksmith business was supported by the agricultural economy of the area. Mr. Vinsonhaler primarily repaired and welded farm equipment. A major portion of his business was the construction of beet beds which were attached to truck beds and used during the harvesting and transporting of sugar beets. On the truck, the sides of the beet beds would fold down to unload the tubers at dumping locations along railroad sidings or

at the sugar beet factory. This type of unloading device was superseded in the early 1970s by hydraulic hoists with a rear dumping mechanism which later evolved into a conveyor - ejector type apparatus that became useful for harvesting and transporting a variety of agricultural products, thus making the use of the beet beds obsolete.

The Vinsonhaler Blacksmith Shop and garage are significant under Criterion C as examples of vernacular buildings. The shop's masonry construction and open interior space lend this building to its small scale blacksmithing operation. The shop portrays the industrial function that utilized the entire interior space for welding and forging purposes. The movement of vehicles and equipment through the large doors at either end of the building and the placement of the large east and west windows contribute to the overall industrial feeling of this structure. The building has not evolved significantly in its function as a specialty shop in the commercial - industrial realm of Nyssa, OR.

The garage, now an accessory building to the shop, at one time represented the proximity and relationship of the owner's dwelling to the business. In the depression era of the 1930s and early 1940s it was probably economically convenient for the owner to live next to the business until the business thrived and dwelling in another location was feasible. The masonry construction of the garage is interesting and bears the mark of craftsmanship found in other residences in Nyssa, while at the same time it is an unusual statement for this commercial setting.
