Description:

The John Stuart House is a two-story brick structure built in a central passage plan in 1875 with Italianate detailing. It is a symmetrical five bay structure with a rear one-story ell. On the main (south) facade is a one-story porch with chamfered posts, vergeboard brackets and dentil molding. The main entrance has an original frame door with a three light transom and sidelights. Windows are four-over-four sash with brick relief arching. At the roof eave are triple brackets over each window. The house is built of common bond brick with a hipped roof of composition shingles. On the east facade is a ca. 1910 one-story porch in the ell of the house. The interior was inaccessible. There are no significant outbuildings.

Statement of Significance:


The John Stuart House is a notable example of a late 19th century central passage plan residence. Constructed in 1875, the residence was built with Italianate detailing including bracketed eaves and porch and arched windows. The house was built for John Stuart, a wealthy farmer and the Stuart family resided here during the late 19th and early 20th centuries. The house retains its original porch, windows and other features. With the exception of a porch addition in the ell in the early 1900s no other major alterations have taken place to the house and it is one of the most unaltered examples of a late 19th century central passage plan brick residence in the county.

Acreage: Less than one acre.

Verbal Boundary Description and Justification:

The boundary for the John Stuart House is illustrated on the accompanying Hardin County property tax map 226, lot 12, and is defined by fencelines to the north and east, by a driveway to the west, and St. Anthony Road to the south. The boundary includes the house and property sufficient to protect the historical setting of the site but excludes modern outbuildings to the north and west.
