

Mt. Olive Baptist Church, located at 301 Church Street [northeast corner of Church and Mullins streets] in Mullins, South Carolina, a town in northeastern Marion County, is a one-story brick cruciform building constructed between 1922 and 1926 with a complex hip and gable roof now clad with composition shingles.

Situated on a level lot and set upon a brick foundation with a protruding brick watertable, the sanctuary is a Late Gothic Revival building laid in five-to-one American or common bond. Featuring twin corner towers of unequal height flanking the Church Street façade [south elevation], the sanctuary is accessed by brick wraparound steps and through two sets of double-leaf doors with pointed brick arch-framed stained glass transoms on each of the exposed elevations of the towers. The taller of the towers, located at the building's southwest corner nearest the street intersection, also contains a marble cornerstone, circular stained glass windows or an oculus above each entrance at the second level, a projecting brick beltcourse delineating the uppermost or third level, and a belfry containing four large pointed-arch openings [now infilled with metal panels painted white]. While the shorter of the two towers does not contain similar or identical decorative elements, both towers boast flat-topped turretted corners which intersect and punctuate their flared pyramidal roofs now clad with composition shingles.

Each of the building's principal facades projects to the south, east and west and features a large, tripartite Gothic-arched, leaded stained glass window flanked by stained glass lancet windows. Thrusting upward into an engaged gable, the large central windows point to half-moon shaped attic ventilators now infilled with painted-white metal panels similar to that in the belfry. On the north side of the west projection is a secondary entrance with single-leaf door and segmental-arched transom, while on the west elevation of the north [rear] projection is a lancet window. An early, if not original, wing extends to the north of the rear elevation and contains a segmental-arched, single-leaf door with transom, a lower or nested hip roof, and an engaged gable. Brick, single-flue chimneys pierce the main building's roof along the south slope of the west façade's gable and along the north slope of the east façade's gable.

In more recent years a small hipped roof extension was added to the rear (north), as was a one-story brick Sunday school building. Extending at the rear of the church building in an easterly direction, this ancillary building clearly reads as a modern, subordinate addition which allows the historic sanctuary to continue to dominate the site and convey its historic architectural integrity and significance.

The sanctuary is accessed from two vestibules within the tower structures. A rope pull for the church's bell is still evident within the westernmost or principal vestibule. Paneled double and single-leaf doors lead into the sanctuary which reflects the cruciform plan of the building's exterior form and massing. Encircling the large space is a beaded board wainscot with heavy molded wood rail, above

which are flat, unadorned plaster walls. The ceiling, superbly crafted in miter-cornered beaded board planes, mirrors the complexity of the exterior hipped roof and culminates in a box-framed Greek cross. The cross's beaded board recessed panel is fitted together using miter cuts to create a decorative effect. A semi-domical apse provides a chancel at the center of the north wall of the sanctuary, while a slightly smaller arched choir alcove flanks the pulpit area to the left [west]. Single leaf, horizontal-paneled doors access anterooms to the rear of the choir alcove and to the right [east] of the chancel. A balustrade separates the chancel from the choir area which it partially surrounds. Set upon hardwood floors, seating within the sanctuary consists of curved, wooden pews with a Tudor Gothic end-panel motif. Arranged in three banks, the pews allow for two inner and two narrower outer aisles and surround the projecting raised pulpit platform. A lighted cross is located above the chancel arch, while the entire space is lighted by hanging brass chandeliers.

Mt. Olive Baptist Church is eligible for listing in the National Register of Historic Places under Criterion C as an example of early twentieth century Late Gothic Revival architecture. Mt. Olive is also eligible under Criterion A for its association with the history of African-American life and culture in Mullins, South Carolina.

Wade Alston Ford, a young African-American architect from Lake View, South Carolina, designed the church and directed its construction between 1922 and 1926. The church was built with volunteer labor from five craftsmen who were members of the congregation.

Ford received his education from the Lake View graded schools and by attending a boarding school at Allen University, a historically African-American college in Columbia, South Carolina. Ford continued to excell academically and graduated near the top of his class in 1921 with a bachelor's degree in Architecture and Building from the South Carolina State Agricultural & Mechanical College in Orangeburg. Ford chose to work as an architect and craftsman near his hometown of Lake View and the surrounding area and is known to have contributed to the construction of St. John African Methodist Episcopal (A.M.E.) Church in Marion, South Carolina, and another A.M.E. church in Bucksport, South Carolina.

Mt. Olive Baptist Church has been an important center of religious and civic activity for the African-American community of Mullins. The church has been home to countless weddings and funerals and served as a meeting place for local clubs and organizations. Due to limited space at local schools, commencement exercises for each grade were held at the church sometime culminating in a twoweek festival of graduation each school year. The church also hosted fellowship unions, local and state Baptist association meetings, and the National Baptist Convention's Annual Session during the 1940s. The church has also hosted nationally known gospel artists such as Rosetta Thorpe and Marie Knight.¹
