

Description

The Weyl Service Station is located in the village of Trenton, Nebraska (2000 population, 507). Located in the southwestern portion of the state in Hitchcock County, the region is characterized topographically by dissected plains. Positioned near the center of the county, Trenton is approximately 250 miles southwest of Lincoln, the State Capital, 12 miles north of the Nebraska-Kansas border, and 60 miles east of the Nebraska-Colorado border. The service station is located one block east of the current business district. When constructed in 1921, the Weyl Service Station was positioned on a busy commercial street; however, the character of that street is now residential.

The Weyl Service Station (HK05-040) is a small one-story filling station sited diagonally on two commercial lots, positioned to allow access from two directions. The building retains its historic exterior and interior integrity. The interior and exterior of the building reflects a standard filling station type that conveys the significance of the building.

This small house with canopy type filling station exhibits elements of the residential bungalow house type, such as a gable roof with exposed rafters, purlins, and overhanging eaves¹. The main portion of the building is stuccoed and the gable roof is covered with asphalt shingles. A brick chimney is located along the ridgeline. The foundation is poured concrete. The gasoline pumps are placed under the canopy toward the outside edge of the support pillars. These gasoline pumps, while not original to the station, probably date to the 1940's and were those in use when the filling station ceased operation in 1967. An air stand resting on a poured concrete base is complete with a pressure gauge and housing for the automatic recoil of the tubing. This air pump sits immediately adjacent to the southeastern pillar and when the correct tire pressure was reached, the air stand would ring to alert the attendant.

The front entry door is centered on the front façade, under the canopy. This door is flanked on either side by a double hung, wood sash window. Large three bay windows consisting of three double hung wood sash windows on each of the secondary façades would have provided a good deal of light through the workday.

An addition was made to the rear of this building, and though its construction date is unknown, it was clearly completed shortly after the construction of the primary portion of the filling station. This portion of the station was added to accommodate an interior restroom, and a small workbench. The addition is clad with stucco and matches the initial construction. The roof of this addition is flat, and one small double hung window provides light on the southeastern façade while a second double hung window was placed in the center of the rear façade.

A second addition was added to the side and the rear of the first addition. This second addition was placed perpendicularly, and extends to the northwest of the building. This shed addition is constructed of wood frame covered by corrugated tin. Access to this shed addition could be gained through the interior, or by a wooden door placed in the addition where the corrugated tin addition meets the original building. An industrial type, steel sash window was placed off center in the northwest façade of this addition. The construction date of this addition is unknown, but is estimated to be in the late 1940's or early 1950's given the window type.

The interior of the Weyl Service Station is intact. In fact, it appears that the operation of filling station could resume with little effort. Upon entering, the customer would see a glass display case, now filled with maps, but presumably could have displayed small parts. Immediately behind the display case is the attendant's desk and work area. A set of locking boxes, built into the underside of the desk, may have held important papers such as customer accounts. The interior walls are painted plaster, and the floor is poured concrete.

As advertised by a sign above the door, the doorway immediately to the left of the attendant's desk leads to the toilet, and also to a small workbench. The small restroom is free standing, and one wainscoted wall also serves as a backdrop for the workbench and storage shelves. The workbench and shelves above hold tools and equipment. A door located a few feet to the right of the workbench accesses the storage area created by the shed addition.

The interior of this filling station contains numerous examples of automotive hardware and equipment, some amassed during the operation of the station, and some donated to the museum that now owns the property. The sights and smells associated with a filling station are still present, ranging from the automotive tools and equipment to the smell of old grease and oil.

The Weyl Service Station is locally significant under Criteria A and C, representing an important period of development of the local economy, and the type of gasoline filling station design that evolved during this period and served to replace earlier, curbside gasoline outlets. The building's period of significance begins in 1921, its date of construction, and extends to 1952, fifty years prior to this nomination.

History

O.E. Reynolds, an early Trenton businessman, constructed the Weyl Service Station in 1921. Mr. Reynolds arrived in the Trenton area in 1884 to take advantage of the need for stores and services.² Reynolds established himself as a successful businessman upon his arrival and established a hardware, furniture and undertaking business. Later, he built a grocery and dry goods store, which was operated by his son.³

In 1921, Reynolds constructed a small gasoline filling station, the subject of this nomination, on the corner of Washington and Commercial Streets in Trenton, Nebraska (1920 population, 592⁴). This filling station, believed to be the first constructed in the community with the primary intent to deliver gasoline and services, was located along the busy "main street" in Trenton. The trans-regional Golden Rod Highway was located 3 blocks north of the filling station.

On April 22, 1921, the *Trenton Register* described the new filling station and stated "Trenton's new filling station located at the corner of Commercial and Washington Streets is as nifty a little building as can be found in any of the larger towns and cities. It is of stucco and greatly improves the looks of the corner and advertises the progressiveness which exists with the good and better roads movement."⁵

Constructed for Reynolds's grandson Leon "Spin" Weyl to manage, the Weyl Service Station advertised that it was open for business in the April 29, 1921 edition of the *Trenton Register*. "The oil service station, located just east of the Reynolds Hardware Store, is now open for business. Your orders solicited and appreciated. — Leon Weyl, mgr."⁶ By July 1 of that year, advertisements in the *Trenton Register* referred to the new filling station as the Weyl Service Station⁷ and by August of the same year, advertisements indicated that the filling station was ready to distribute oil to customers.⁸ Early advertisements for the filling station indicate that in addition to gasoline and kerosene, the Weyl Service Station also offered tanker service and a limited line of products and service.

O.E. Reynolds died in the fall of 1922⁹ at which time ownership of the filling station passed to Mrs. Lena E. Weyl, Reynolds's daughter and the mother of Leon Weyl. Leon Weyl continued to operate the Weyl Service Station until 1925 when he and his wife (who Weyl met when she became a customer of the filling station) moved to a nearby community to construct another filling station.

B.O. Kipp managed the Weyl Service Station following Leon Weyl's tenure, and offered many of the same products and services. Mrs. Weyl sold the station to T. Cloyd and Maria Curran in 1944.¹⁰ The Curran's continued to operate the filling station until 1967.

Significance

The Weyl Service Station is significant under Criterion C, displaying distinctive characteristics of a type: the American gasoline station. It reflects the evolution of the gasoline station as the automobile gained dominance and the corresponding market for petroleum products and services grew¹¹. The design, form and function of this filling station reflect the important marketing trends of the American gasoline station during the period when most gasoline was distributed from curbside pumps, a secondary service to those already offered. The design of this filling station fits into well-known typology, the house with canopy, as defined by Jakle.¹² Borrowing many design influences from residential construction of the time, this small filling station looked tidy and neat, unlike the earlier curbside services of the community.

The Weyl Service Station was constructed during a period when the automobile was revolutionizing travel much the way the railway had earlier. At a time when much of nation's gasoline was dispensed from curbside pumps outside general stores, O.E. Reynolds and his grandson Leon Weyl were well ahead of the national trend when they constructed a separate facility to market gasoline to the residents of Trenton and the surrounding area. In choosing to construct a filling station that was reflective of a bungalow the most modern building style of the time, Reynolds demonstrated that he understood his customers and his community would appreciate a stylish, yet functional building.

The Weyl Service Station is significant under Criterion A as it reflects the development of separate commercial facilities by which petroleum products and related services were offered to the consumer. This commercial venture, the first of its kind in the community of Trenton, offered the motorist a glimpse of the future of the

increasingly prevalent automobile. In addition, the tanker service that delivered petroleum products to residents of Trenton and the surrounding rural countryside played an important role in the local economy.

In advertisements, the Weyl Service Station continually stressed service and its commitment to its customers. This dedication undoubtedly proved itself, when after a flood on the Republican River in 1935, the channel shifted and the new river bridge constructed was a bit further west. This movement of the river bridge helped facilitate the movement of the Trenton business district one block west to Market Street. As the new business district solidified, the businesses along Commercial Street slowly began to disappear. The Weyl Service Station survived this gradual change, continuing to provide an integral service to the community until 1967.


