Description

The second-generation Norden bombsight vault at the former McCook Army Air Field is a small rectangular structure, one-story in height. It has a very slightly sloping shed-roof and one door on the main facade. An ell-shaped wing is located on the southeast facade. It also has a shed-roof and a door on the main facade. The entire structure is constructed of poured reinforced concrete. Surrounding the vault is a combination two strand barbed wire and six-by-six woven-wire mesh fence supported by wood posts. This nomination includes two contributing structures; the fence and the vault.

The second-generation Norden bombsight vault is located on the access road that runs parallel to the northwest-southeast runway, and is set in about the middle of the row of hangars at the former McCook Army Air Field. It is a one-story shed-roofed structure that measures 11 feet wide and 13 feet deep. Constructed c1943 of poured reinforced concrete with walls that are 8 inches thick, the roof is also of reinforced concrete with a tar membrane. An ell-shaped wing that measures 5 five feet 10 inches by 6 feet 8 inches is located on the southeast facade. Its construction is integral with the vault. It is of identical construction, and also has a shed-roof and a door on the main facade. Its function is unknown, though it may have housed electrical equipment.

Vents to the inside are located above each door and at the top of the rear wall, venting to the "attic", and at the bottom of the rear wall venting from behind a curb at the floor into the main space. A small opening in the ceiling vents from this space to the attic. Original vault doors are of the bank-vault type. A second set of exterior doors (not extant) of wooden board-and-batten construction originally sheltered both vault doors.

The interior of the vault storage space is finished concrete at the walls and floor, with a wooden ceiling that has an attic crawl space access. Originally the space contained metal shelves for storage purposes. The interior of the ell-shaped wing cannot be determined because of inaccessibility.

Surrounding the bombsight vault is a combination two-strand barbed wire and six-by-six woven-wire fence, supported by wooden posts. Divided into 10-foot sections, the fence extends 50 feet on each side except in the front where a 10-foot gap provides an entryway. This fence is original to the property.

Statement of Significance

The second-generation Norden bombsight vault at the former McCook Army Air Base is eligible at the local level under Criterion A. It is a good representative example of this air base associated property type which was used by the military to help ensure the secrecy of an advanced technology device during World War II. The use of Norden bombsights was an integral part of World War II army airfields, and is significant under Criterion A as an important relic and feature of a significant event (air war) associated with the war. The period of significance is c1943 when the vault was constructed.

After the United States became involved in World War II, the military quickly decided that strategic bombing would play a crucial role. Initially, the military leaders determined that high-altitude, daylight bombing would be the most accurate and effective way of using strategic bombers. To help ensure that this theory would work in practice the Army Air Force needed a bombsight that could deliver the bomb load on

target. The Norden bombsight, at the time of its development, was thought to be the device of choice by the military.

The Norden was a critical element in conducting high-altitude precision strategic operations by the USAAF in World War II and was made a most secret device. The sight was a highly accurate precision instrument developed by Carl L. Norden, a civilian consultant, and Captain Frederick I. Entwistle, assistant research chief of the U.S. Navy's Bureau of Ordnance. In 1932, following extensive testing the previous year using outdated warships, the United States Army Air Corps ordered its own Norden bombsight.

Precision bombing required meticulous control; to accomplish this, the Norden incorporated a gyrostabilized automatic pilot. The mechanism was modified in 1941 by the Minneapolis Honeywell Company and designated the Army Type C-1 autopilot. This modification enabled a bomber to be flown on a straight, level course, giving the bombardier a steady platform on which to operate the bombsight during the bombing run. Also known as the "Blue Ox" the Norden could quickly calculate and correct directional changes due to wind drift. Flying at a preset altitude, it could rapidly compute the correct bomb release angle for a constant speed of closure to the aiming point. Adjustments could be made in a fraction of a second based on data entered into the sight. Under optimal condition on an undisturbed run, the accuracy of the device was excellent. However, any last second changes in the altitude of the bomber at the instant of release, such as those encountered during battle, could markedly influence the accuracy of the sight.¹

When the Norden bombsight was not in use at a training facility it was stored in a vault because of its secret classification. Originally, a building of wood construction contained five or six concrete vaults inside. In addition to being used as a security storage area, the building also had room to test and repair the sights. This type of building is designated as a first-generation bombsight vault.

After the Norden bombsight was reclassified from secret to restricted (probably in 1943), the second-generation bombsight vault came into use. Rather than being contained in a wooden building the vault stood in the open and was used solely for storage purposes. The nominated structure is a second-generation vault.

The Norden bombsight was an essential factor in defining air war strategy. Because of its importance and the sensitive nature of the technology it employed, the bombsight was a closely guarded secret. But for bomber crews to effectively use this new instrument they had to train with it. This meant that when not in use the bombsight needed to be stored in a secure area. The second-generation vault filled this need. Even though the second-generation vault did not contain testing and repair facilities, and the security measures were not as strict (since the classification was downgraded), the structure is still significant at the local level under Criterion A. The McCook Army Air Base could not have performed its mission of training bomber crews if the second-generation vault was not present.


Verbal Boundary Description
