2. <u>Location</u>: southwest corner of junction of Highway **61 and** Forest Route 73, Mimbres, N.M.

7. <u>Description</u>: Photo 34; map 6; concrete foundation; wood frame and clapboard with endboards; corrugated metal gables with eaves returns or false front; 4/4, 2/2 double hung windows; single doors. The interior retains wainscoting, picture rails, and molding frames around windows and doors. A contributing outbuilding has a concrete foundation, unstuccoed adobe, a hipped corrugated metal roof and a small shed roofed addition enclosed by board and batten.

8. Significance: This is one of four unaltered historic buildings in the village of Mimbres and the sole historic wood frame structure in the valley. (See Sibole Store, #71, above for discussion of the development of the village of Mimbres.) The residential portion at the back of this building was built on the opposite side of the road before 1922 by Raul Sepulveda. In 1922 J.J. Hooks purchased the building and moved it to its present location. This event reflects the relatively-common historic practice in New Mexico and elsewhere of moving wood frame buildings. At the same time, the portion projecting toward the road was added. The building has remained unaltered since. The false fronted portion served as the Mimbres post office and the portion to its left as the store run by Hooks and later by Walter Moore. The building meets Criterion A as a good representative of the commercial importance of Mimbres in the upper Mimbres valley and Criterion C as a well-preserved, vernacular ·building.

Verbal boundary: A rectangle, roughly 100' by 75', as shown on map 6, formed by lines parallel to and ten feet from the north, east and west sides of the store and the south side of the outbuilding. Since this is an unplatted area, this boundary has been created to include only the store and outbuilding.
