DESCRIPTION

The Oliver J. and Anna Burckhardt House in the Near South neighborhood of Lincoln, Lancaster County, Nebraska is a small, one and one-half story, wood-frame Prairie Box style residence. The property consists of one contributing building—the house—and a non-contributing garage that was altered after the period of significance. The property is related to the Multiple Property Documentation Form entitled "African American Historic and Architectural Resources in Lincoln, Nebraska" exemplifying the property type "dwellings." The frame dwelling was constructed in 1903. The house is an example of a rare property type in Lincoln, Nebraska. This property retains integrity of location, design, materials, feeling, and association. The exterior material, asphalt siding with a brick-like appearance, covers the original clapboards but was installed in 1939, within the period of significance.

The Oliver J. and Anna Burckhardt House at 1236 Washington Street in the Near South neighborhood Lincoln, Lancaster County, Nebraska, was the home of two of Lincoln's most influential and beloved African American residents from 1903 to 1945. Deeds and directories indicate that the house was constructed for the Burckhardts in 1903. The one and one-half story Prairie Box style house has a cross gabled roof with return box eaves on the south facing front gable, a shed roofed dormer on the west side, and a hipped roof porch on the front facade. The house has a simple rectangular plan. The present exterior asphalt siding with brick-like appearance was applied to the house by the Burckhardts in 1939, within the second historic context period.

The principal entrance facade of the house faces south. This facade features a full width porch with rusticated concrete-block pedestals supporting neoclassical wooden columns. A wooden balustrade with simple square-section balusters surrounds the porch. Decorative elements include a small wooden balcony at a second story center bay window on the east facade, and double-hung windows with decorative muntins in the upper sash.

A gable roof wooden garage at the rear of the property was enlarged and modified in 1960 and hence is regarded as a non-contributing feature. Its location to the rear of the property is not intrusive upon the setting or feeling of the house.

The Burckhardt House is regarded as an example of a rare property type in Lincoln, Nebraska. The house retains a high degree of historic integrity as is illustrated through retention of all significant features from its period of significance, 1903 to 1941. These include its location and residential setting, design characteristics, materials, feeling and association.

STATEMENT OF SIGNIFICANCE

The Burckhardt House is significant on the local level under criterion B for its association with Oliver J. Burckhardt who provided secular and spiritual leadership to both the African American and broader Lincoln community from 1890 through 1951; and for its association with Anna Jones Burckhardt, a nationally recognized artist and local art teacher. The Burckhardt House is related to the Multiple Property Documentation Form entitled "African American Historic and Architectural Resources in Lincoln, Nebraska." The property demonstrates the historic contexts entitled "Early Settlement including the First Exodus, 1870 - 1913" and "Institution Building in an Era of Segregation, 1914 - 1941." Its date of significance begins with the current structure's construction date of 1903 and extends through 1941, the last date of significance of the second historic context identified in the Multiple Property Document Listing.

The house at 1236 Washington Street in Lincoln, Lancaster County, Nebraska is significant on the local level under criterion B for its association as the home of Oliver J. and Anna Burckhardt from 1903 through 1945. Oliver J. Burckhardt worked throughout his life to improve conditions for African Americans both in Lincoln and in the state of Nebraska. He provided leadership, counsel, and spiritual guidance within the African American community and to elected officials. Anna Jones Burckhardt was a nationally recognized artist and locally respected and beloved art teacher. The Burckhardt House contributes to the Multiple Property Documentation Form entitled "African American Historic and Architectural Resources in Lincoln, Nebraska." The property relates to historic contexts entitled "Early Settlement including the First Exodus, 1870 - 1913" and "Institution Building in an Era of Segregation, 1914 - 1941."

Oliver J. Burckhardt was born in Howard County, Missouri in 1868. He attended Lincoln Institute, a school organized by African American civil war veterans in Jefferson City, Missouri, before coming to Lincoln, Nebraska in 1890. Throughout his life Oliver Burckhardt worked to better conditions and provide spiritual guidance to fellow African Americans. In 1910, Burckhardt was a missionary evangelist of the African Methodist Church. Upon learning of a new African American settlement in rural Brownlee, Cherry County, Nebraska, he visited the settlement and provided leadership resulting in the settlement's growth to over two hundred African Americans. He also established a church, St. James R.M.C., before returning to his Lincoln home in 1912.

Included among Oliver Burckhardt's local endeavors was helping charter the Lincoln branch of the National Association for the Advancement of Colored People in 1918. As the organization's first membership chair, Burckhardt recruited influential citizens including the State's Lieutenant Governor and Governor-elect. Also in 1918 as a representative of the NAACP, Burckhardt joined J. E. Jeltz and William Woods in successfully blocking the proposed Lincoln showing of the film *The Birth of a Nation*. Local courts ruling that the film tended to "inflame public opinion against backs at a time when blacks were doing their part in the war effort." In 1932 Burckhardt was a key supporter of the formation of the Lincoln Urban League. Local and state officials frequently sought his advice regarding issues effecting the African American community. Included among those who requested Rev. Burckhardt's insight was A. E. Sheldon, President of the State Historical Society. O. J. Burckhardt's extensive civic activities were all undertaken as he, like most others of his race in Lincoln, earned his livelihood in service occupations, as a porter and waiter.

Oliver Burckhardt worked for social change while also focusing on the larger Lincoln community's spiritual needs. His involvement included serving for twenty years as Associate Chaplain at the State Penitentiary, and organizing and serving as president of the interracial and interdenominational Christian Alliance. Upon his wife's death in 1945, Rev. Burckhardt moved to Omaha where he served as pastor of the Church of Christ Holiness until his death in 1951.

In a tribute to Oliver Burckhardt in 1943, Rev. A.V. Wilson referred to him as "an outstanding civic and religious counselor who knows no distinction in race or social status and whose great concern is about the poor, destitute and friendless . . . His aid to the homeless and needy and to unfortunate humanity has been extensive."

Anna Jones Burckhardt was born in Burlington, Iowa in 1868 to James and Matilda Jones. In 1898 the Burckhardts were married and Anna joined her husband in Lincoln. Living in an era when most African American women were limited to work as maids or cooks, Anna Burckhardt's development of her creative talent as an artist and work as an art teacher was unusual. For over forty years she taught art to students from her studio in the home at 1236 Washington Street. She was primarily known for her work in oils. During her life-time she received numerous awards including a bronze medal for china painting at the Jamestown Exposition in 1907.

The Burckhardts contribution to the community is eulogized by their tombstones at Wyuka Cemetery in Lincoln. The headstones are inscribed "Rev. O. J. Burckhardt: Here Lies a Helper of Unfortunate Mankind" and "Anna Burckhardt, The Artist: Here Lies the Helper of the Helper of Men."
