Summary Paragraph

Elon Village Library is located in western Amherst County in the unincorporated village of Elon. The library is located on a knoll that is shared with the Elon Elementary School and Elon Baptist Church, at the intersection of Younger Drive (Route 703) and Camden Drive (Route 797). The library is a simple 16- by 30-foot frame building constructed in 1917 by the Elon community, using donated materials, as a project of the Elon Civic Betterment League. The building, a community landmark, has remained unchanged on the interior and exterior since 1924, when the rear ell was constructed. It operated from 1918 to 1965 as the only free-lending library in predominantly rural Amherst County. The building retains its integrity of location, setting, design, materials, and workmanship. The building was placed on a prominent site in the community, and continues its association with education, an important concern of the rural area. There are no other resources on the property.

Narrative Description

Elon Village Library is located in western Amherst County in the village of Elon. It stands on its 1.05-acre hillside site, surrounded by mature hardwood trees, at the intersection of Younger and Camden Drives in a residential subdivision. The library shares its driveway entry from Younger Drive with the Elon Baptist Church and Elon Elementary School.

The library is a vernacular, one-story, frame building measuring 16- by 30-feet. Construction started in 1917 by community volunteers with donated materials. The foundation consists of both fieldstone piers and brick piers. The fieldstone piers are on the south side and the brick piers are on the north with fieldstone infill between the piers. The rear ell, added in 1924, sits on fieldstone piers. The building is frame with weatherboard siding on the exterior. The side-gable roof has asphalt shingles. The cornices have exposed rafter tails.

The main or west elevation has an entry with a single-leaf, five-horizontal-panel door and two single 6/6 double-hung sash windows. In 1926, a one-bay stoop of fieldstone with a gable roof supported on four simple, squared posts replaced the original platform entry. The gable end of the porch has vertical boards in the apex.¹

The north elevation has a double window of two 6/6 double-hung sashes. The east elevation has a single 6/6 double-hung sash window and a brick chimney flue. The south elevation has a bank of three windows, each of which has Craftsman-style four-light sash.

In 1924, the community built the rear ell onto the original block's southeast corner. The rear ell has an asphalt-shingled gable roof and board-and-batten siding. An entry is on the south elevation; it has two bays, of which one has a single-leaf, five-horizontal-panel wood door and the other has a 3/3 horizontal-sliding sash window. At the entry is a single fieldstone used as a step. The ell's east elevation is without any openings. The north elevation has a single 6/6 double-hung sash.²

The interior of the building consists of the main room and the 1924 ell's room. The main room has a medium-gauge wood floor. There are built-in wood bookshelves on all four walls from the floor to halfway up the wall or to the lower sash of the windows. The shelves have bead-board backing. The main door and double-sash windows have molded trim with bulls-eye corner blocks. The 3/1 windows on the south wall have a simple, plain trim. On the east wall, there is a double-leaf entry with five horizontal panels and simple door trim. Hanging from the ceiling are two pendant lights which are original to the electrification of the building in the 1920s-1930s.

The rear ell's room was built as a kitchen in 1924. It has unfinished wood floors and bead-board paneling on the walls. The eastern wall has floor-to-ceiling built-in shelving and a stove exhaust in the ceiling. This room is now used for storage.³

Statement of Significance Summary Paragraph (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The Elon Village Library is nominated for its significance locally under Criterion A in the areas of Social History and Education and under Criterion C in the area of Architecture as an example of a locally-designed building for use as a public lending library. Featuring simple design and decoration, the building served as a free-lending library for the rural village area of Elon in Amherst County from 1918 until 1965, which represents the property's period of significance. This building served many other uses as well, such as a community meeting house, schoolroom, and polling place throughout its history. The interior and exterior of the building remain unchanged since 1924, when the rear ell was constructed. The Elon Village Library is unusual as the first dedicated rural public lending-library building in the county, possibly in the state. Designed and built by the local community using donated materials, it was open daily from 1918 to 1965 and closed only after Amherst County established a branch public library in nearby Madison Heights and created a library within the new 1960s school building on a parcel adjacent to the Elon Village Library.

Narrative Statement of Significance (Provide at least **one** paragraph for each area of significance.)

Elon Village Library is significant locally under Criterion A for Social History and Education. This is a landmark building of the Elon community. It was the idea of Theodora Stevens Lea (1872-1943), a former teacher and community worker. Several sources cite her concern about the lack of reading materials she noticed upon a visit to one of the one-room public schoolhouses in the Elon vicinity. She collected some books and magazines on her own then gathered many members of the community. Theodora Stevens Lea was the wife to Roland Lea of Speed the Plough (DHR 005-0040). She was a teacher in New York before she married and worked for many years in the Elon Community. She was recognized by Sweet Briar College with the Algernon Award for her dedication to community service. On 23 November 1915, the Elon Civic Betterment League was formed with 31 charter members, both men and women, with the purpose to improve education and health in the community. Charter members of the Elon Civic Betterment League included the Leas and George Stevens of Speed the Plough and Queena Stovall, the noted Virginia folk artist. The first project of the league was the library.⁴

The Elon Village Library is also locally significant under Criterion C in the area of Architecture. It is a unique vernacular building that retains its historic integrity of form, design and materials, and is essentially a time capsule, unaltered since 1924. Its one-room plan and interior design with wall shelving was likely the idea agreed upon by the Civic Betterment League members. Construction took place through community effort and donated materials which resulted in the building's appearance; they constructed the building using the materials on hand which were of varying styles. This reliance on materials available at the time is illustrated in that most of the windows used were six-over-six double-hung sash except the south wall, which contains a bank of Craftsman-style four-light wood sash. Similarly, the early 20th century

five-paneled entry door was trimmed with 19th century bull's eye corner blocks. The lighting fixtures and former school benches which remain are original to the creation of the building. Thus, it is a truly vernacular building that was created by the Elon community members themselves and used through most of the 20th century without any alterations. The building also is the earliest dedicated library building in Amherst County, and provides important insight into the rural community's needs and resources at the time, as well as their cultural ideals and values in working together to erect a public library.

Historical Background

A lending library was originally opened in 1916 in a rented building about one-half mile from the existing building. It was located at the corner of Elon Road (State Route 130) and what is known today as Monacan Park Road. The log building soon was too small and local landholder C. W. Dameron (1856-1931) offered the current plot on which the library stands. At that time, the parcel was an open knoll and part of a field; today, it is adjacent to a residential subdivision at the corner of Younger and Camden Drives and shares its entranceway with the Elon Elementary School and Elon Baptist Church.⁵

Community members constructed the building in 1917-1918 using donated materials. Dorothy Moore, in her 1924 Elon School graduation speech about the creation of the village, noted that the foreman for the building construction was Mr. Davis, a local electrician. There was a playground in the front yard. The building was furnished with benches and a table from the former Triple Oaks School and additional furniture from community residents. The benches remain in the building. The newly completed building library opened in 1918 and operated on a daily basis with a paid librarian and volunteers. At its height, the library contained more than 2,000 volumes, with 20 of those having been donated by Dr. H. McIlwaine, Virginia State Librarian around 1916. He noted, at the time, that this was the only rural free-lending library in the state.⁶

Continuing their work using community labor and donations, the Elon Civic Betterment League built a six-room school with auditorium next to the library in 1921. The Elon Village Library doubled as the school library and was later used as an additional classroom. Beginning in 1918, the league also supported a community nurse who used the library as an office. The services of the nurse, Miss Clara Davis, were partially financed by a grant from Colgate (Soap).⁷

Throughout its existence the league held benefits and fundraisers to maintain the library and the school. They built the rear ell in 1924 to be used as a kitchen. The building acted as the community meeting center as well as an election polling site. Around 1960, Amherst County replaced the 1921 community-built school building with a new school that included its own library. Around the same time, a county-sponsored branch library opened in Madison Heights, about ten miles from Elon. Miss Phyllis Lea (1893-1972) worked to keep the Elon Village Library open as well. She was the sister-in-law to Theodora Lea and resided at nearby Fair Lea. She had worked in the community most of her adult life and even taught kindergarten in the library around the 1940s. However, the library closed in 1965. The Ruritan Club maintained the

building through the 1970s. By 1990, the Elon Civic Betterment League no longer existed. The property reverted, according to the 1918 deed, to the Elon Presbyterian Church and the Elon Baptist Church jointly. The churches decided that the Elon Baptist Church was the best caretaker for the building. Today, it is open only for special occasions and is used for storage.⁸

The Elon Village Library is locally significant under Criterion C for Architecture as a unique community-designed and -maintained library building using donated materials. The form, design and materials are simple and fit the building's use as a library and community center. The building remains unaltered on the exterior and interior since construction of the rear ell in 1924. It is the earliest known dedicated public library building in Amherst County.

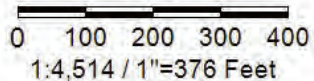

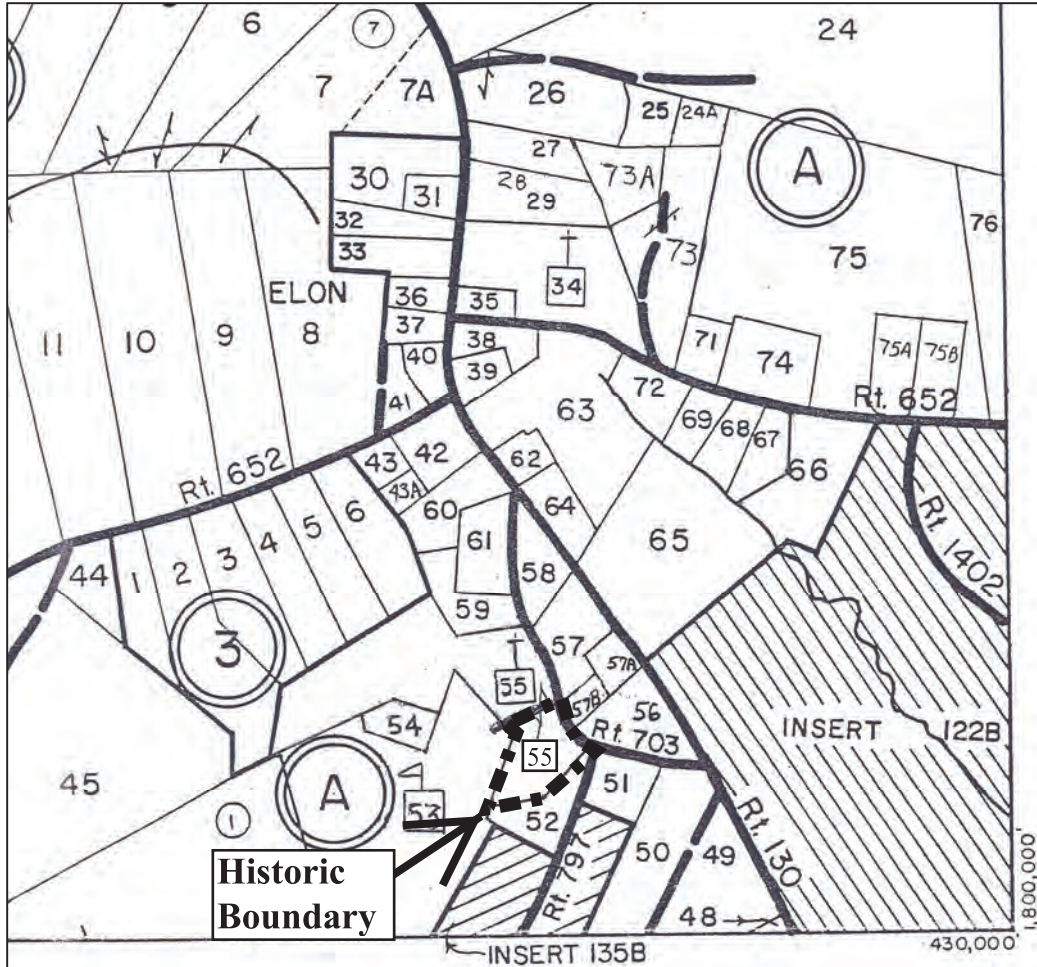

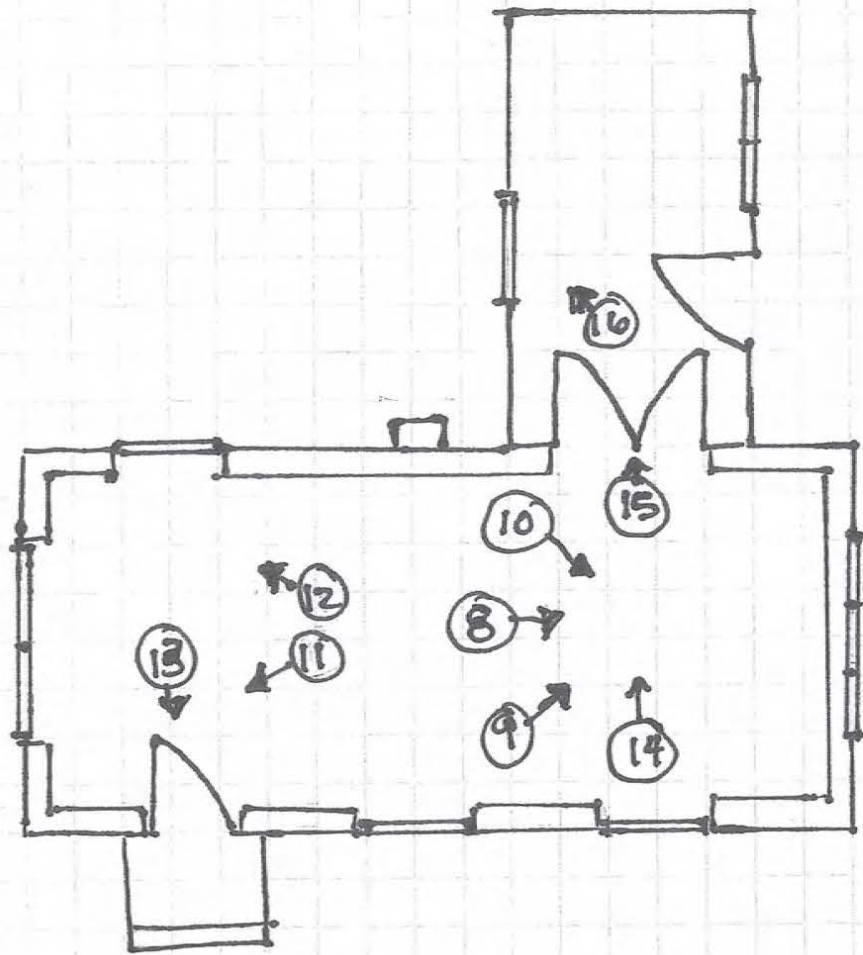
